SPECIAL PROVISIONS

1. General.

Perform the work under this construction contract for Project 1166-12-85 Plainfield – Stevens Point, CTH B Bridge Overheight Detection, IH 39, Portage County, Wisconsin as the plans show and execute the work as specified in the State of Wisconsin, Department of Transportation, Standard Specifications for Highway and Structure Construction, 2014 Edition, as published by the department, and these special provisions.

If all or a portion of the plans and special provisions are developed in the SI metric system and the schedule of prices is developed in the US standard measure system, the department will pay for the work as bid in the US standard system. 100-005 (20130615)

2. Scope of Work.

The work under this contract shall consist of furnishing and installing overheight vehicle detection assemblies, poles type 2, signs reflective type II, install monotube arms 45-ft, install poles type 12, traffic control, and all incidental items necessary to complete the work as shown on the plans and included in the proposal and contract. 104-005 (20090901)

3. Prosecution and Progress.

Begin work within ten calendar days after the engineer issues a written order to do so.

Provide the start date to the engineer in writing within a month after executing the contract but at least 14 calendar days before the preconstruction conference. Upon approval, the engineer will issue the notice to proceed within ten calendar days before the approved start date.

To revise the start date, submit a written request to the engineer at least two weeks before the intended start date. The engineer will approve or deny that request based on the conditions cited in the request and its effect on the department's scheduled resources.

4. Traffic.

Lane and Shoulder Closure Times

On IH 39 ramps and CTH B, closures are allowed only at the times in the following tables and text. At all other times all lanes and shoulders shall be fully open to traffic.

Installing foundations, supports, mounted devices, and similar minor construction at non-freeway, state highway, and local road locations that does not require a lane closure and does not interfere with traffic movement is permitted from 7:00 AM to 4:00 PM. Work described under this paragraph requires prior review and approval by the engineer.

Except as noted below, maintain one 16-foot minimum travel lanes on CTH B in each direction and one 16-foot minimum travel lane on the IH 39 southbound off ramp, using the details provided in the plans or as directed by the engineer.

Work over travel lanes shall be completed with a lane closure or a combination lane closure and flagperson. Traffic may be stopped for 15 minutes or less during an off peak period with approval of the engineer for CTH B.

5. Holiday Work Restrictions.

7. Traffic Control.

Supplement standard spec 643 as follows:

Provide 24-hours-a-day availability of equipment and forces to expeditiously restore lights, signs or other traffic control devices that are damaged or disturbed.

Supply the name and 24-hour telephone number of a local contact person for traffic control repair at preconstruction conference.

Conduct operations in such a manner that causes the least interference and inconvenience to the free flow of vehicles on the roadways. This includes the following:

- Park or store no vehicles, equipment, or construction materials on the right-of-way without approval of the engineer.
- All construction vehicles and equipment entering or leaving live traffic lanes shall yield to through traffic.
- All vehicles entering or leaving the live traffic lanes shall be equipped with a
 hazard identification beam (flashing yellow signal) capable of being visible on a
 sunny day when viewed without the sun directly on or behind the device from a
 distance of 1,000 feet. The beam shall be activated when merging into or exiting a
 live traffic lane.

9. Public Convenience and Safety - Lane Closure Notification.

Supplement standard spec 107.8 with the following:

At least 14 days prior to the preconstruction meeting submit to the engineer for approval a schedule of closures necessary for completion of the contract. Identify general information including the construction activity requiring a closure, location of closure, type of closure, duration of closure, and times of closure.

All closures must be in accordance to the contract unless approved by the engineer. Submit any changes to the traffic control plan or other traffic related requirements of the contract to the engineer for approval at a minimum of 14 calendar days prior to the closure.

Review the closure schedule with the engineer at the preconstruction meeting. Within five calendar days after the meeting, the engineer will accept the contractor's initial schedule or request additional information. Provide additional information requested by the engineer within five calendar days after the request. Provide the engineer with an updated closure schedule whenever changes are necessary.

Include detailed information on the construction activity, location, type, duration, and time of closures. Verify with the engineer that the closure is approved in the Wisconsin Lane Closure System prior to implementing the closure. Immediately notify the engineer if there are any changes in the schedule, early completions, or cancellations of scheduled work.

Supplement standard spec 638.3.4 with the following:

Do not remove or move blue specific service signs or their associated posts. Specific service signs are signs with logos that identify commercial entities providing gas, food, lodging, camping, or attractions. A separate contractor, Derse, Inc., is responsible for these signs. Contact Mark Rognsvoog of the Derse Company at (800) 345-5772 a minimum of 14 calendar days in advance to coordinate removing, moving, or re-installation of these signs.

Design/Shop Drawings

Prior to the purchase and/or fabrication of any of the components listed herein, and no more than 30 days after notice to proceed, and no less that 14 days prior to the pre-construction meeting, submit five copies of design drawings and shop drawings, as required, to the department for review. The items and the drawings that represent them shall meet the requirements of the standard specifications.

Design drawing submissions shall consist of design drawings, calculations, and material specifications for required items.

Submittals will be required for, but not limited to the following:

- Schematic design of the overheight detection and warning system, including location of all system components, communication wiring diagram and power wiring diagram.
- Operations and maintenance manual for the overheight detection and warning system.
- Shop drawings of mounting assemblies for the vehicle height sensors, including their attachment to the poles.
- · Shop drawings of mounting LED warning beacons to the monotube sign structure.
- Shop drawings of mounting LED warning beacons to Traffic Signal Standard.
- Shop drawings for electrical service meter breaker pedestal.

The department will advise the contractor, in writing, as to the acceptability of the material submitted. The department may determine that if no exceptions were taken for the item, it is approved, and no further action is required by the contractor; or the item may be partially or totally rejected, in which case modify and/or amend the submittal as required by the department and resubmit the item within 14 days. At this time, the review and approval cycle described above will begin again.

13. Intelligent Transportation Systems – General Requirements.

Supplement standard spec 670 as follows

A Description

A.1 General

This contract includes furnishing and installing elements for an Intelligent Transportation System (ITS) in or along the existing roadway as shown on the plans.

A.2 Surge Protection

Equip every ungrounded conductor wire entering or leaving any equipment cabinet with a surge protector. For purposes of this section, multiple cabinets on a single pole or foundation are considered a single cabinet.

B Materials

B.1 General

Only furnish equipment and component parts for this work that are new and have high quality workmanship. All controls, indicators, and connectors shall be clearly and permanently labeled in a manner approved by the engineer. All equipment of each type shall be identical.

All electrical equipment shall conform to the standards and requirements of the Wisconsin Electrical Code, the National Electrical Manufacturers Association (NEMA), National Electric Safety Council (NESC), Underwriter's Laboratory Inc. (UL) or the Electronic Industries Association (EIA), when applicable. All materials and workmanship shall conform to the requirements of the National Electrical Code (NEC), Rural Electrification Administration (REA), Standards of the American Society for Testing and Materials (ASTM), American Association of State Highway and Transportation Officials (AASHTO), requirements of the plans these special provisions, the standard specifications, and to any other codes, standards, or ordinances that may apply. All system wiring, conduit, grounding hardware and circuit breakers shall be in conformance with the National Electrical Code. Whenever reference is made to any of the standards mentioned, the reference shall be considered to mean the code, ordinance, or standard that is in effect at the time of the bid advertisement.

B.2 Outdoor Equipment

All conductive connectors, pins (except pins connected by soldering), and socket contacts shall be gold plated. Acrylic conformal coating shall protect each circuit board side that has conductive traces. Except for integrated circuits containing custom firmware, all components shall be soldered to the printed circuit board.

To prevent galvanic corrosion, all connections between dissimilar metals shall incorporate a means of keeping moisture out of the connection. Where the connection need not conduct electricity, interpose a non-absorbing, inert material or washer between the dissimilar metals. Use nonconductive liners and washers to insulate fasteners from dissimilar metals. Where the connection shall conduct electricity, use a conductive sealant

between the dissimilar metals. Alternatively, use an insulating gasket and a bond wire connecting the two metal parts.

B.3 Custom Equipment

Equipment that is not part of the manufacturer's standard product line, or that is made or modified specifically for this project, shall conform to the following requirements:

Where practical, electronics shall be modular plug-in assemblies to facilitate maintenance. Such assemblies shall be keyed to prevent incorrect insertion of modules into sockets.

All components shall be available from multiple manufacturers as part of the manufacturers' standard product lines. All shall be clearly labeled with the value, part number, tolerance, or other information sufficient to enable a technician to order an exact replacement part.

Lamps used for indicator purposes shall be light-emitting diodes.

The printed circuit boards shall be composed of "two-ounce" copper on 1/16-inch thick fiberglass epoxy or equivalent type construction. Holes that carry electrical connections from one side of the boards to the other shall be completely plated through. Multilayer printed circuit boards shall not be used. The name or reference number used for the board in the drawings and maintenance manuals supplied to the department shall be permanently affixed to each board.

All components shall be mounted so that the identifying markings are visible without moving or removing any part, if practical.

B.4 Environmental Conditions

Equipment shall continue to operate as specified under the following ranges of environmental conditions, except as noted in the specifications for individual pieces of equipment.

Vibration and Shock:

 Any equipment mounted atop poles or on structures shall not be impaired by the continuous vibration caused by winds (up to 90 mph with a 30 percent gust factor) and traffic.

Duty Cycle:

Continuous

Electromagnetic Radiation:

• The equipment shall not be impaired by ambient electrical or magnetic fields, such as those caused by power lines, transformers, and motors. The equipment shall not radiate signals that adversely affect other equipment.

Electrical Power:

- Operating power: The equipment shall operate on 120-volts, 60-Hz, single-phase unless otherwise specified. It shall conform to its specified performance requirements when the input voltage varies from 89 to 135 volts and the frequency varies +3 Hz.
- High frequency interference: The equipment operation shall be unaffected by power supply voltage spikes of up to 150 volts in amplitude and 10 microseconds duration.
- Line voltage transients: The equipment operation shall be unaffected by voltage transients of plus or minus 20 percent of nominal line voltage for a maximum duration of 50 milliseconds. Equipment in the field shall meet the power service transient requirements of NEMA Standard TS-2 when connected to the surge protectors in the cabinets.

Temperature and Humidity:

- Field equipment: Equipment in the field shall meet the temperature and humidity requirements of NEMA Standard TS-2. Liquid crystal displays shall be undamaged by temperatures as high as 165 degrees F, and shall produce a usable display at temperatures up to 120 degrees F.
- Equipment in controlled environments shall operate normally at any combination of temperatures between 50 degrees F and 100 degrees F, and humidity between 5 percent and 90 percent, non-condensing, and with a temperature gradient of 9 degrees F per hour.

B.5 Patch Cables and Wiring

All cables and wiring between devices installed in a single cabinet, in separate cabinets sharing a single concrete base, and in a pole-mounted cabinet and equipment sharing the same pole will be considered incidental to the installation of the devices and no separate payment will be made for them. It is anticipated that this may include Ethernet cables, serial cables between individual devices and terminal servers, and power cables between individual devices and power sources within the cabinets.

B.6 Surge Protection

Low-voltage signal pairs, including twisted pair communication cable(s) entering each cabinet shall be protected by two-stage, plug-in surge protectors and shall be installed on both ends of camera control cables. The protectors shall meet or exceed the following minimum requirements:

- The protectors shall suppress a peak surge current of up to 10k amps.
- The protectors shall have a response time less than one nanosecond.
- The protector shall clamp the voltage between the two wires at a voltage that is no more than twice the peak signal voltage, and clamp the voltage between each wire and ground at 50 volts.
- The first stage of protection shall be a three-element gas discharge tube, and the second stage shall consist of silicon clamping devices.
- The protector shall also contain a resettable fuse (PTC) to protect against excessive current.

- There shall be no more than two pairs per protector.
- It shall be possible to replace the protector without using tools.

B.7 Grounding

All electrical and electronic grounding meets "SINGLE POINT" GROUNDING requirements. Single point grounding means referencing all grounded devices to a single point, one single piece ground rod, via the shortest and straightest route. Collect the devices' chassis and electrical grounds at a ground bus before connecting them to the earth ground rod. Connect the ground busses via conductors that meet the requirements of single point grounding.

Provide single point grounding by:

- Grounding all equipment to meet the requirements of the manufacturer;
- Routing each ground conductor to the ground bus via the straightest route that does not hinder maintenance or installation activities; and
- Cleaning each grounding component with 300-grit emery cloth before bonding. Apply a mineral oil based oxide inhibitor to the bond area.

An oxide inhibitor is applied over bonded connections to ground rods. The Oxide Inhibitor:

- Provides an airtight seal around the conductor and ground rod;
- May be applied to the bonded area between the temperatures of -22 degrees C (-30 degrees F) and 149 degrees C (300 degrees F);
- May be used on copper conductors;
- · Prevents oxides from forming; and is mineral oil based.

Selected Oxide Inhibitor shall be approved by the engineer.

- Bonding the ground conductor to the ground rod shall be accomplished through exothermic welding.
- Maintain the electrical continuity of the cable shields. Ground all cable shields entering an enclosure. Shield bonding complies with RUS splicing Standard PC-2, Section 3.3. Use bonding connectors complying with RUS standard PE-33 (Cable Shield Connectors).

C Construction

C.1 Thread Protection

Provide rust, corrosion, and anti-seize protection at all thread assemblies of metallic parts by coating (non-spray) the mating surfaces with an approved compound. Failure to use an approved compound will result in no payment for the items to which coating was to have been applied.

C.2 Cable Installation

When installing new cables into conduits containing existing cables, remove the existing cables and reinstall the existing cables simultaneously with the new cables. Take every precaution necessary to protect the existing cables. In the event of avoidable damage to the existing cables, replace all damaged cables, in-kind, at no additional expense to the

department. When cables are pulled into conduit, use a cable pulling lubricant approved by the cable manufacturer. Submit documentation supporting manufacturer approval of the lubricant to the engineer.

C.3 Wiring

Every conductor, except a conductor contained entirely within a single piece of equipment, must terminate either in a connector or on a terminal block. Provide and install the connectors and terminal blocks where needed, without separate payment. Use approved splice kits instead of connectors and terminal blocks for underground power cable splices.

Permanently label and key connectors to preclude improper connection.

Terminal blocks shall be affixed to panels that permanently identify the block and what wire connects to each terminal. This may be accomplished by silk screening or by installing a laminated printed card under the terminal block, with the labels on portions of the card that extend beyond the block. Installation of terminal blocks by drilling holes in the exterior wall of the cabinet is not acceptable.

Use barriers to protect personnel from accidental contact with all dangerous voltages.

Do not install conductors carrying AC power in the same wiring harness as conductors carrying control or communication signals.

Communication and control cables may not be spliced underground, except where indicated on the plans.

C.4 Surge Protection

Arrange the equipment and cabinet wiring to minimize the distance between each conductor's point of entry and its protector. Locate the protector as far as possible from electronic equipment. Ensure that all wiring between the surge protectors and the point of entry is free from sharp bends.

C.5 Labeling Cables and Components

Secure permanent identifying labels to each cable and component; including any required cross connects to communications equipment, according to these contract documents and information provided by the engineer. Use self-laminating vinyl labels at least 1-inch wide and long enough that the translucent portion of the label completely covers the white area bearing the legend. Use vinyl with a layer of pressure sensitive acrylic adhesive. Use labels that resist oil, water, and solvents and are self-extinguishing. Use a machine to print the legend in letters at least 1/8 inch high.

C.6 Electric and Electronic Cabling

Electric, electronic, video, and telephone cables are found within the project limits and may be impacted by construction activities. Exercise caution when working near existing cables.

- Exercise caution and dig by hand when exposing the existing cables. Seal all nicks or abrasions with rubber splicing tape. If the cable jacket is nicked so deeply that the armor is exposed, install an approved epoxy repair kit over the damaged area.
- · Stock approved splice kits to repair any cable, damaged by Construction activities.
- Use button style, gel filled, crimp-on butt splices enclosed in zippered poly bags, when making temporary, twisted pair, control cable splices. Protect the splices in an approved manner, above ground, until the permanent splices are installed.
- Install new cable between existing terminations or vaults, as appropriate, for cable severed by contract activities.
- The devices, enclosures, and material required for severed cable repair/replacement are incidental to the Contract

Selected splice kit shall be approved by the engineer.

- Permanent repairs to twisted pair cables are done using rigid-body, non-reenterable, enclosures in combination with button style, crimp-on butt splices. The closure is made of translucent polypropylene and packed with a urethane Compound. Rubber tape is used to seal the ends of the closure. The closure is available in 4-pr, 18-pr, and 50-pr sizes.
- The electric and electronic cables comply with the following specifications. Splices are not allowed in electric or electronic cables without the engineer's approval. Power, Control, and RF cables are one-piece cables between termination points.
- When using crimp-on connectors, install the insulation of electrical cables deep enough into the lug that the insulation acts as a strain relief. Crimp both the conductor and the insulation to the lug. When using crimp-on connectors, make the crimps with a ratchet style crimp tool. The AMP 59250 has met this specification.

Protect all cables not terminated immediately and stored below ground (in a pullbox) from moisture intrusion. Provide epoxy encapsulation for cable ends. It is not necessary to provide epoxy protection for cable ends stored above ground. Protecting power cable ends is incidental to the ITS subsystems.

D Measurement

No separate measurement will be made for the work described in this article.

E Payment

No separate payment will be made for the work described in this article. All work described in this article shall be included under the ITS items in the contract.

14. Overheight Vehicle Detection Assembly, Item SPV.0060.01.

A Description

This special provision describes furnishing and installing two overheight vehicle detection assemblies to detect all overheight vehicles on roadways approaching the IH 39 southbound bridge at CTH B (Bridge B-49-15). Each overheight vehicle detection assembly consists, in part, of a pair of detector units mounted on opposite sides of the roadway. Two overheight vehicle detection assemblies or "systems" are included in this

contract. System OHS-49-0001 is located on CTH B and system OHS-49-0002 is located on the IH 39 southbound off ramp to CTH B. Key system requirements are as follows:

- DETECTION- All overheight vehicles or overheight vehicle loads traveling towards the bridge on the monitored roadways shall be detected. Vehicles traveling away from the bridge shall be ignored by the detection equipment. Detection of the vehicles traveling toward the bridge shall be counted and recorded on an electronic counting device. The detectors shall be aligned parallel to the roadway grade in order to detect vehicles or loads of 14.5 feet or higher above all lanes and portions of lanes that approach the bridge.
- WARNING TO DRIVERS The system shall warn drivers that their vehicle is overheight through activation of flashing beacons as shown on the plans. The duration of the warning shall be user configurable from 1 to 30 seconds. The two beacons located on CTH B shall flash in unison at a rate of 1 Hz with 50 percent duty cycle. The four beacons located on the IH 39 southbound off ramp shall flash in an alternating (wig-wag) fashion such that the two beacons on the left side of the road flash in unison, alternating with the two beacons on the right side of the road flashing in unison. The IH 39 off ramp beacons shall also flash at 1 Hz with 50 percent duty cycle.
- PROVISION FOR AUDIO ALERT The overheight vehicle detection assembly shall be capable of providing an audio alert through a future system upgrade. The equipment provided under this contract shall support the addition of audio warning through the addition of only cabling and sound emission equipment (i.e. horn, siren, bell, etc.).
- PROVISION FOR POWER FAILURE In the event of power loss, the system shall resume normal operation immediately after restoration of power.

B Materials

B.1 General

Use stainless steel hardware (e.g. mounting bolts, nuts, washers, and external hinges, etc.) on outdoor components.

Use only components designed for 10, or more, years of industrial use.

Round and smooth the sharp corners and edges of all systems components.

B.3 Environmental Conditions

The overheight detection equipment shall operate and meet all of the requirements of this specification under the following conditions:

Temperature -40 F and 135 FRelative Humidity 0 to 100%

• Rain 2 inches per hour at 200 feet between source and detector

- Snow Light snow

FogWind Velocity200 foot visibility0 to 90 Miles per hour

B.4 Mechanical and Performance Requirements General

The detection system shall consist of transmitter and receiver units mounted on opposite sides of the roadway. The detector unit electronics shall be solid state with printed circuit boards and regulated power supply. The detector units shall be of modular assembly type. The detector units shall have an effective range of 10 feet to 700 feet with a reaction speed range of 1 MPH to 75 MPH for a 2 ½ inch diameter object 1 inch above the detection height. The detector units shall utilize two technologies to detect overheight vehicles: pulsed visible optics and pulsed infrared (IR) optics. The detector units shall eliminate the effect of ambient light, including ability to automatically switch to single beam detection mode if the sun or other interference saturates one detector. The variation of light intensity caused by the shadows of passing clouds shall not interfere with the proper operation of the equipment. The overheight detection system shall have a built-in meter and LEDs to facilitate proper aiming and fault indication.

Access

The detector units shall be provided with an enclosure to protect the operating equipment. The enclosure shall maintain its structural integrity for the operational life of the equipment and shall allow ready access for control adjustment and electrical interconnection without the use of any specialized tools. The enclosure shall have an internal environmental control element that reduces operational failure from fog, condensation, and insects. Dimensions shall not exceed a maximum overall size of 20 x 15 x 10 inches. The housing shall be cast of not less than 1/8" thickness and shall be weather sealed.

Mounting Provisions

Each of the detection units shall be provided with means for rigidly attaching the unit to a vertically cylindrical pole. The attachment means shall not stress or deform the unit and shall prevent the movement of the unit in any direction by the force developed by wind. The mounting means shall allow adjustment of the vertical position on the pole. The mounting means for the transmitter unit and the receiver unit shall have the capability of adjusting the angular orientation of the optical axis in both the horizontal and vertical plane over an angular range of plus or minus five degrees of the horizontal. The mounting shall allow for directional adjustment and aiming after initial installation.

Power and Signal Cable Connections

Provide all power and/or signal cabling between the receiver unit, transmitter unit, circuit breakers and flasher relays. A communication cable is required between the transmitter and receiver units to enable IR detection functionality. This cable is not shown in the plans. All flash relays shall be installed in a pole mounted cabinet located on the detection pole nearest the meter breaker pedestal, and shall be accessible from the ground.

Circuit Breaker Assignment

In addition to the main breaker, provide four 30-amp single-pole breakers in the Electric Service Meter Breaker Pedestal. One breaker shall power the transmitter, one the receiver, one the flasher relays/beacons, and one spare.

C Construction

C.1 General

Assemble, install and test the overheight detection and warning system as shown in the plans and as described in these special provisions.

C.2 Aiming

Align the optical axis parallel to the road surface elevation at a height of 14.5 feet as shown in the plans. If possible, install receiver unit such that the sun is outside 10 degrees of the unit's extended optical axes in all seasons.

C.3 Testing

Perform a one-day functional test in the presence of the engineer to demonstrate successful operation of all system functions. Tests will be conducted with an overheight vehicle (or vehicle with overheight load) to verify the system activates properly at a height of 14.5 feet on both CTH B and the IH 39 southbound off ramp. Verify the height of the test vehicle to the satisfaction of the engineer. Conduct testing in westbound direction to verify system does not activate for vehicles driving away from bridge. Conduct testing again with a vehicle height of 14.0 feet to verify the system does not activate. Drive vehicle in each of the lanes of CTH B for all test scenarios (14.5 foot, 14.0 foot, eastbound and westbound). Drive vehicle at prevailing speeds during all tests.

D Measurement

The department will measure Overheight Vehicle Detection Assembly by each individual unit, acceptably completed.

E Payment

The department will pay for measured quantities at the contract unit price under the following bid item:

Payment is full compensation for furnishing and installation of the overheight vehicle detection assembly, and for furnishing and installation of other materials necessary to provide a fully functional system. System testing is paid under 670.0100 Field System Integrator.

15. Contractor Provided H.S. Bolt Assemblies for Mono. Arms, Poles Type 12, Item SPV.0060.02.

A Description

Erect the sign mounting supports in accordance to standard spec 641. Install concrete masonry anchors in accordance to standard spec 502.2.12.

D Measurement

The department will measure Sign Mounting Supports as a single lump sum unit of work, acceptably completed.

B Materials

The department will furnish the traffic signal monotube materials to include the equipment listed in the plans, such as, poles, arms, luminaire arms, anchor bolts, and bolt templates.

C Construction

Contact North Central Region electrician Ken Radke at (715) 459-4264 at least five working days prior to make arrangements for picking up the department furnished materials. The pickup shall not be done on Fridays.

Load and transport the department furnished monotube materials, from the North Central Region Electrical Shop located in the Sign Shop at 2841 Industrial Street, Wisconsin Rapids to the installation site.

Provide, assemble and install all other traffic signal and lighting materials at the specified location in accordance to the pertinent provisions of the standard specifications and the plan details for each item.

Request a signal inspection of the completed signal installation. Make this request to the engineer at least five working days prior to the date of the requested inspection. The department's electricians will perform the inspection. The inspection will not be done on Fridays.

D Measurement

The department will measure Transport Department Furnished Traffic Signal Monotube Materials as a single lump sum unit of work for each location, acceptably completed.

E Payment

The department will pay for measured quantities at the contract unit price under the following bid item:

ADDITIONAL SPECIAL PROVISION 4

Payment to First-Tier Subcontractors

Within 10 calendar days of receiving a progress payment for work completed by a subcontractor, pay the subcontractor for that work. The prime contractor may withhold payment to a subcontractor if, within 10 calendar days of receipt of that progress payment, the prime contractor provides written notification to the subcontractor and the department documenting "just cause" for withholding payment.

The prime contractor may also withhold routine retainage from payments due subcontractors.

Payment to Lower-Tier Subcontractors

Ensure that subcontracting agreements at all tiers provide prompt payment rights to lower-tier subcontractors that parallel those granted first-tier subcontractors in this provision.

Release of Routine Retainage

After granting substantial completion the department may reduce the routine retainage withheld from the prime contractor to 75 percent of the original total amount retained.

When the Department sends the semi-final estimate the department may reduce the routine retainage withheld from the prime contractor to 10 percent of the original total amount retained.

Within 30 calendar days of receiving the semi-final estimate from the department, submit written certification that subcontractors at all tiers are paid in full for acceptably completed work and that no routine retainage is being withheld. The department will pay the prime contractor in full and reduce the routine retainage withheld from the prime contractor to zero when the department approves the final estimate.

This special provision does not limit the right of the department, prime contractor, or subcontractors at any tier to withhold payment for work not acceptably completed or work subject to an unresolved contract dispute.

ADDITIONAL SPECIAL PROVISION 6

ASP 6 - Modifications to the standard specifications

Make the following revisions to the 2014 edition of the standard specifications:

101.3 Definitions

Replace the definition of semi-final estimate with the following effective with the December 2013 letting:

Semi-final estimate An estimate indicating the engineer has measured and reported all contract quantities and materials requirements.

105.11.1 Partial Acceptance

Replace paragraph two with the following effective with the December 2013 letting:

(2) Partial acceptance will relieve the contractor of maintenance responsibility for the designated portion of the work. By relieving the contractor of maintenance, the department does not relieve the contractor of responsibility for defective work or damages caused by the contractor's operations. Do not construe partial acceptance to be conditional final acceptance or final acceptance of any part of the project, or a waiver of any legal rights specified under 107.16.

105.11.2 Final Acceptance

Retitle and replace the entire text with the following effective with the December 2013 letting:

105.11.2 Project Acceptance

105.11.2.1 Inspection

105.11.2.1.1 General

- (1) Notify the engineer when the project is substantially complete as defined in 105.11.2.1.3. As soon as it is practical, the engineer will inspect the work and categorize it as one of the following:
 - 1. Unacceptable or not complete.
 - 2. Substantially complete.
 - 3. Complete.

105.11.2.1.2 Unacceptable or Not Complete

- (1) The engineer will identify, in writing, work that is unacceptable or not complete. Immediately correct or complete that work. The engineer will assess contract time until the work is corrected or completed.
- (2) Proceed as specified in 105.11.2.1.1 until the engineer determines that the work is complete.

105.11.2.1.3 Substantially Complete

- (1) The project is substantially complete and the engineer will no longer assess contract time if the contractor has completed all contract bid items and change order work, except for the punch-list. As applicable, the following must have occurred:
 - 1. All lanes of traffic are open on a finished surface.
 - 2. All signage and traffic control devices are in place and operating.
 - 3. All drainage, erosion control, excavation, and embankments are completed.
 - 4. All safety appurtenances are completed.
- (2) The engineer will provide a written punch-list enumerating work the contractor must perform and documents the contractor must submit before the the engineer will categorize the work as complete.
 - 1. Punch-list work includes uncompleted cleanup work required under 104.9 and minor corrective work. Immediately correct or complete the punch-list work. The engineer may restart contract time if the contractor does not complete the punch-list work within 5 business days after receiving the written punch-list. The engineer and contractor may mutually agree to extend this 5-day requirement.
 - Punch-list documents include whatever contract required documentation is missing. The engineer may restart contract time if the contractor does not submit the punch-list documents within 15 business days after receiving the written punch-list. The engineer and contractor may mutually agree to extend this 15day requirement.
- (3) Proceed as specified in 105.11.2.1.1 until the work is complete.

105.11.2.1.4 Complete

(1) The project is complete when the contractor has completed all contract bid items, change order work, and punch-list work including the submission of all missing documentation.

105.11.2.2 Conditional Final Acceptance

(1) When the engineer determines that the project is complete, the engineer will give the contractor written notice of conditional final acceptance relieving the contractor of maintenance responsibility for the completed work.

105.11.2.3 Final Acceptance

- (1) The engineer will grant final acceptance of the project after determining that all contract is work complete; all contract, materials, and payroll records are reviewed and approved; and the semi-final estimate quantities are final under 109.7.
- (2) Failure to discover defective work or materials before final acceptance does not prevent the department from rejecting that work or those materials later. The department may revoke final acceptance if the department discovers defective work or materials after it has accepted the work.

(1) If required by the special provisions, provide or arrange for a subcontractor to provide railroad protective liability insurance in addition to the types and limits of insurance required in 107.26. Keep railroad protective liability insurance coverage in force until completing all work, under or incidental to the contract, on the railroad right of way or premises of the railroad and until the engineer determines that the work is complete as specified in 105.11.2.1.4.

107.26 Standard Insurance Requirements

Replace paragraph one with the following effective with the December 2013 letting:

(1) Maintain the following types and limits of commercial insurance in force until the engineer determines that the work is complete as specified in 105.11.2.1.4.

Replace paragraph two with the following effective with the December 2013 letting:

- (2) The department will pay for the quantity of work acceptably completed and measured for payment as the measurement subsection for each bid item specifies. Within the contract provide means to furnish and install the work complete and in-place. Payment is full compensation for everything required to perform the work under the applicable bid items including, but not limited to, the work elements listed in the payment subsection. Payment also includes all of the following not specifically excluded in that payment subsection:
 - 1. Furnishing and installing all materials as well as furnishing the labor, tools, supplies, equipment, and incidentals necessary to perform the work.
 - 2. All losses or damages, except as specified in 107.14, arising from one or more of the following:
 - The nature of the work.
 - The action of the elements.
 - Unforeseen difficulties encountered during prosecution of the work.
 - 3. All insurance costs, expenses, and risks connected with the prosecution of the work.
 - 4. All expenses incurred because of an engineer-ordered suspension, except as specified in 104.2.2.3.
 - 5. All infringements of patents, trademarks, or copyrights.
 - 6. All other expenses incurred to complete and protect the work under the contract.

109.6.1 General

- (3) The department's payment of an estimate before conditional final acceptance of the work does not constitute the department's acceptance of the work, and does not relieve the contractor of responsibility for:

The engineer and the contractor can mutually agree to extend this 30-day submission requirement.

Correct errata to reference to 105.11.2.3 as revised to implement changes to the finals process.

- (1) Under 105.11.2.3 the department may revoke acceptance and direct the contractor to repair or replace previously accepted sign installations if the department subsequently discovers evidence of defective materials or improper installation. Deficiencies that warrant department action include but are not limited to the following:
 - Sign posts more than five degrees out of plumb.
 - Signs twisted by more than 5 degrees from plan orientation.
 - Signs with delaminated or warped plywood.
 - Signs with bubbling, fading, delaminating, or buckling sheeting.

646.3.3.4 Proving Period

Correct errata to reference to 105.11.2.3 as revised to implement changes to the finals process.

(4) Replace all marking within sections with a percent failing more than 10% and repair or replace all markings that, in the engineer's assessment, show evidence of improper construction. If post-acceptance inspections uncover evidence of defective materials or improper construction, the department may revoke acceptance under 105.11.2.3.

ADDITIONAL SPECIAL PROVISION 7

- A. Reporting 1st Tier and DBE Payments During Construction
 - 1. Comply with reporting requirements specified in the department's Civil Rights Compliance, Contractor's User Manual, Sublets and Payments.
 - 2. Report payments to all DBE firms within 10 calendar days of receipt of a progress payment by the department or a contractor for work performed, materials furnished, or materials stockpiled by a DBE firm. Report the payment as specified in A(1) for all work satisfactorily performed and for all materials furnished or stockpiled.
 - 3. Report payments to all first tier subcontractor relationships within 10 calendar days of receipt of a progress payment by the department for work performed. Report the payment as specified in A(1) for all work satisfactorily performed.
 - 4. All tiers shall report payments as necessary to comply with the DBE payment requirement as specified in A(2).
 - 5. Require all first tier relationships, DBE firms and all other tier relationships necessary to comply with the DBE payment requirement in receipt of a progress payment by contractor to acknowledge receipt of payment as specified in A(1), (2), (3) and (4).
 - 6. All agreements made by a contractor shall include the provisions in A(1), (2), (3), (4) and (5), and shall be binding on all first tier subcontractor relationships and all contractors and subcontractors utilizing DBE firms on the project.
- B. Costs for conforming to this special provision are incidental to the contract.

ADDITIONAL SPECIAL PROVISION 9 Electronic Certified Payroll Submittal

- (1) Use the department's Civil Rights Compliance System (CRCS) to submit certified payrolls electronically. Details are available online through the department's highway construction contractor information (HCCI) site on the Labor, Wages, and EEO Information page at: http://roadwaystandards.dot.wi.gov/hcci/labor-wages-eeo/index.shtm
- (2) Ensure that all tiers of subcontractors, as well as all trucking firms, submit their weekly certified payrolls electronically through CRCS. These payrolls are due within seven calendar days following the close of the payroll period. Every firm providing physical labor towards completing the project is a subcontractor under this special provision.
- (3) Upon receipt of contract execution, promptly make all affected firms aware of the requirements under this special provision and arrange for them to receive CRCS training as they are about to begin payrolls. The department will provide training either in a classroom setting at one of our regional offices or by telephone. Contact Tess Mulrooney at 608-267-4489 to schedule the training.
- (4) The department will reject all paper submittals of forms DT-1816 and DT-1929 for information required under this special provision. All costs for conforming to this special provision are incidental to the contract.
- (5) Firms wishing to export payroll data from their computer system into CRCS should have their payroll coordinator send several sample electronic files to Tess two months before a payroll needs to be submitted. Not every contractor's payroll system is capable of producing export files. All steel and iron materials permanently incorporated in this project shall be domestic products and all manufacturing and coating processes for these materials from smelting forward in the manufacturing process must have occurred within the United States. Coating includes epoxy coating, galvanizing, painting and any other coating that protects or enhances the value of a material subject to the requirements of Buy America. The exemption of this requirement is the minimal use of foreign materials if the total cost of such material permanently incorporated in the product does not exceed one-tenth of one percent (1/10 of 1%) of the total contract cost or \$2,500.00, whichever is greater. For purposes of this paragraph, the cost is that shown to be the value of the subject products as they are delivered to the project. The contractor shall take actions and provide documentation conforming to CMM 2-28.5 to ensure compliance with this "Buy America" provision.

I. WAGE RATES, HOURS OF LABOR AND PAYMENT OF WAGES

The schedule of "Minimum Wage Rates" attached hereto and made a part hereof furnishes the prevailing wage rates that have been determined pursuant to Section 103.50 of the Wisconsin Statutes. These wage rates are the minimum required to be paid to the various laborers, workers, mechanics and truck drivers employed by contractors and subcontractors on the construction work embraced by the contract and subject to prevailing hours and wages under Section 103.50, Stats. If necessary to employ laborers, workers, mechanics or truck drivers whose classification is not listed on the schedule, they shall be paid at rates conformable to those listed for similar classifications. Apprentices shall be paid at rates not less than those prescribed in their state indenture contacts.

While the wage rates shown are the minimum rates required by the contract to be paid during its life, this in not a representation that labor can be obtained at these rates. It is the responsibility of bidders to inform themselves as to the local labor conditions and prospective changes or adjustments of wage rates. No increase in the contract price shall be allowed or authorized on account of the payment of wage rates in excess of those listed herein.

Pursuant to Section 103.50 of the Wisconsin Statutes, the prevailing hours of labor have been determined to be up to 10 hours per day and 40 hours per calendar week Monday through Friday. If any laborer, worker, mechanic or truck driver is permitted or required to work more than the prevailing number of hours per day or per calendar week on this contract, they shall be paid for all hours in excess of the prevailing hours at a rate of at least one and one-half (1 1/2) times their hourly rate of pay. All work on Saturday, Sunday and the following holidays is to be paid at time and a half: (1) January 1, (2) the last Monday in May, (3) July 4, (4) the first Monday in September, (5) the fourth Thursday in November, (6) December 25, (7) the day before if January 1, July 4 or December 25 falls on a Saturday and (8) the day following if January 1, July 4 or December 25 falls on a Sunday.

All laborers, workers, mechanics and truck drivers shall be paid unconditionally not less often than once a week. Persons who own and operate their own trucks must receive the prevailing truck driver rate for the applicable type of truck (i.e. 2 axle, 3 or more axle, articulated, eculid or dumptor) he or she operates, plus an agreed upon amount for the use of his or her truck. Every owner-operator MUST be paid separately for their driving and for the use of their truck.

For those projects subject to the requirements of the Davis-Bacon Act, the Secretary of Labor will also have determined "Minimum Wage Rates" for work to be performed under the contract. These rates are, for all or most of the labor, worker, mechanic or truck driver classifications, identical to those established under Section 103.50 of the Wisconsin Statutes. In the event the rates are not identical, the higher of the two rates will govern.

II. PAYROLL REQUIREMENTS

All contractors and subcontractors must submit weekly Certified Payrolls and Compliance Statement verifying that all laborers, workers, mechanics and truck drivers working on the project have been paid the prevailing wage rates for all work performed under the contract required by Section 103.50 of the Wisconsin Statutes.

III. POSTINGS AT THE SITE OF THE WORK

In addition to the required postings furnished by the Department, the contractor shall post the following in at least one conspicuous place at the site of work:

- a. "NOTICE TO EMPLOYEES," which provides information required to be posted by the provisions of Section 103.50 of the Wisconsin Statutes.
- b. A copy of the State of Wisconsin Minimum Wages Rates. (Four pages.)
- c. A copy of the contractor's Equal Employment Opportunity Policy.
- d. On any project involving federal aid, in addition to the furnished postings, the contractor shall post a copy of the "Davis-Bacon Act, Minimum Wage Rates". (Three pages.)

IV. WAGE RATE REDISTRIBUTION

The amount specified as the hourly basic rate of pay and the amount(s) specified as the fringe benefit contribution(s), for all classes of laborers, workers, mechanics or truck drivers may be redistributed, when necessary, to conform to those specified in any applicable collective bargaining agreement, provided that both parties to such agreement

request and receive the approval for any such redistribution from both the Department of Transportation and the Department of Workforce Development prior to the implementation of such redistribution.

V. ADDITIONAL CLASSIFICATIONS

Any unlisted laborer or mechanic classification that is needed to perform work on this project, and is not included within the scope of any of the classifications listed in the application prevailing wage rate determination, may be added after award only if all of the following criteria have been met:

- 1. The affected employer(s) must make a written request to WisDOT Central Office to utilize the unlisted classification on this project.
- 2. The request must indicate the scope of the work to be performed by the unlisted classification and must indicate the proposed wage/fringe benefit package that the unlisted classification is to receive.
- 3. The work to be performed by the unlisted classification must not be performed by a classification that is included in the applicable prevailing wage rate determination.
- 4. The unlisted classification must be commonly employed in the area where the project is located.
- 5. The proposed wage/fringe benefit package must bear a reasonable relationship to those set forth in the applicable prevailing wage rate determination.
- 6. The request should be made prior to the actual performance of the work by the unlisted classification.
- 7. DWD must approve the use of the unlisted classification and the proposed wage/fringe benefit package. USDOL also must approve the use of the unlisted classification and the proposed wage/fringe benefit package on federal aid projects.
- 8. WisDOT and DWD may amend the proposed wage/fringe benefit package, as deemed necessary, and may set forth specific employment ratios and scope of work requirements in the approval document.

The approved wage/fringe benefit package shall be paid to all laborers, workers, mechanics or truck drivers performing work within the scope of that performed by the unlisted classification, from the first day on which such work is performed. In the event that work is performed by the unlisted classification prior to approval, the wage/fringe benefit package to be paid for such work must be in conformance with the wage/fringe

benefit package approved for such work. Under this arrangement a retroactive adjustment in wages and/or fringe benefits may be required to be made to the affected laborers, workers, mechanics or truck drivers by the affected employer(s).

FUTURE INCREASE: If indicated for a specific trade or occupation, the full amount of such increase MUST be added to the "TOTAL" indicated for such trade or occupation on the date(s) such increase(s) becomes effective.

PREMIUM PAY: If indicated for a specific trade or occupation, the full amount of such pay MUST be added to the "HOURLY BASIC RATE OF PAY" indicated for such trade or occupation, whenever such pay is applicable.

SUBJOURNEY: Wage rates may be available for some of the classifications indicated below. Any employer that desires to use any subjourney classification on a project MUST request the applicable wage rate from the Department of Workforce Development PRIOR to the date such classification is used on such project. Form ERD-10880 is available for this purpose and can be obtained by writing to the Department of Workforce Development, Equal Rights Division, P.O. Box 8928, Madison, WI 53708.
