# PROPOSAL REQUIREMENTS AND CONDITIONS

The bidder, signing and submitting this proposal, agrees and declares as a condition thereof, to be bound by the following conditions and requirements.

If the bidder has a corporate relationship with the proposal design engineering company, the bidder declares that it did not obtain any facts, data, or other information related to this proposal from the design engineering company that was not available to all bidders.

The bidder declares that they have carefully examined the site of, and the proposal, plans, specifications and contract forms for the work contemplated, and it is assumed that the bidder has investigated and is satisfied as to the conditions to be encountered, as to the character, quality, and quantities of work to be performed and materials to be furnished, and as to the requirements of the specifications, special provisions and contract. It is mutually agreed that submission of a proposal shall be considered conclusive evidence that the bidder has made such examination.

The bidder submits herewith a proposal guaranty in proper form and amount payable to the party as designated in the advertisement inviting proposals, to be retained by and become the property of the owner of the work in the event the undersigned shall fail to execute the contract and contract bond and return the same to the office of the engineer within fourteen (14) days after having been notified in writing to do so; otherwise to be returned.

The bidder declares that they understand that the estimate of quantities in the attached schedule is approximate only and that the attached quantities may be greater or less in accordance with the specifications.

The bidder agrees to perform the said work, for and in consideration of the payment of the amount becoming due on account of work performed, according to the unit prices bid in the following schedule, and to accept such amounts in full payment of said work.

The bidder declares that all of the said work will be performed at their own proper cost and expense, that they will furnish all necessary materials, labor, tools, machinery, apparatus, and other means of construction in the manner provided in the applicable specifications and the approved plans for the work together with all standard and special designs that may be designed on such plans, and the special provisions in the contract of which this proposal will become a part, if and when accepted. The bidder further agrees that the applicable specifications and all plans and working drawings are made a part hereof, as fully and completely as if attached hereto.

The bidder, if awarded the contract, agrees to begin the work not later than ten (10) days after the date of written notification from the engineer to do so, unless otherwise stipulated in the special provisions.

The bidder declares that if they are awarded the contract, they will execute the contract agreement and begin and complete the work within the time named herein, and they will file a good and sufficient surety bond for the amount of the contract for performance and also for the full amount of the contract for payment.

The bidder, if awarded the contract, shall pay all claims as required by Section 779.14, Statutes of Wisconsin, and shall be subject to and discharge all liabilities for injuries pursuant to Chapter 102 of the Statutes of Wisconsin, and all acts amendatory thereto. They shall further be responsible for any damages to property or injury to persons occurring through their own negligence or that of their employees or agents, incident to the performance of work under this contract, pursuant to the Standard Specifications for Road and Bridge Construction applicable to this contract.

In connection with the performance of work under this contract, the contractor agrees to comply with all applicable state and federal statutes relating to non-discrimination in employment. No otherwise qualified person shall be excluded from employment or otherwise be subject to discrimination in employment in any manner on the basis of age, race, religion, color, gender, national origin or ancestry, disability, arrest or conviction record (in keeping with s.111.32), sexual orientation, marital status, membership in the military reserve, honesty testing, genetic testing, and outside use of lawful products. This provision shall include, but not be limited to the following: employment, upgrading, demotion or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation, and selection for training, including apprenticeship. The contractor further agrees to ensure equal opportunity in employment to all applicants and employees and to take affirmative action to attain a representative workforce.

- 1. By signing and submitting this proposal, the prospective contractor is providing the certification set out below.
- 2. The inability of a person to provide the certification required below will not necessarily result in denial of participation in this covered transaction. The prospective contractor shall submit an explanation of why it cannot provide the certification set out below. The certification or explanation will be considered in connection with the department or agency's determination whether to enter into this transaction. However, failure of the prospective contractor to furnish a certification or an explanation shall disqualify such person from participation in this transaction.
- 3. The certification in this clause is a material representation of fact upon which reliance was placed when the department determined to enter into this transaction. If it is later determined that the contractor knowingly rendered an erroneous certification in addition to other remedies available to the Federal Government the department may terminate this transaction for cause or default.
- 4. The prospective contractor shall provide immediate written notice to the department to whom this proposal is submitted if at any time the prospective contractor learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
- 5. The terms "covered transaction," "debarred," "suspended," "ineligible," "lower tier covered transaction," "participant," "person," "primary covered transaction," "principal," "proposal," and "voluntarily excluded," as used in this clause, have the meanings set out in the Definitions and Coverage sections of the rules implementing Executive Order 12549. The prospective contractor agrees by submitting this proposal that, should this contract be entered into, it shall not knowingly enter into any lower tier covered transaction with a person who is debarred, suspended, declared ineligible, or voluntarily excluded from participation in this covered transaction, unless authorized by the department entering into this transaction.

#### SPECIAL PROVISIONS

# 1. General.

Perform the work under this construction contract for Project 1390-04-98, Jefferson Bypass, CTH W to CTH J, Salt Storage Facility, STH 26, Jefferson County, Wisconsin as the plans show and execute the work as specified in the State of Wisconsin, Department of Transportation, Standard Specifications for Highway and Structure Construction, 2014 Edition, as published by the department, and these special provisions.

If all or a portion of the plans and special provisions are developed in the SI metric system and the schedule of prices is developed in the US standard measure system, the department will pay for the work as bid in the US standard system. 100-005 (20130615)

# 2. Scope of Work.

The work under this contract shall consist of constructing two salt storage structures and all incidental items necessary to complete the work as shown on the plans and included in the proposal and contract.

# 3. Waiving Bidder Prequalification.

Bidder prequalification is not required; however, prior to awarding a contract, the department may require the bidder to produce financial documentation similar to the prequalification statement (DT1621) and evidence that they have a history of performing work of a similar character in a satisfactory manner.

# 4. Prosecution and Progress.

Begin work within ten calendar days after the engineer issues a written notice to do so.

Provide the start date to the engineer in writing within a month after executing the contract but at least 14 calendar days before the preconstruction conference. Upon approval, the engineer will issue the notice to proceed within ten calendar days before the approved start date.

To revise the start date, submit a written request to the engineer at least two weeks before the intended start date. The engineer will approve or deny that request based on the conditions cited in the request and its effect on the department's scheduled resources.

Submit an Erosion Control Implementation Plan (ECIP) meeting the requirements of standard spec 107.20 for any selected waste sites at least 14 calendar days before the preconstruction conference.

Construction shall not begin prior to April 1, 2015 without written approval from the engineer.

# 5. Traffic.

Work under this contract will be conducted off the state highway system and will not require traffic control.

Obtain prior approval from the engineer for the location of egress and ingress for construction vehicles to prosecute the work.

The traffic requirements are subject to change at the direction of the engineer in the event of an emergency.

# 6. Project Communication Enhancement Effort.

Use the Project Communication Enhancement Effort (PCEE) tools on this contract. Coordinate with the department to modify the various published tools as necessary to meet the particular project needs and determine how to implement those tools under the contract. Ensure the full participation of the contractor and its principal subcontractors throughout the term of the contract.

# **A Description**

This special provision describes designing, providing and installing a fully-operational salt brine making system consisting of the following major components:

- · Salt brine maker, salinity control system
- Two-product blending system

The system shall comply with the following requirements:

# A Description

This special provision describes designing, providing and erecting a 100'-0" wide by 152'-0" long high-arch gambrel style storage buildings located adjacent to each other with pressure treated wood structures, concrete foundations, fans and electrical systems as shown in the plans and hereinafter provided.

The building shall be self-supporting with no internal supports inside to hamper loading and unloading of material complete with doorways on each end of the building. The buildings shall be constructed of pressure treated wood members.

Provide a ten year warranty on the roof. Include labor and a 30 year warranty on shingle materials in the warranty.

The salt storage building shall be of sufficient size to store a minimum of 8,000 tons each of deicing salt based on the weight of 80 lbs. per cubic foot. Storage of piled salt shall have a repose angle of 32 degrees. Totally unobstructed and usable floor area within the interior walls shall be approximately 16,000 square feet. Buildings shall be a maximum of 57'-0" feet high and shall include a built-in fan dormer for a 30-inch diameter exhaust fan as

The salt storage building will be located on a newly developed site for the Jefferson County Highway Department. The new salt sheds shall be located on the north side of this site. Construction activities will be ongoing for other parts of the facility concurrent with the construction of the salt storage buildings. The bonding company must have an AM Best rating of "A-"or better and the contractor will provide proof of a ten-year bond commitment before execution of the contract.

The warranty bond will be \$24,000 for the warranted roof. The bond will ensure the proper and prompt completion of required warranty work for the duration of the warranty period, including payments for furnishing all labor, equipment and materials used according to this specification.

The contract bond, which remains in effect for one year beyond the completion of the project, will also include warranty work as described in Section C.15 Warranty Work of this article. For the remaining nine-year warranty period, provide documentation that the warranty bond will remain in effect for the portion of the warranty period after expiration of the contract bond.

If a subcontractor places the warranted roof, the subcontractor may provide the warranty bond for the remaining nine-year warranty period after expiration of the contract bond. If the subcontractor does provide the bond, it shall be a dual obligee bond, naming the contractor and the Wisconsin Department of Transportation as obligees. The subcontractor shall provide documentation that the warranty bond will remain in effect for the portion of the warranty period after expiration of the contract bond.

Failure of the contractor, subcontractor or its surety to issue or renew the warranty bond will be considered a default and will result in forfeiture of the face amount of the bond to the department.

The salt shed contractor shall coordinate with the main site contractor and owner's representative for staging areas. All bidders are invited to inspect the site prior to bidding.

#### **B.2** Earthwork and Foundation Excavation

The main site contractor will prepare the site for the building so that the grade within the building area is level to within plus or minus 2", and so that the grade of the surrounding area slopes away from the building in all directions sufficiently to ensure proper drainage. The salt storage building contractor shall excavate and backfill to original grade for the foundation footings.

# **B.3** Asphalt Flooring and Paving

# **B.4 Building Products**

The following minimum required standards shall be met for the products listed:

#### Metal Plates and Fasteners:

Metal plates and fasteners used in the building (truss bearing plates, shear plates, truss gusset plates, joist hangers, nails, bolts, nuts, washers, screws, etc.) which are in direct contact with salt, or which are exposed to an atmosphere containing salt, shall be designed to resist corrosion due to such contact or exposure.

- Truss bearing plates, bolts, and washers: to be stainless steel.
- Truss gusset plates: to be galvanized steel, epoxy coated.
- Joist hangers: to be triple-zinc coated.
- · Nails applied to CCA or CDX lumber shall be galvanized.

#### Wood Products:

All above-ground lumber exposed to weather, or directly in contact with salt, shall be preservative treated with water-borne preservatives for above-ground use, complying with AWPA-LP-2 (CCA .40). Provide exterior grade plywood in thicknesses that comply with loading and code requirements and are compatible with proposed roofing system.

# Exterior Wall System:

Provide exterior wall system or components of pressure treated wood as indicated on the drawings to provide a durable weather-resistant barrier, which may be maintained easily by owner with non-proprietary products readily available for such purpose.

The salt shed contractor shall provide engineering showing that the proposed exterior wall system meets loading and code requirements and is designed by a licensed engineer.

#### Barrier Wall:

Provide a suitable interior protective barrier wall conforming to the following:

- Barrier wall and supports to be pressure treated wood. No concrete to be used above grade.
- No matter what type barrier wall is used, exterior braces must be provided to support the wall columns and to support the loads on the wall described below.
- Design the barrier wall to resist the weight (i.e., forces) of salt and sand assuming the following loading conditions:
- Salt and sand will be stored to a contained height of twelve 12 feet against the barrier wall.
- The salt and sand will further slope upwards and away from the wall toward a peak or ridge in the center of the building at a 32 degree angle of repose.

# Electrical and Lighting:

Perform all electrical work per applicable codes and shall be inspected and approved by the local building department. Coordinate the power supply to the salt storage building. Power shall be placed underground and be brought to the side nearest the southern building entrance. Place electrical underground conduit prior to commencement of asphalt pad construction. Locate the electrical panel in compliance with proper clearances in compliance with all applicable codes on the interior face of the southern building walls, adjacent to the entryway.

Electrical power for salt shed storage to originate from brine mixing building located to the west of the proposed salt storage buildings. Refer to architectural site plan for exact location. Architectural site plan is available from Jefferson County Representative, Chris Raykowski. Panel "RP/BM" located in the southeast corner of the brine mixing building and shall have space to install a 200-ampere, 3-pole circuit breaker to extend electrical power at 208Y/120-volt to the salt shed storage buildings as needed. Panel "RP/BM" to be installed by others under separate contract.

Power to the salt shed building shall be 208Y/120-Volt, 3-phase, 4-wire, 60 hertz unless otherwise approved by the engineer. Contractor shall confirm power supply with engineer prior to beginning work. On the exterior side of the entryway, the electrical contractor shall install a heavy duty, NEMA 3R rated 200-ampere, 208Y/120-volt, 3-phase, 4-wire electrical panel with wiring to power the following:

- Install two electrical outlets next to the electrical breaker panel in accordance to local code requirements.
- Install fixtures with all necessary switches and wiring to the fixtures and to the electrical fan. Light fixtures shall be positioned as follows on the appropriate location:
- Installation shall include LED light fixtures equally spaced around the upper one-third of the structure to provide 20 foot candles. The fixtures shall be industrial moisture-proof types for use of this nature and two exterior fixture mounted over the canopy of each entranceway. Install the interior fixtures so as not to be hidden or obstructed by any building construction and aligned to completely illuminate the full interior of the building.
- Installation shall include LED light fixtures equally spaced around the exterior of the building for general security illumination. Exterior fixtures shall have photocell switch for local on/off control.
- All exterior conduits shall be galvanized metal Rigid Galvanized Steel (RGS) or Intermediate Metallic Conduit (IMC). All interior conduits to be non-metallic Schedule 40 PVC.

- All pull boxes and junction boxes inside the structure shall be non-metallic PVC, weatherproof and corrosion resistant. They shall be firmly attached to the walls of the structure. The contractor shall install a flush-mounted switch for controlling interior lights.

- · Place all electrical underground conduits prior to commencement of pad construction.
- All electrical loads associated with the salt storage shed building shall be wired back to the electrical panel located on the exterior of the building as indicated previously.

# Pipe Bollards:

Furnish and install pipe bollards indicated on the drawings to be used as door jamb guard posts, minimum 6 inches in diameter and 6 feet in height above finished grade, consisting of standard weight galvanized steel structural pipe, filled with concrete. Form concrete crown at top of bollard. These shall be embedded in concrete footings, and painted federal safety yellow using rust-inhibitive paint. Paint shall be applied to entire length of pipe, including the joint between pipe and footing.

#### Accessories:

General: Provide accessories as standard with metal building system manufacturer and as specified. Fabricate and finish accessories at the factory to greatest extent possible, by manufacturer's standard procedures and processes. Comply with indicated profiles and with dimensional and structural requirements.

 Form exposed sheet metal accessories that are without excessive oil-canning, buckling, and tool marks and that are true to line and levels indicated, with exposed edges folded back to form hems.

Flashing and Trim: Formed from 0.022-inch nominal-thickness, metallic-coated steel sheet or aluminum-zinc alloy-coated steel sheet pre-painted with coil coating; finished to match adjacent metal panels.

Roof Ventilators: Gravity type, complete with hardware, flashing, closures, and fittings.

Circular-Revolving Type: Minimum 20-inch- diameter throat opening; finished to match metal roof panels; with matching base and rain cap.

- Type: Directional revolving.
- · Bird Screening: Galvanized steel or aluminum.
- Dampers: Spring-loaded, butterfly type; pull-chain operation; with pull chain of length required to reach within 36 inches of floor.
- Continuous or Sectional-Ridge Type: Factory-engineered and -fabricated, continuous unit; fabricated from 0.022-inch nominal-thickness, metallic-coated steel sheet or aluminum-zinc alloy-coated steel sheet pre-painted with coil coating; finished to match metal roof panels. Fabricated in minimum 10-foot- long sections. Provide throat size and total length indicated, complete with side baffles, ventilator assembly, end caps, splice plates, and reinforcing diaphragms.
- · Bird Screening: Galvanized steel or aluminum.
- Dampers: Manually operated, spring-loaded, vertically rising type; chain and worm gear operator; with pull chain of length required to reach within 36 inches of floor.
- Throat Size: 9 or 12 inches, as standard with manufacturer, and as required to comply with ventilation requirements.

# **B.5** Final Grading and Restoration

Complete all final grading and site restoration activities. The contractor shall restore any and all of the 8-Inch deep base aggregate dense 3-inch layer disturbed as part of the salt storage facility construction activities to the pre-construction condition. The material used as part of the restoration may be salvaged at the time the foundation excavation is completed or new material hauled to the site meeting the requirements of standard spec 305.

# **B.6** Electrical

Provide power to the building and furnish and install all lighting, wiring, and other electrical equipment.

# **C** Construction

Provide construction execution in compliance with the following:

# C.1 Dimensional Requirements for Rectangular Building

Width: 100'-0". Length: 152'-0".

Vertical Side Wall Height: 12' above finished floor.

Overall Height: Not to exceed 57'-0" above finished grade.

## **C.2** Loading Method

The building shall be filled without the use of conveyors, grain augers, or similar loading equipment. For this reason, it shall be designed to permit delivery of materials directly into the building, including by such vehicles as tractor-trailer trucks.

#### C.3 Storage Method

The building shall, when filled to capacity, enclose the material stored entirely within the structure, exclusive of the entranceway. Pile sides shall be enclosed by the interior barrier

wall described in 3.01.G. The remaining uncontained pile sides, above the contained portion, shall be assumed to be sloped at a 32-degree angle of repose.

## **C.4 Building Structural Requirements**

Provide a rigid, self-supporting structure comprised of standard building framing components, or an approved building system of integrated structural components, complete with necessary foundations which are designed to securely and permanently support roof and wall construction. Building shall meet or exceed the following minimum structural design criteria:

• Ground Snow Load: 30 pounds per square foot.

· Lateral Wind Load: 95 mph.

· Soil Bearing Pressure: 3,000 pounds per square foot.

## **C.5** Interior Space

Provide unobstructed interior space to allow charging and re-charging of the pile storage area to full capacity, and to allow unimpeded loading of truck-spreader vehicles with frontend loading equipment. Provide the entire interior floor area free of columns or roof supports of any type.

Minimum Center Clearance: Provide a 30-ft. clear height at the center of the building width and extending the length of the building. This clearance shall be maintained in an area at least 20 feet wide, centered on the entranceways and running the length of the structure.

## **C.6 Barrier Walls**

Provide a suitable protective barrier wall conforming to the following:

Barrier wall and supports to be pressure treated wood, complying with B.4. No concrete to be used above grade.

• No matter what type barrier wall is used, exterior braces must be provided to support the wall columns and to support the loads on the wall described below.

Design the barrier wall to resist the weight (i.e., forces) of salt and sand assuming the following loading conditions:

- Salt and sand will be stored to a contained height of 12 feet against the barrier wall.
- The salt and sand will further slope upwards and away from the wall toward a peak or ridge in the center of the building at a 32 degree angle of repose.
- The resulting horizontal force created against the wall will be 0.719 times the weight of the sand and salt.

Wall shall be designed to resist salt and sand load of 100 pcf, to resist a horizontal impact load of 250 lbs., and to resist structural damage from abrasion by salt loading equipment.

Design and construct the barrier wall to require minimal maintenance. It shall be arranged for easy replacement of components by maintenance personnel without requiring the use of heavy equipment.

## **C.7** Exterior Wall Construction

Provide exterior wall system or components of pressure treated wood as indicated on the drawings to provide a durable weather-resistant barrier, which may be maintained easily by owner with non-proprietary products readily available for such purpose.

#### C.8 Doors

Provide two unobstructed rectangular entrance openings, one at each end of the building, nominal dimensions to be 30' high by 22' wide.

- In each opening, provide an upward acting sectional door (overhead) designed for 20 psf minimum wind load. Supply and install all wood head and jamb framing and blocking as called for by door manufacturer.
- A chain hoist to provide capability for manual operation of each door shall be included.
- Electric door operators shall be jack shaft, side mounted, model as recommended by door manufacturer for door size and lift condition, with standard hardware operable both from inside and outside of building.

In the crib wall adjacent to the each overhead door, furnish and install one 3'-0" x 7'-0" exterior grade fiberglass swing-out pass door with jambs and hardware, color as selected by owner.

## **C.9 Pipe Bollards**

Furnish and install two pipe bollards to be used as door jamb guard posts, minimum 6 inches in diameter and 10 feet in length, consisting of standard weight galvanized steel structural pipe, filled with concrete. Form concrete crown at top of bollard. These shall be embedded in concrete footings, and painted federal safety yellow using rust-inhibitive paint. Paint shall be applied to entire length of pipe, including the joint between pipe and footing.

## **C.10** Roofing System

Install felt underlayment on roof deck not covered by self-adhering sheet underlayment.

Install metal flashings according to recommendations in NRCA's "The NRCA Roofing and Waterproofing Manual."

Install first and remaining courses of asphalt shingles stair-stepping diagonally across roof deck with manufacturer's recommended offset pattern at succeeding courses, maintaining uniform exposure.

#### C.11 Ventilation

Provide suitable openings located at or near the highest point of the roof to provide a minimum ratio of 1 sq. inch of free air area for each 55 sq. feet of building floor area.

#### C.12 Electrical Work

Perform all electrical work per applicable codes and shall be inspected and approved by the local building department.

## C.13 Testing

Testing for all materials shall be in accordance to the pertinent section of the standard specifications and performed by the contractor.

The contractor shall also provide maintenance and service information for the principal components of the salt storage building.

## C.14 Construction Staking and Survey

Perform all survey and constructions taking necessary to complete construction to the dimensions and elevations identified in the contract plans and specifications. Bench mark data is included in the plans. The contractor shall verify the accuracy of the bench marks with the site representative for Jefferson County prior to the start of construction.

## C.15 Warranty Work

Perform warranty work for the roof during the ten-year warranty period at no additional cost to the department or county. Warranty work consists of remedial work and elective/preventive maintenance. Maintain insurance for performing warranty work as specified in standard spec 107.26 throughout the warranty period.

During warranty work operations, traffic control will be as specified in standard spec 643 and all will conform to Part 6 of the Wisconsin Manual on Uniform Traffic Control Devices.

The contractor shall document all warranty work performed and annually provide this information to the county.

If warranty work causes damage to the Salt Storage Building and all associated components, repair or replacement of the damage will be the responsibility of the contractor. Use replacement materials of the same kind specified in the original contract unless mutually agreed otherwise by the engineer and the contractor.

All warranty work including, but not limited to, remedial work and elective/preventive maintenance shall require a permit from the county. The county will provide contact information for obtaining a permit to the contractor.

Document all warranty work performed. Use the departments form DT2305 to provide this information to the county each time work is performed on a warranty project.

## C.16 Remedial Work

Remedial work will be based on the result of manual surveys or evaluations. Perform remedial work in the same calendar year that the distresses were recorded. Remedial work to be performed and materials to be used will be the joint decision of the contractor and the engineer.

The contractor will have the first option to perform the remedial work. If, in the opinion of the engineer, the problem requires immediate attention for the safety of the public, and the contractor cannot perform the remedial work within eight hours, the engineer may have the remedial work performed by other forces and at the contractor's expense.

Remedial work performed by other forces will not alter the requirements, responsibilities, or obligations of the warranty.

If remedial action work or elective/preventive action work performed by the contractor necessitates a corrective action to other components of the Salt Storage Building, then such corrective action will be the responsibility of the contractor.

#### **D** Measurement

The department will measure SW Region Salt Shed and Jefferson County Salt Shed as a single lump sum unit of work, acceptably completed.

## E Payment

The department will pay for measured quantities at the contract unit price under the following bid item:

## ADDITIONAL SPECIAL PROVISION 4

## **Payment to First-Tier Subcontractors**

Within 10 calendar days of receiving a progress payment for work completed by a subcontractor, pay the subcontractor for that work. The prime contractor may withhold payment to a subcontractor if, within 10 calendar days of receipt of that progress payment, the prime contractor provides written notification to the subcontractor and the department documenting "just cause" for withholding payment.

The prime contractor may also withhold routine retainage from payments due subcontractors.

## **Payment to Lower-Tier Subcontractors**

Ensure that subcontracting agreements at all tiers provide prompt payment rights to lower-tier subcontractors that parallel those granted first-tier subcontractors in this provision.

## **Release of Routine Retainage**

After granting substantial completion the department may reduce the routine retainage withheld from the prime contractor to 75 percent of the original total amount retained.

When the Department sends the semi-final estimate the department may reduce the routine retainage withheld from the prime contractor to 10 percent of the original total amount retained.

Within 30 calendar days of receiving the semi-final estimate from the department, submit written certification that subcontractors at all tiers are paid in full for acceptably completed work and that no routine retainage is being withheld. The department will pay the prime contractor in full and reduce the routine retainage withheld from the prime contractor to zero when the department approves the final estimate.

This special provision does not limit the right of the department, prime contractor, or subcontractors at any tier to withhold payment for work not acceptably completed or work subject to an unresolved contract dispute.

## **ADDITIONAL SPECIAL PROVISION 6**

## ASP 6 - Modifications to the standard specifications

Make the following revisions to the 2014 edition of the standard specifications:

#### 101.3 Definitions

Replace the definition of semi-final estimate with the following effective with the December 2013 letting:

**Semi-final estimate** An estimate indicating the engineer has measured and reported all contract quantities and materials requirements.

## 105.11.1 Partial Acceptance

Replace paragraph two with the following effective with the December 2013 letting:

(2) Partial acceptance will relieve the contractor of maintenance responsibility for the designated portion of the work. By relieving the contractor of maintenance, the department does not relieve the contractor of responsibility for defective work or damages caused by the contractor's operations. Do not construe partial acceptance to be conditional final acceptance or final acceptance of any part of the project, or a waiver of any legal rights specified under 107.16.

## 105.11.2 Final Acceptance

Retitle and replace the entire text with the following effective with the December 2013 letting:

## 105.11.2 Project Acceptance

105.11.2.1 Inspection

#### 105.11.2.1.1 General

- (1) Notify the engineer when the project is substantially complete as defined in 105.11.2.1.3. As soon as it is practical, the engineer will inspect the work and categorize it as one of the following:
  - 1. Unacceptable or not complete.
  - 2. Substantially complete.
  - 3. Complete.

## 105.11.2.1.2 Unacceptable or Not Complete

- (1) The engineer will identify, in writing, work that is unacceptable or not complete. Immediately correct or complete that work. The engineer will assess contract time until the work is corrected or completed.
- (2) Proceed as specified in 105.11.2.1.1 until the engineer determines that the work is complete.

## 105.11.2.1.3 Substantially Complete

- (1) The project is substantially complete and the engineer will no longer assess contract time if the contractor has completed all contract bid items and change order work, except for the punch-list. As applicable, the following must have occurred:
  - 1. All lanes of traffic are open on a finished surface.
  - 2. All signage and traffic control devices are in place and operating.
  - 3. All drainage, erosion control, excavation, and embankments are completed.
  - 4. All safety appurtenances are completed.
- (2) The engineer will provide a written punch-list enumerating work the contractor must perform and documents the contractor must submit before the the engineer will categorize the work as complete.
  - 1. Punch-list work includes uncompleted cleanup work required under 104.9 and minor corrective work. Immediately correct or complete the punch-list work. The engineer may restart contract time if the contractor does not complete the punch-list work within 5 business days after receiving the written punch-list. The engineer and contractor may mutually agree to extend this 5-day requirement.
  - Punch-list documents include whatever contract required documentation is missing. The engineer may restart contract time if the contractor does not submit the punch-list documents within 15 business days after receiving the written punch-list. The engineer and contractor may mutually agree to extend this 15day requirement.
- (3) Proceed as specified in 105.11.2.1.1 until the work is complete.

## 105.11.2.1.4 Complete

(1) The project is complete when the contractor has completed all contract bid items, change order work, and punch-list work including the submission of all missing documentation.

## 105.11.2.2 Conditional Final Acceptance

(1) When the engineer determines that the project is complete, the engineer will give the contractor written notice of conditional final acceptance relieving the contractor of maintenance responsibility for the completed work.

## 105.11.2.3 Final Acceptance

- (1) The engineer will grant final acceptance of the project after determining that all contract is work complete; all contract, materials, and payroll records are reviewed and approved; and the semi-final estimate quantities are final under 109.7.
- (2) Failure to discover defective work or materials before final acceptance does not prevent the department from rejecting that work or those materials later. The department may revoke final acceptance if the department discovers defective work or materials after it has accepted the work.

#### 105.13.3 Submission of Claim

Replace paragraph one with the following effective with the December 2013 letting:

(1) Submit the claim to the project engineer as promptly as possible following the submission of the Notice of Claim, but not later than final acceptance of the project as specified in 105.11.2.3. If the contractor does not submit the claim before final acceptance of the project, the department will deny the claim.

## 107.17.3 Railroad Insurance Requirements

Replace paragraph one with the following effective with the December 2013 letting:

(1) If required by the special provisions, provide or arrange for a subcontractor to provide railroad protective liability insurance in addition to the types and limits of insurance required in 107.26. Keep railroad protective liability insurance coverage in force until completing all work, under or incidental to the contract, on the railroad right of way or premises of the railroad and until the engineer determines that the work is complete as specified in 105.11.2.1.4.

#### 107.26 Standard Insurance Requirements

Replace paragraph one with the following effective with the December 2013 letting:

(1) Maintain the following types and limits of commercial insurance in force until the engineer determines that the work is complete as specified in 105.11.2.1.4.

## 109.2 Scope of Payment

Replace paragraph two with the following effective with the December 2013 letting:

- (2) The department will pay for the quantity of work acceptably completed and measured for payment as the measurement subsection for each bid item specifies. Within the contract provide means to furnish and install the work complete and in-place. Payment is full compensation for everything required to perform the work under the applicable bid items including, but not limited to, the work elements listed in the payment subsection. Payment also includes all of the following not specifically excluded in that payment subsection:
  - 1. Furnishing and installing all materials as well as furnishing the labor, tools, supplies, equipment, and incidentals necessary to perform the work.
  - 2. All losses or damages, except as specified in 107.14, arising from one or more of the following:
    - The nature of the work.
    - The action of the elements.
    - Unforeseen difficulties encountered during prosecution of the work.
  - 3. All insurance costs, expenses, and risks connected with the prosecution of the work.
  - 4. All expenses incurred because of an engineer-ordered suspension, except as specified in 104.2.2.3.
  - 5. All infringements of patents, trademarks, or copyrights.
  - 6. All other expenses incurred to complete and protect the work under the contract.

## 109.6.1 General

Replace paragraphs three and four with the following effective with the December 2013 letting:

- (3) The department's payment of an estimate before conditional final acceptance of the work does not constitute the department's acceptance of the work, and does not relieve the contractor of responsibility for:
  - 1. Protecting, repairing, correcting, or renewing the work.
  - 2. Replacing all defects in the construction or in the materials used in the construction of the work under the contract, or responsibility for damage attributable to these defects.
- (4) The contractor is responsible for all defects or damage that the engineer may discover on or before the engineer's conditional final acceptance of the work. The engineer is the sole judge of these defects or damage, and the contractor is liable to the department for not correcting all defects or damage.

## 109.7 Acceptance and Final Payment

Replace paragraphs one and two with the following effective with the December 2013 letting:

- (1) After the engineer grants conditional final acceptance of the work as specified in 105.11.2.2 and reviews required document submittals and materials test reports, the engineer will issue the semi-final estimate.
- (2) Within 30 calendar days after receiving the semi-final estimate, submit to the engineer a written statement of agreement or disagreement with the semi-final estimate. For an acceptable statement of disagreement, submit an item-by-item list with reasons for each disagreement. If the contractor does not submit this written statement within those 30 days, the engineer will process the final estimate for payment. The engineer and the contractor can mutually agree to extend this 30-day submission requirement.

## 450.3.3 Maintaining the Work

Replace paragraph one with the following effective with the December 2013 letting:

(1) Protect and repair the prepared foundation, tack coat, base, paved traffic lanes, shoulders, and seal coat. Correct all rich or bleeding areas, breaks, raveled spots, or other nonconforming areas in the paved surface.

#### 455.3.2.5 Maintaining Tack Coat

Replace paragraph one with the following effective with the December 2013 letting:

(1) Protect and repair the existing surface and the tack coat. Correct areas with excess or deficient tack material and any breaks, raveled spots, or other areas where bond might be affected.

## 460.2.2.3 Aggregate Gradation Master Range

Replace paragraph one with the following effective with the January 2014 letting:

(1) Ensure that the aggregate blend, including recycled material and mineral filler, conforms to the gradation requirements in table 460-1. The values listed are design limits; production values may exceed those limits.

  - Maintenance procedures manuals: for contractor furnished equipment, submit a manual containing detailed preventive and corrective maintenance procedures for each type or model of equipment furnished.
  - Cabinet fiber optic wiring diagram: submit a cabinet wiring diagram, identified by location for each
    cabinet. Include both electrical wiring and fiber optic conductor and cable connections. Place one copy
    of the fiber optic wiring diagram in a weatherproof holder in the cabinet. Deliver the other copies to the
    engineer.
  - As-built drawings: submit final as-built drawings that detail the final placement of all conduit, cabling, equipment, and geometric modifications within the contract. Provide all documentation in an electronic format adhering to the region's ITS computer aided drafting standards and according to the department's as-built requirements. The department will review the as-built drawings for content and electronic format. Modify both the content and format of as-built drawings until meeting all requirements.

  - 2. Report payments to all DBE firms within 10 calendar days of receipt of a progress payment by the department or a contractor for work performed, materials furnished, or materials stockpiled by a DBE firm. Report the payment as specified in A(1) for all work satisfactorily performed and for all materials furnished or stockpiled.
  - 3. Report payments to all first tier subcontractor relationships within 10 calendar days of receipt of a progress payment by the department for work performed. Report the payment as specified in A(1) for all work satisfactorily performed.
  - 4. All tiers shall report payments as necessary to comply with the DBE payment requirement as specified in A(2).
  - 5. Require all first tier relationships, DBE firms and all other tier relationships necessary to comply with the DBE payment requirement in receipt of a progress payment by contractor to acknowledge receipt of payment as specified in A(1), (2), (3) and (4).
  - 6. All agreements made by a contractor shall include the provisions in A(1), (2), (3), (4) and (5), and shall be binding on all first tier subcontractor relationships and all contractors and subcontractors utilizing DBE firms on the project.
- B. Costs for conforming to this special provision are incidental to the contract.

# **ADDITIONAL SPECIAL PROVISION 9 Electronic Certified Payroll Submittal**

- (1) Use the department's Civil Rights Compliance System (CRCS) to submit certified payrolls electronically. - (2) Ensure that all tiers of subcontractors, as well as all trucking firms, submit their weekly certified payrolls electronically through CRCS. These payrolls are due within seven calendar days following the close of the payroll period. Every firm providing physical labor towards completing the project is a subcontractor under this special provision.
- (3) Upon receipt of contract execution, promptly make all affected firms aware of the requirements under this special provision and arrange for them to receive CRCS training as they are about to begin payrolls. The department will provide training either in a classroom setting at one of our regional offices or by telephone. Contact Tess Mulrooney at 608-267-4489 to schedule the training.
- (4) The department will reject all paper submittals of forms DT-1816 and DT-1929 for information required under this special provision. All costs for conforming to this special provision are incidental to the contract.
- (5) Firms wishing to export payroll data from their computer system into CRCS should have their payroll coordinator send several sample electronic files to Tess two months before a payroll needs to be submitted. Not every contractor's payroll system is capable of producing export files. Coating includes epoxy coating, galvanizing, painting and any other coating that protects or enhances the value of a material subject to the requirements of Buy America. The exemption of this requirement is the minimal use of foreign materials if the total cost of such material permanently incorporated in the product does not exceed one-tenth of one percent (1/10 of 1%) of the total contract cost or \$2,500.00, whichever is greater. For purposes of this paragraph, the cost is that shown to be the value of the subject products as they are delivered to the project. The contractor shall take actions and provide documentation conforming to CMM 2-28.5 to ensure compliance with this "Buy America" provision.

## I. WAGE RATES, HOURS OF LABOR AND PAYMENT OF WAGES

The schedule of "Minimum Wage Rates" attached hereto and made a part hereof furnishes the prevailing wage rates that have been determined pursuant to Section 103.50 of the Wisconsin Statutes. These wage rates are the minimum required to be paid to the various laborers, workers, mechanics and truck drivers employed by contractors and subcontractors on the construction work embraced by the contract and subject to prevailing hours and wages under Section 103.50, Stats. If necessary to employ laborers, workers, mechanics or truck drivers whose classification is not listed on the schedule, they shall be paid at rates conformable to those listed for similar classifications. Apprentices shall be paid at rates not less than those prescribed in their state indenture contacts.

While the wage rates shown are the minimum rates required by the contract to be paid during its life, this in not a representation that labor can be obtained at these rates. It is the responsibility of bidders to inform themselves as to the local labor conditions and prospective changes or adjustments of wage rates. No increase in the contract price shall be allowed or authorized on account of the payment of wage rates in excess of those listed herein.

Pursuant to Section 103.50 of the Wisconsin Statutes, the prevailing hours of labor have been determined to be up to 10 hours per day and 40 hours per calendar week Monday through Friday. If any laborer, worker, mechanic or truck driver is permitted or required to work more than the prevailing number of hours per day or per calendar week on this contract, they shall be paid for all hours in excess of the prevailing hours at a rate of at least one and one-half (1 1/2) times their hourly rate of pay. All work on Saturday, Sunday and the following holidays is to be paid at time and a half: (1) January 1, (2) the last Monday in May, (3) July 4, (4) the first Monday in September, (5) the fourth Thursday in November, (6) December 25, (7) the day before if January 1, July 4 or December 25 falls on a Saturday and (8) the day following if January 1, July 4 or December 25 falls on a Sunday.

All laborers, workers, mechanics and truck drivers shall be paid unconditionally not less often than once a week. Persons who own and operate their own trucks must receive the prevailing truck driver rate for the applicable type of truck (i.e. 2 axle, 3 or more axle, articulated, eculid or dumptor) he or she operates, plus an agreed upon amount for the use of his or her truck. Every owner-operator MUST be paid separately for their driving and for the use of their truck.

For those projects subject to the requirements of the Davis-Bacon Act, the Secretary of Labor will also have determined "Minimum Wage Rates" for work to be performed under the contract. These rates are, for all or most of the labor, worker, mechanic or truck driver classifications, identical to those established under Section 103.50 of the Wisconsin Statutes. In the event the rates are not identical, the higher of the two rates will govern.

## II. PAYROLL REQUIREMENTS

All contractors and subcontractors must submit weekly Certified Payrolls and Compliance Statement verifying that all laborers, workers, mechanics and truck drivers working on the project have been paid the prevailing wage rates for all work performed under the contract required by Section 103.50 of the Wisconsin Statutes.

## III. POSTINGS AT THE SITE OF THE WORK

In addition to the required postings furnished by the Department, the contractor shall post the following in at least one conspicuous place at the site of work:

- a. "NOTICE TO EMPLOYEES," which provides information required to be posted by the provisions of Section 103.50 of the Wisconsin Statutes.
- b. A copy of the State of Wisconsin Minimum Wages Rates. (Four pages.)
- c. A copy of the contractor's Equal Employment Opportunity Policy.
- d. On any project involving federal aid, in addition to the furnished postings, the contractor shall post a copy of the "Davis-Bacon Act, Minimum Wage Rates". (Three pages.)

## IV. WAGE RATE REDISTRIBUTION

The amount specified as the hourly basic rate of pay and the amount(s) specified as the fringe benefit contribution(s), for all classes of laborers, workers, mechanics or truck drivers may be redistributed, when necessary, to conform to those specified in any applicable collective bargaining agreement, provided that both parties to such agreement

request and receive the approval for any such redistribution from both the Department of Transportation and the Department of Workforce Development prior to the implementation of such redistribution.

## V. ADDITIONAL CLASSIFICATIONS

Any unlisted laborer or mechanic classification that is needed to perform work on this project, and is not included within the scope of any of the classifications listed in the application prevailing wage rate determination, may be added after award only if all of the following criteria have been met:

- 1. The affected employer(s) must make a written request to WisDOT Central Office to utilize the unlisted classification on this project.
- 2. The request must indicate the scope of the work to be performed by the unlisted classification and must indicate the proposed wage/fringe benefit package that the unlisted classification is to receive.
- 3. The work to be performed by the unlisted classification must not be performed by a classification that is included in the applicable prevailing wage rate determination.
- 4. The unlisted classification must be commonly employed in the area where the project is located.
- 5. The proposed wage/fringe benefit package must bear a reasonable relationship to those set forth in the applicable prevailing wage rate determination.
- 6. The request should be made prior to the actual performance of the work by the unlisted classification.
- 7. DWD must approve the use of the unlisted classification and the proposed wage/fringe benefit package. USDOL also must approve the use of the unlisted classification and the proposed wage/fringe benefit package on federal aid projects.
- 8. WisDOT and DWD may amend the proposed wage/fringe benefit package, as deemed necessary, and may set forth specific employment ratios and scope of work requirements in the approval document.

The approved wage/fringe benefit package shall be paid to all laborers, workers, mechanics or truck drivers performing work within the scope of that performed by the unlisted classification, from the first day on which such work is performed. In the event that work is performed by the unlisted classification prior to approval, the wage/fringe benefit package to be paid for such work must be in conformance with the wage/fringe

benefit package approved for such work. Under this arrangement a retroactive adjustment in wages and/or fringe benefits may be required to be made to the affected laborers, workers, mechanics or truck drivers by the affected employer(s).

  - 1. January 1.
  - 2. The last Monday in May.
  - 3. July 4.
  - 4. The first Monday in September.
  - 5. The 4th Thursday in November.
  - 6. December 25.
  - 7. The day before if January 1, July 4 or December 25 falls on a Saturday.
  - 8. The day following if January 1, July 4 or December 25 falls on a Sunday.

## s. 66.0903 (10) RECORDS; INSPECTION; ENFORCEMENT.

(a) Each contractor, subcontractor, or contractor's or subcontractor's agent performing work on a project of public works that is subject to this section shall keep full and accurate records clearly indicating the name and trade or occupation of every person performing the work described in sub. (4) and an accurate record of the number of hours worked by each of those persons and the actual wages paid for the hours worked.

## s. 66.0903 (11) LIABILITY AND PENALTIES.

- (a) 1. Any contractor, subcontractor, or contractor's or subcontractor's agent who fails to pay the prevailing wage rate determined by the department under sub. (3) or who pays less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor is liable to any affected employee in the amount of his or her unpaid wages or his or her unpaid overtime compensation and in an additional amount as liquidated damages as provided under subd. 2., 3., whichever is applicable.
- 2. If the department determines upon inspection under sub. (10) (b) or (c) that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the department shall order the contractor to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages within a period specified by the department in the order.
- 3. In addition to or in lieu of recovering the liability specified in subd. 1. as provided in subd. 2., any employee for and in behalf of that employee and other employees similarly situated may commence an action to recover that liability in any court of competent jurisdiction. If the court finds that a contractor, subcontractor, or contractor's or subcontractor's agent has failed to pay the prevailing wage rate determined by the department under sub. (3) or has paid less than 1.5 times the hourly basic rate of pay for all hours worked in excess of the prevailing hours of labor, the court shall order the contractor, subcontractor, or agent to pay to any affected employee the amount of his or her unpaid wages or his or her unpaid overtime compensation and an additional amount equal to 100 percent of the amount of those unpaid wages or that unpaid overtime compensation as liquidated damages. 5. No employee may be a party plaintiff to an action under subd. 3. unless the employee consents in writing to become a party and the consent is filed in the court in which the action is brought. Notwithstanding s. 814.04 (1), the court shall, in addition to any judgment awarded to the plaintiff, allow reasonable attorney fees and costs to be paid by the defendant.

## **BUILDING OR HEAVY CONSTRUCTION**

Includes sheltered enclosures with walk-in access for the purpose of housing persons, employees, machinery, equipment or supplies and non-sheltered work such as canals, dams, dikes, reservoirs, storage tanks, etc. A sheltered enclosure need not be "habitable" in order to be considered a building. The installation of machinery and/or equipment, both above and below grade level, does not change a project's character as a building. On-site grading, utility work and landscaping are included within this definition. Residential buildings of four (4) stories or less, agricultural buildings, parking lots and driveways are NOT included within this definition.

#### **SKILLED TRADES**

Employers performing work on public works and publicly funded private construction projects in Wisconsin are required to have a written substance abuse testing program in place. The provisions of this requirement are contained in Sec. 103.503, Wis. Stats. The Department of Workforce Development is neither responsible for enforcement of this law nor authorized to answer questions concerning its provisions. For legal advice on complying with Sec. 103.503, Wis. Stats., you may wish to consult with a private attorney.

103.503 Substance abuse prevention on public works and publicly funded projects. (1) DEFINITIONS. In this section:

- (a) "Accident" means an incident caused, contributed to, or otherwise involving an employee that resulted or could have resulted in death, personal injury, or property damage and that occurred while the employee was performing the work described in s. 66.0903 (4), 66.0904 (3), or 103.49 (2m) on a project.
  - (b) "Alcohol" has the meaning given in s. 340.01 (1q).
- (c) "Contracting agency" means a local governmental unit, as defined in s. 66.0903 (1) (d), a state agency, as defined in s. 103.49 (1) (f), or an owner or developer under s. 66.0904 that has contracted for the performance of work on a project.
- (d) "Drug" means any controlled substance, as defined in s. 961.01 (4), or controlled substance analog, as defined in s. 961.01 (4m), for which testing is required by an employer under its substance abuse prevention program under this section.
- (e) "Employee" means a laborer, worker, mechanic, or truck driver who performs the work described in s. 66.0903 (4), 66.0904 (3), or 103.49 (2m) on a project.
- (f) "Employer" means a contractor, subcontractor, or agent of a contractor or subcontractor that performs work on a project.
- (g) "Project" mean a project of public works that is subject to s. 66.0903 or 103.49 or a publicly funded private construction project that is subject to s. 66.0904.
- (2) SUBSTANCE ABUSE PROHIBITED. No cimployee may use, possess, attempt to possess, distribute, deliver, or be under the influence of a drug, or use or be under the influence of alcohol, while performing the work described in s. 66.0903 (4), 66.0904 (3), or 103.49 (2m) on a project. An employee is considered to be under the influence of alcohol for purposes of this subsection if he or she has an alcohol concentration that is equal to or greater than the amount specified in s. 885.235 (1g) (d).
- (3) SUBSTANCE ABUSE PREVENTION PROGRAMS REQUIRED. (a) Before an employer may commence work on a project, the employer shall have in place a written program for the prevention of substance abuse among its employees. At a minimum, the program shall include all of the following:
- 1. A prohibition against the actions or conditions specified in sub. (2).
- 2. A requirement that employees performing the work described in s. 66.0903 (4), 66.0904 (3), or 103.49 (2m) on a project submit to random, reasonable suspicion, and post-accident drug and alcohol testing and to drug and alcohol testing before commencing work on a project, except that testing of an employee before commencing work on a project is not required if the employee has been participating in a random testing program during the 90 days preceding the date on which the employee commenced work on the project.

- 3. A procedure for notifying an employee who violates sub. (2), who tests positive for the presence of a drug in his or her system, or who refuses to submit to drug or alcohol testing as required under the program that the employee may not perform work on a project until he or she meets the conditions specified in sub. (4) (b) 1. and 2.
- (b) Each employer shall be responsible for the cost of developing, implementing, and enforcing its substance abuse prevention program, including the cost of drug and alcohol testing of its employees under the program. The contracting agency is not responsible for that cost, for the cost of any medical review of a test result, or for any rehabilitation provided to an employee.
- (4) EMPLOYEE ACCESS TO PROJECT. (a) No employer may permit an employee who violates sub. (2), who tests positive for the presence of a drug in his or her system, or who refuses to submit to drug or alcohol testing as required under the employer's substance abuse prevention program under sub. (3) to perform work on a project until he or she meets the conditions specified in par. (b) 1. and 2. An employer shall immediately remove an employee from work on a project if any of the following occurs:
- 1. The employee violates sub. (2), tests positive for the presence of a drug in his or her system, or refuses to submit to drug or alcohol testing as required under the employer's substance abuse prevention program.
- 2. An officer or employee of the contracting agency has a reasonable suspicion that the employee is in violation of sub. (2) and requests the employer to immediately remove the employee from work on the project.
- (b) An employee who is barred or removed from work on a project under par. (a) may commence or return to work on the project upon his or her employer providing to the contracting agency documentation showing all of the following:
- 1. That the employee has tested negative for the presence of drugs in his or her system and is not under the influence of alcohol as described in sub. (2).
- 2. That the employee has been approved to commence or return to work on the project in accordance with the employer's substance abuse prevention program.
- (c) Testing for the presence of drugs or alcohol in an employee's system and the handling of test specimens shall be conducted in accordance with guidelines for laboratory testing procedures and chain—of—custody procedures established by the substance abuse and mental health services administration of the federal department of health and human services.
- (5) LOCAL ORDINANCES; STRICT CONFORMITY REQUIRED. A local governmental unit, as defined in s. 66.0903 (1) (d), may enact an ordinance regulating the conduct regulated under this section only if the ordinance strictly conforms to this section.

# **PREVAILING WAGE - Public Entity Project Owners**

Any public works project that has a total estimated project cost that equals or exceeds single-trade or multiple-trade project thresholds requires a prevailing wage rate determination issued by the Department of Workforce Development (DWD). Public works include erecting, constructing, remodeling, repairing, demolishing, alterations, painting and decorating projects for a local governmental unit or state agency. State law excludes minor service or maintenance work, warranty work, or work under a supply-and-installation contract. There is a statutory definition for each of these exclusions. The prevailing wage law that applies to local governmental units is §66.0903, Wis. Stats. The prevailing wage law that applies to state agencies is §103.49, Wis. Stats. The applicable administrative rules for all public entities are DWD 290 and DWD 294, Wis. Adm. Code.

### Thresholds

- A "single-trade project of public works" means a project in which a single trade accounts for 85% or more of the total labor cost of the project. The single trade threshold is \$48,000.
- A "multiple-trade project of public works" means a project in which no single trade accounts for 85% or more of the total labor cost of the project.
- (a) The multiple-trade threshold is \$100,000, unless a municipality falls under the description in (b).
  - (b) The multiple-trade threshold of \$234,000 applies to public works projects erected, constructed, repaired, remodeled, or demolished by a private contractor for ●a city or village with a population less than 2500 or ●a town.

Effective July 1, 2011, a local governmental unit or state agency that has a public works project that equals or exceeds the prevailing wage thresholds must do all of the following:

 Request a prevailing wage rate determination for the project from DWD at least 30 days before soliciting bids or negotiating contracts. An Application for Prevailing Wage Rate Determination is available on the DWD website: http://dwd.wisconsin.gov/er/prevailing wage rate/default.htm

To avoid waiting for a project determination use the on-line application system that permits the user to generate a determination immediately and save all documents in PDF form to the user's computer. Use this project determination on line application at the following address:

- Tell potential contractors the project is subject to state prevailing wage law when soliciting bids.
- Include the prevailing wage rate determination in the construction contract, or if there is no written contract, provide a copy of the project determination to each prime contractor.
- Award contracts to contractors who do not appear on the "Consolidated List of Debarred Contractors."
- Post the prevailing wage rate determination on the project site. (This document is often referred to as "the white sheet.")
- Notify project contractors that if DWD finds that a contractor violated the prevailing wage law, DWD will assess liquidated damages of 100% of the wages owed to employees.
- Obtain an Affidavit of Compliance from each prime contractor before making final payment for the project.

If the total estimated cost of the project exceeds the prevailing wage thresholds, a local governmental unit or state agency also must obtain a prevailing wage rate determination under the following circumstances:

- when a completed facility is leased, purchased, lease-purchased or otherwise acquired by or dedicated to a public entity in lieu of the public entity contracting for the project,
- when one public entity does work for another public entity,
- when a *private* entity will construct a road, street, bridge, sanitary sewer or water main project and dedicate it to a local governmental unit or the state for its ownership or maintenance (except for some residential subdivisions).

### **PREVAILING WAGE – Contractors**

Any public works project that has a total estimated project cost that equals or exceeds prevailing wage project thresholds requires a prevailing wage rate determination issued by the Department of Workforce Development (DWD). Public works include erecting, constructing, remodeling, repairing, demolishing, alterations, painting and decorating projects for a local governmental unit or state agency. State law excludes minor service or maintenance work, warranty work, or work under a supply-and-installation contract. There is a statutory definition for each of these exclusions. The prevailing wage law that applies to local governmental units and their contractors is §66.0903, Wis. Stats. The prevailing wage law that applies to state agencies and their contractors is §103.49, Wis. Stats. The applicable administrative rules for all prevailing wage projects are DWD 290 and DWD 294, Wis. Adm. Code. These laws include provisions that apply to all contractors and subcontractors working on prevailing wage projects.

Effective July 1, 2011, any contractor or subcontractor working on a local governmental unit or state agency's public works project that equals or exceeds current prevailing wage project thresholds must do all of the following:

- Receive and review the project's prevailing wage rate determination (i.e., white sheet).
- Tell subcontractors the project is subject to state prevailing wage law and include the prevailing wage rate determination in the construction contract, or if there is no written contract, provide a copy of the project determination to each subcontractor.
- Hire subcontractors who do *not* appear on the "Consolidated List of Debarred Contractors."
- Notify subcontractors that if DWD finds that a contractor or subcontractor violated the prevailing wage law, DWD will assess liquidated damages of 100% of the wages owed to employees.

- Apply to DWD for subjourney wage rates prior to employing these individuals on the project.
- Receive and retain a completed Affidavit of Compliance from each subcontractor brought on to the project before providing final payment to those subcontractors.
- Submit a completed Affidavit of Compliance to the contractor who brought the subcontractor on to the project before receiving final payment for the project.
- Maintain payroll records for 3 years that comply with §§66.0903(10)(a) or 103.49(5)(a), Stats. and DWD 274.06.
- Respond to requests from DWD or the project owner to provide payroll records and/or respond to prevailing wage complaints filed by employees or third parties.

The 2009-2011 State budget bill (2009 Wisconsin Act 28) created a new prevailing wage law (§66.0904, Wis. Stats.) for PUBLICLY FUNDED PRIVATE CONSTRUCTION PROJECTS effective January 1, 2010. The current 2011-2013 State budget bill (2011 Wisconsin Act 32) REPEALS this law. So the publicly funded private construction projects law only applies to projects that awarded the prime contract during the period January 1, 2010 through June 30, 2011.

# SINGLE & MULTIPLE TRADE PROJECT THRESHOLDS FOR §§66.0903 & 103.49, Wis. Stats. Effective July 1, 2011

The \$25,000 threshold for public works projects has been changed to single-trade and multiple-trade project thresholds as described below. Projects of public works with total estimated costs of completion that equal or exceed these thresholds require a prevailing wage rate determination.

## SINGLE-TRADE THRESHOLD

A "single-trade project of public works" means a project in which a single trade accounts for 85 percent or more of the total labor cost of the project.

The single trade threshold is \$48,000.

# **MULTIPLE-TRADE THRESHOLDS**

A "multiple-trade project of public works" means a project in which no single trade accounts for 85 percent or more of the total labor cost of the project.

- (a) The multiple-trade threshold is \$100,000, unless a municipality falls under the description in (b).
- (b) The multiple-trade threshold of \$234,000 applies to public works projects erected, constructed, repaired, remodeled, or demolished by a private contractor for:
  - a city or village with a population less than 2500, or
  - a town

# **APPLYING THE NEW THRESHOLDS**

The department will apply the new single-trade & multiple-trade prevailing wage thresholds to projects of public works for which the prime contract is awarded on or after July 1, 2011.
