#### SPECIAL PROVISIONS

#### 1. General.

Perform the work under this construction contract for Project 1009-11-72, Black River Falls – Tomah, CTH ET B-41-0042, IH 94, Monroe County, Wisconsin as the plans show and execute the work as specified in the State of Wisconsin, Department of Transportation, Standard Specifications for Highway and Structure Construction, 2016 Edition, as published by the department, and these special provisions.

If all or a portion of the plans and special provisions are developed in the SI metric system and the schedule of prices is developed in the US standard measure system, the department will pay for the work as bid in the US standard system. 100-005 (20151210)

## 2. Scope of Work.

The work under this contract shall consist of repairing Structure B-41-42 and all incidental items necessary to complete the work as shown on the plans and included in the proposal and contract.

## 3. Prosecution and Progress.

Begin work within ten calendar days after the engineer issues a written notice to do so.

Provide the time frame for construction of the project within the 2016 construction season to the engineer in writing within a month after executing the contract but at least 14 calendar days before the preconstruction conference. Assure that the time frame is consistent with the contract completion time. Upon approval, the engineer will issue the notice to proceed within ten calendar days before the beginning of the approved time frame.

To revise the time frame, submit a written request to the engineer at least two weeks before the beginning of the intended time frame. The engineer will approve or deny that request based on the conditions cited in the request and its effect on the department's scheduled resources.

#### 4. Traffic.

Eastbound IH 94 traffic may only be detoured using the details in the plans for two nights. One night to remove Structure B-41-42 and one night to place the new steel girder sections on Structure B-41-42. All other work shall be performed using single lane closures.

Single lane closures on the eastbound lanes of IH 94 are permitted during the following times:

8:00 PM Sunday to 9:00 AM Monday 6:00 PM Monday, Tuesday, Wednesday to 10:00 AM the following day 7:00 PM Thursday to 9:00 AM Friday.

If the contractor fails to complete the work necessary to reopen the lanes of eastbound IH 94 by the designated times listed above damages will be assessed according to the Lane Rental Fee Assessment article.

Both eastbound lanes of IH 94 are permitted to be closed to traffic for the removal of Structure B-41-42 and for the setting of the steel girders. The closures are permitted during the following times:

11:00 PM Sunday, Monday, Tuesday, Wednesday, Thursday to 5:00 AM the following day

If the contractor fails to complete the work necessary to reopen the lanes of eastbound IH 94 by the designated times listed above damages will be assessed according to the Lane Rental Fee Assessment article.

Notify the engineer if there are any changes in the schedule, early completions, or cancellations of scheduled work. Failure to provide advance notification may result in non-compensable delays to the contractor. No time extensions will be granted for these delays.

Coordinate all arrangements for handling traffic with the engineer before work is started on a new stage of construction that will change the traffic pattern existing at the time. Ensure that all traffic control devices are in place and approved by the engineer before beginning each stage.

Maintain two lanes of IH 94 traffic in each direction at all times unless within a permitted lane closure period as defined in these special provisions.

Keep all entrance and exit ramps open to traffic at all times unless within a permitted closure period as defined in these special provisions.

Conduct construction and hauling operations in such a manner that minimizes the duration and intensity of interference to the free flow of vehicles on IH 94. This includes the following:

- Do not park or store any equipment, vehicles, or construction material within the right-of-way of IH 94 traveled roadways.
- No vehicle or piece of equipment will be permitted to directly cross live traffic lanes.
- Equip all vehicles and machines used to transport materials or supplies to the work site which are operated on the traveled roadway, with hazard identification beam (flashing yellow signal) 5-1/2 inch minimum diameter. The beam shall be visible from 360 degrees and shall be in operation when the vehicle is within the roadway or shoulder area.
- Have available at all times, sufficient experienced personnel to promptly install, remove, and reinstall the required traffic control devices to route traffic in accordance to the plans, these special provisions, and as directed by the engineer.
- Do not use existing median crossovers for storage of equipment or materials.
- Do not use any maintenance crossovers or any other median crossovers unless a left lane closure is in place for entry and exit. Violators will be restricted from working on the project for the remainder of the contract time and any material they are hauling will not be paid.
- Interstate access control shall remain intact during construction.
- Immediately clean up all debris falling onto the roadway.

Access to and from the roadway shall be at the existing interchange ramps.

Construction vehicles shall move with traffic, shall be able to accelerate with IH 94 traffic prior to merging with it and must exit the work zone at the end of the lane closure.

Do not disturb, remove, or obliterate any traffic control signs, advisory signs, shoulder delineators, or beam guard in place along the traveled roadways without the approval of the engineer.

Reinstall or replace any signs damaged during construction operations at the contractor's expense.

#### 5. Lane Rental Fee Assessment.

#### A General

The contract designates some lane closures to perform the work. The contractor will not incur a Lane Rental Fee Assessment for closing lanes during the permitted lane closure times. The contractor will incur a Lane Rental Fee Assessment for each lane closure outside of the permitted lane closure times. If a lane is obstructed at any time due to contractor operations, it is considered a closure. The purpose of lane rental is to enforce compliance of lane restrictions and discourage unnecessary closures.

The permitted lane closure times are shown in the Traffic article.

Submit the dates of the proposed lane, ramp, and roadway restrictions to the engineer as part of the progress schedule. Coordinate lane, ramp, and roadway closures with any concurrent operations on adjacent roadways within 3 miles of the project.

Prior to overcoating or power tool cleaning, solvent clean all surfaces to be coated according to SSPC-SP1. A SSPC-SP 11 power Tool Cleaning according to Steel Structures Painting Council Specification 11 will be required on all metal surfaces to be painted with a three-coat system. Prime the same day, or re-clean before application, all metal surfaces receiving a No. 11 cleaning.

Remove all abrasive or paint residue from steel surfaces with a High Efficiency Particulate Abatement (HEPA-VAC) vacuum cleaner equipped with a brush-type cleaning tool, or by double blowing. If the double blowing method is used, vacuum the exposed top surfaces of all structural steel, including flanges, longitudinal stiffeners, splices, plates, and hangers, after the double blowing operations are completed. The air line used for blowing the steel clean shall have an inline water trap and the air shall be free of oil and water as it leaves the air line.

Take care to protect freshly coated surfaces from subsequent cleaning operations. Thoroughly wire brush damaged primed surfaces with a non-rusting tool. Clean and reprime the brushed surfaces within the time recommended by the manufacturer.

#### C.2 Painting

Paint by applying two or three coats of an approved coating system as specified herein to the surfaces as described in A.1 from the department's approved products list.

#### **C.3** Coating Application

Apply paint in a neat, workmanlike manner. The resultant paint film shall be smooth and uniform without skips or areas of excessive paint. Apply coating according to the manufacturer's recommendations.

Prior to applying the prime coat, coat with primer all edges, rivet and bolt heads, nuts and washers by using either a brush, roller, or spray application.

Dry Film Thickness per coat shall be a minimum of 3-mil. The dry film thickness shall be determined by use of a magnetic film thickness gage. The gage shall be calibrated for dry film thickness measurement according to SSPC-PA 2.

# 11. Containment and Collection of Waste Materials B-41-0042, Item 517.4000.S.01.

### **A Description**

This special provision describes furnishing and erecting tarpaulins to contain, collect and store the spent material from surface preparation of steel surfaces, collecting such spent material, and labeling and storing the spent material in waste containers according to the contract and as hereinafter provided.

#### **B** Materials

Provide 5-gallon lidded plastic containers for containing the spent material.

#### **C** Construction

Erect tarpaulins or other materials to collect all of the spent material from power tool cleaning. Consider and treat all spent material as hazardous waste because it contains lead.

Collect and store all waste material collected by this operation at the bridge site for disposal. Collect and store all waste materials at the end of each workday or more often if needed. Store materials in 5-gallon lidded plastic containers.

Label each container with the date the first waste was placed in the container and the words "Hazardous Waste – EPA Waste Code D008." Lock and secure all containers at the end of each workday. Keep the containers covered at all times except to add or remove waste material. Store the containers in an accessible and secured area, not located in a storm water runoff course, flood plain or exposed to standing water.

Collect the spent debris by vacuuming, shoveling, sweeping, or by channeling it directly to disposal containers. The enclosure shall be thoroughly cleaned at the end of each work day.

#### **D** Measurement

The department will measure Containment and Collection of Waste Materials B-41-42, completed according to the contract and accepted, as a single complete unit of work for each structure designated in the contract.

## 12. Heat Straightening of Damaged Girders, Item SPV.0105.01.

#### **A Description**

This special provision describes heat straightening portions of bent or damaged girders back to their original shape. Straighten the girders back into their original position and shape within the tolerances listed in the AWS Bridge Welding Code D1.5.

#### B (Vacant)

#### **C** Construction

Fuel for heating shall be an oxygen-fuel combination. Heat application may be by either single or multiple orifice tips. Use a tip size that is proportional to the thickness of the heated material. Jacks, come-alongs or other force application devices may be either hydraulic or mechanical, but under no circumstance shall heating or jacking permanently yield or wrinkle the material. Do not exceed a temperature in the steel of 1200 degrees Fahrenheit during the heat straightening operation. Monitor the temperature with temperature sensitive crayons or an infrared non-contact thermometer. Heat the material in a single pass, following a specified pattern and allow it to cool below 250 degrees Fahrenheit prior to reheating. Place jacks so that the measured forces can be maintained or relieved as straightening occurs during cooling. Limit jacking so that the maximum bending moment in the heated zone is less than 50 percent of the plastic moment capacity of the member. Call to the attention of the engineer all suspected areas of cracking and inspect by one or more of the following methods as applicable: visual inspection, liquid penetrant examination, magnetic particle testing, or ultrasonic examination. Repair cracked areas at the direction of the engineer.

### 13. Counterweight Structure, Item SPV.0105.02.

#### **A Description**

This special provision describes furnishing, placing, and removing counterweights on the bridge structure in order to replace damaged sections of the structure according to the pertinent plan details, as directed by the engineer, and as hereinafter provided. The counterweights are required to prevent considerable stresses from accumulating in the field splice plates when a large portion of dead weight is removed from the structure and also to limit permanent redistribution of dead loads to other portions of the structure when a portion of the continuous-span steel superstructure is removed and replaced.

#### **B** Materials

Furnish stationary weights composed of steel plates or crane weights, concrete blocks, or other materials approved by the engineer. Provide elastomeric-rubber or tempered-hardboard-wood bearing pads or strips to level counterweights and provide a uniform contact stress on the existing concrete bridge surfaces. If required, provide a steel base/distribution plate between counterweights and pads of sufficient area, thickness, and strength to limit the contact stress on the existing concrete surfaces to 500 pounds per square inch (PSI) maximum.

#### **C** Construction

#### C.1 Placement

Locate individual counterweights at the locations shown in the plans. Weights may be placed by crane from below/off the existing bridge structure or trucked onto the structure and craned from it, provided all truck loads and cranes remain on the southern half of the structure, south of girder line 3. If existing structure is used to deliver/place counterweights, contractor shall independently verify the structure can safely support all loads and is not overstressed/damaged during placement given their specific placement procedure/s. Place counterweights, and portions thereof, according to the sequence specified in the plans. Avoid placing more than half of a counterweight at one girder prior to placing half of the adjacent girder's counterweight at the same span location.

#### C.2 Size and Weight

Each individual counterweight shall be contained within the maximum footprint indicated on the plans. Each counterweight shall be within (+/-) 500 pounds (LBS) of the design values indicated on the plans.

#### C.3 General

Secure counterweights to existing structure as required to safely stabilize their load and prevent their accidental displacement. Provide any necessary bracing, support framing, or scaffolding required to locate the counterweights at the locations shown in the plans. Utilize bearing pads and base/distribution plates as required to limit the contact stress on the existing concrete surfaces to 500 pounds per square inch and account for any surface irregularities in the existing concrete surfaces.

#### C.4 Removal

Remove counterweights at the point in the work sequence specified in the plan. Weights may be removed via a crane located off the structure or loaded and trucked via the existing structure, provided all truck loads and cranes remain on the southern half of the structure, south of girder line 3. If existing structure is used to remove the counterweights, the contractor shall independently verify the structure can safely support all loads and is not overstressed/damaged during their removal given their specific removal procedure/s. Avoid removing more than half of a counterweight at one girder prior to removing half of the adjacent girder's counterweight at the same span location.

#### **D** Measurement

The department will measure Counterweight Structure as a single lump sum unit of work for the structure, acceptably completed.

#### **E** Payment

The department will pay for measured quantities at the contract unit price under the following bid item:

Payment is full compensation for providing, placing, and removing all counterweights; and for transporting to and from the jobsite.

## 14. Magnetic Particle Testing and Grinding, Item SPV.0105.03.

#### A Description

Work under this item consists of magnetic particle testing (MT) and grinding out shallow cracks found by MT prior to preparation for painting of structural steel. The extent of the testing shall be as necessary for the engineer to comfortably believe that no crack exists or until the end of a crack has been found.

#### **B** (Vacant)

#### **C** Construction

#### C.1 Preparation of Retrofit Areas for Testing

Clean the areas to be tested/inspected of all paint, cutting fluid, oil, grease, and other contaminants that impede the inspection process.

#### **C.2** Independent Magnetic Particle Inspection

Use Magnetic Particle Testing (MT) performed by a certified Level II Technician according to SNT-TC-1A in the areas identified on the plans to locate cracks and related defects. Follow the procedures and techniques for dry powder magnetic particle examination using the yoke method, ASTM E709, Practices for Magnetic Particle Examination. Contract with an independent certified ASNT Level II Technician to complete MT and to provide a report of defect locations and details to the engineer.

#### C.3 Grinding

Grind welds and base metal as required to eliminate shallow cracks and blend the weld to the base metal with a smooth transition. Where grinding the transition into the base metal, fare/transition the surface to the minimum slope of 5 to 1 on the girder web and 10 to 1 on the girder flange. Grind no more than 1/8" into the web without the permission of the engineer.

#### **D** Measurement

The department will measure Magnetic Particle Testing and Grinding at the stiffener locations identified on the plan sheets as a lump sum unit of work, acceptably completed.

#### E Payment

The department will pay for measured quantities at the contract unit price under the following bid item.

Payment is full compensation for independent magnetic particle testing/inspection, for grinding cracks, for all preparation work required to accomplish the work under this specification (including removing paint), and for all incidentals related to work under this specification.

#### ADDITIONAL SPECIAL PROVISION 4

#### **Payment to First-Tier Subcontractors**

Within 10 calendar days of receiving a progress payment for work completed by a subcontractor, pay the subcontractor for that work. The prime contractor may withhold payment to a subcontractor if, within 10 calendar days of receipt of that progress payment, the prime contractor provides written notification to the subcontractor and the department documenting "just cause" for withholding payment.

The prime contractor may also withhold routine retainage from payments due subcontractors.

### **Payment to Lower-Tier Subcontractors**

Ensure that subcontracting agreements at all tiers provide prompt payment rights to lower-tier subcontractors that parallel those granted first-tier subcontractors in this provision.

#### **Release of Routine Retainage**

After granting substantial completion the department may reduce the routine retainage withheld from the prime contractor to 75 percent of the original total amount retained.

When the Department sends the semi-final estimate the department may reduce the routine retainage withheld from the prime contractor to 10 percent of the original total amount retained.

Within 30 calendar days of receiving the semi-final estimate from the department, submit written certification that subcontractors at all tiers are paid in full for acceptably completed work and that no routine retainage is being withheld. The department will pay the prime contractor in full and reduce the routine retainage withheld from the prime contractor to zero when the department approves the final estimate.

This special provision does not limit the right of the department, prime contractor, or subcontractors at any tier to withhold payment for work not acceptably completed or work subject to an unresolved contract dispute.

# ADDITIONAL SPECIAL PROVISION 6 ASP 6 - Modifications to the standard specifications

Make the following revisions to the standard specifications:

#### 550.5.2 Piling

Add the following as paragraph three effective with the December 2015 letting:

(3) The department will not entertain a change order request for a differing site condition under 104.2.2.2 or for a quantity change under 104.2.2.4.3 for the Piling bid items. Instead the department will adjust pay under the Piling Quantity Variation administrative item if the total driven length of each size is less than 85 percent of, or more than 115 percent of the contract quantity as follows:

#### 643.2.1 General

Replace paragraph two with the following effective with the December 2015 letting:

#### **Errata**

Make the following corrections to the standard specifications:

#### 641.2.9 Overhead Sign Supports

Correct errata adding back accidentally deleted paragraphs one through three.

- (1) Provide commercially fabricated overhead sign supports conforming to AASHTO design and fabrication standards for structural supports for highway signs, luminaires, and traffic signals. Use a design life of 50 years with a wind importance factor of 1.00. Design to withstand a 3 second gust wind speed of 90 mph. Do not use the methods of appendix C of those AASHTO standards.
- (2) Design structures, listed as applicable structure types in the AASHTO standards, to the fatigue category criteria as follows:
  - 1. Structures carrying variable message signs:
    - Category I criteria for structures over all roadway types.
  - 2. Structures carrying type II or III signs:
    - Category I criteria for structures used over highways and free flow ramps.
    - Category II criteria for structures with arms greater than 30 feet used over local roads and city streets.
    - Category III criteria for structures with arms 30 feet or less used over local roads and city streets.
- (3) Use the posted speed limit of the roadway beneath the structure for truck-induced gusts.
- (4) Submit shop drawings identified by structure number, design computations, and material specifications, to the engineer before erecting sign supports. Provide tightening procedures for mast arm or luminaire arm to pole shaft connections on the shop drawings. Have a professional engineer registered in the state of Wisconsin sign, seal, and date the shop drawings and certify that the design conforms to AASHTO standards and the contract.
- (5) Provide steel pole shafts and mast arms zinc coated according to ASTM A123. Provide tapered pole and arm shafts with a minimum taper of 0.14 inch per foot for single-member vertical and single-member horizontal structure components. Provide bolts and other hardware conforming to 641.2.2.

#### **ADDITIONAL SPECIAL PROVISION 7**

- A. Reporting 1<sup>st</sup> Tier and DBE Payments During Construction
  - 1. Comply with reporting requirements specified in the department's Civil Rights Compliance, Contractor's User Manual, Sublets and Payments.
  - 2. Report payments to all DBE firms within 10 calendar days of receipt of a progress payment by the department or a contractor for work performed, materials furnished, or materials stockpiled by a DBE firm. Report the payment as specified in A(1) for all work satisfactorily performed and for all materials furnished or stockpiled.
  - 3. Report payments to all first tier subcontractor relationships within 10 calendar days of receipt of a progress payment by the department for work performed. Report the payment as specified in A(1) for all work satisfactorily performed.
  - 4. All tiers shall report payments as necessary to comply with the DBE payment requirement as specified in A(2).
  - 5. Require all first tier relationships, DBE firms and all other tier relationships necessary to comply with the DBE payment requirement in receipt of a progress payment by contractor to acknowledge receipt of payment as specified in A(1), (2), (3) and (4).
  - 6. All agreements made by a contractor shall include the provisions in A(1), (2), (3), (4) and (5), and shall be binding on all first tier subcontractor relationships and all contractors and subcontractors utilizing DBE firms on the project.
- B. Costs for conforming to this special provision are incidental to the contract.

# ADDITIONAL SPECIAL PROVISION 9 Electronic Certified Payroll Submittal

- (2) Ensure that all tiers of subcontractors, as well as all trucking firms, submit their weekly certified payrolls electronically through CRCS. These payrolls are due within seven calendar days following the close of the payroll period. Every firm providing physical labor towards completing the project is a subcontractor under this special provision.
- (3) Upon receipt of contract execution, promptly make all affected firms aware of the requirements under this special provision and arrange for them to receive CRCS training as they are about to begin payrolls. The department will provide training either in a classroom setting at one of our regional offices or by telephone. Contact Tess Mulrooney at 608-267-4489 to schedule the training.
- (4) The department will reject all paper submittals of forms DT-1816 and DT-1929 for information required under this special provision. All costs for conforming to this special provision are incidental to the contract.
- (5) Firms wishing to export payroll data from their computer system into CRCS should have their payroll coordinator send several sample electronic files to Tess two months before a payroll needs to be submitted. Not every contractor's payroll system is capable of producing export files. ### **Effective August 2015 letting**

#### **BUY AMERICA PROVISION**

All steel and iron materials permanently incorporated in this project shall be domestic products and all manufacturing and coating processes for these materials from smelting forward in the manufacturing process must have occurred within the United States. Coating includes epoxy coating, galvanizing, painting and any other coating that protects or enhances the value of a material subject to the requirements of Buy America. The exemption of this requirement is the minimal use of foreign materials if the total cost of such material permanently incorporated in the product does not exceed one-tenth of one percent (1/10 of 1%) of the total contract cost or \$2,500.00, whichever is greater. For purposes of this paragraph, the cost is that shown to be the value of the subject products as they are delivered to the project. The contractor shall take actions and provide documentation conforming to CMM 2-28.5 to ensure compliance with this "Buy America" provision.

#### I. WAGE RATES, HOURS OF LABOR AND PAYMENT OF WAGES

The schedule of "Minimum Wage Rates" attached hereto and made a part hereof furnishes the prevailing wage rates that have been determined pursuant to Section 103.50 of the Wisconsin Statutes. These wage rates are the minimum required to be paid to the various laborers, workers, mechanics and truck drivers employed by contractors and subcontractors on the construction work embraced by the contract and subject to prevailing hours and wages under Section 103.50, Stats. If necessary to employ laborers, workers, mechanics or truck drivers whose classification is not listed on the schedule, they shall be paid at rates conformable to those listed for similar classifications. Apprentices shall be paid at rates not less than those prescribed in their state indenture contacts.

While the wage rates shown are the minimum rates required by the contract to be paid during its life, this in not a representation that labor can be obtained at these rates. It is the responsibility of bidders to inform themselves as to the local labor conditions and prospective changes or adjustments of wage rates. No increase in the contract price shall be allowed or authorized on account of the payment of wage rates in excess of those listed herein.

Pursuant to Section 103.50 of the Wisconsin Statutes, the prevailing hours of labor have been determined to be up to 10 hours per day and 40 hours per calendar week Monday through Friday. If any laborer, worker, mechanic or truck driver is permitted or required to work more than the prevailing number of hours per day or per calendar week on this contract, they shall be paid for all hours in excess of the prevailing hours at a rate of at least one and one-half (1 1/2) times their hourly rate of pay. All work on Saturday, Sunday and the following holidays is to be paid at time and a half: (1) January 1, (2) the last Monday in May, (3) July 4, (4) the first Monday in September, (5) the fourth Thursday in November, (6) December 25, (7) the day before if January 1, July 4 or December 25 falls on a Saturday and (8) the day following if January 1, July 4 or December 25 falls on a Sunday.

All laborers, workers, mechanics and truck drivers shall be paid unconditionally not less often than once a week. Persons who own and operate their own trucks must receive the prevailing truck driver rate for the applicable type of truck (i.e. 2 axle, 3 or more axle, articulated, eculid or dumptor) he or she operates, plus an agreed upon amount for the use of his or her truck. Every owner-operator MUST be paid separately for their driving and for the use of their truck.

For those projects subject to the requirements of the Davis-Bacon Act, the Secretary of Labor will also have determined "Minimum Wage Rates" for work to be performed under the contract. These rates are, for all or most of the labor, worker, mechanic or truck driver classifications, identical to those established under Section 103.50 of the Wisconsin Statutes. In the event the rates are not identical, the higher of the two rates will govern.

#### II. PAYROLL REQUIREMENTS

All contractors and subcontractors must submit weekly Certified Payrolls and Compliance Statement verifying that all laborers, workers, mechanics and truck drivers working on the project have been paid the prevailing wage rates for all work performed under the contract required by Section 103.50 of the Wisconsin Statutes.

#### III. POSTINGS AT THE SITE OF THE WORK

In addition to the required postings furnished by the Department, the contractor shall post the following in at least one conspicuous place at the site of work:

- a. "NOTICE TO EMPLOYEES," which provides information required to be posted by the provisions of Section 103.50 of the Wisconsin Statutes.
- b. A copy of the State of Wisconsin Minimum Wages Rates. (Four pages.)
- c. A copy of the contractor's Equal Employment Opportunity Policy.
- d. On any project involving federal aid, in addition to the furnished postings, the contractor shall post a copy of the "Davis-Bacon Act, Minimum Wage Rates". (Three pages.)

#### IV. WAGE RATE REDISTRIBUTION

The amount specified as the hourly basic rate of pay and the amount(s) specified as the fringe benefit contribution(s), for all classes of laborers, workers, mechanics or truck drivers may be redistributed, when necessary, to conform to those specified in any applicable collective bargaining agreement, provided that both parties to such agreement

request and receive the approval for any such redistribution from both the Department of Transportation and the Department of Workforce Development prior to the implementation of such redistribution.

#### V. ADDITIONAL CLASSIFICATIONS

Any unlisted laborer or mechanic classification that is needed to perform work on this project, and is not included within the scope of any of the classifications listed in the application prevailing wage rate determination, may be added after award only if all of the following criteria have been met:

- 1. The affected employer(s) must make a written request to WisDOT Central Office to utilize the unlisted classification on this project.
- 2. The request must indicate the scope of the work to be performed by the unlisted classification and must indicate the proposed wage/fringe benefit package that the unlisted classification is to receive.
- 3. The work to be performed by the unlisted classification must not be performed by a classification that is included in the applicable prevailing wage rate determination.
- 4. The unlisted classification must be commonly employed in the area where the project is located.
- 5. The proposed wage/fringe benefit package must bear a reasonable relationship to those set forth in the applicable prevailing wage rate determination.
- 6. The request should be made prior to the actual performance of the work by the unlisted classification.
- 7. DWD must approve the use of the unlisted classification and the proposed wage/fringe benefit package. USDOL also must approve the use of the unlisted classification and the proposed wage/fringe benefit package on federal aid projects.
- 8. WisDOT and DWD may amend the proposed wage/fringe benefit package, as deemed necessary, and may set forth specific employment ratios and scope of work requirements in the approval document.

The approved wage/fringe benefit package shall be paid to all laborers, workers, mechanics or truck drivers performing work within the scope of that performed by the unlisted classification, from the first day on which such work is performed. In the event that work is performed by the unlisted classification prior to approval, the wage/fringe benefit package to be paid for such work must be in conformance with the wage/fringe

benefit package approved for such work. Under this arrangement a retroactive adjustment in wages and/or fringe benefits may be required to be made to the affected laborers, workers, mechanics or truck drivers by the affected employer(s).

**FUTURE INCREASE:** If indicated for a specific trade or occupation, the full amount of such increase MUST be added to the "TOTAL" indicated for such trade or occupation on the date(s) such increase(s) becomes effective.

**PREMIUM PAY:** If indicated for a specific trade or occupation, the full amount of such pay MUST be added to the "HOURLY BASIC RATE OF PAY" indicated for such trade or occupation, whenever such pay is applicable.

**SUBJOURNEY:** Wage rates may be available for some of the classifications indicated below. Any employer that desires to use any subjourney classification on a project MUST request the applicable wage rate from the Department of Workforce Development PRIOR to the date such classification is used on such project. Form ERD-10880 is available for this purpose and can be obtained by writing to the Department of Workforce Development, Equal Rights Division, P.O. Box 8928, Madison, WI 53708.
