Provide the start date to the engineer in writing within a month after executing the contract but at least 14 calendar days before the preconstruction conference. Upon approval, the engineer will issue the notice to proceed within ten calendar days before the approved start date.

To revise the start date, submit a written request to the engineer at least two weeks before the intended start date. The engineer will approve or deny that request based on the conditions cited in the request and its effect on the department's scheduled resources.

It is anticipated that the Notice to Proceed will be issued no later than May 1, 2018.

This section of Old CTH PB is included in the bicycle course for the Ironman Triathlon event scheduled for September 9, 2018. The completion date has been established, and the following provision developed, so that the project is completed prior to the event.

The department will not grant time extensions to the completion date for the following:

- 1. Severe weather as specified in standard spec 108.10.2.2.
- 2. Labor disputes that are not industry wide.
- 3. Delays in material deliveries.

# Fish Spawning

There shall be no instream disturbance of Badger Mill Creek as a result of construction activity under or for this contract, from September 16 to April 30, both dates inclusive, in order to avoid adverse impacts upon the spawning of aquatic organisms.

Any change to this limitation will require submitting a written request by the contractor to the engineer, subsequent review and concurrence by the Department of Natural Resources in the request, and final approval by the engineer. The approval will include all conditions to the request as mutually agreed upon by WisDOT and DNR.

# **Migratory Birds**

Swallow and other migratory birds' nests have been observed on or under the existing bridge for Project 5796-00-73 (Town of Verona). All active nests (when eggs or young are present) of migratory birds are protected under the federal Migratory Bird Treaty Act.

The nesting season for swallows and other birds is usually between May 1 and August 30. Either prevent active nests from becoming established, or apply for a depredation permit from the US Fish and Wildlife Service for work that may disturb or destroy active nests. The need for a permit may be avoided by removing the existing bridge structure prior to nest occupation by birds, or clearing nests from all structures before the nests become active in early spring. As a last resort, prevent birds from nesting by installing a suitable netting device on the remaining structure prior to nesting activity. Include the cost for preventing nesting in the cost of Removing Old Structure Over Waterway with Minimal Debris.

# **Northern Long-eared Bat** (*Myotis septentrionalis*)

Northern Long-eared Bats (NLEB) have the potential to inhabit the project limits because they roost in trees. Roosts may not have been observed on this project, but conditions to support the species exist. The species and all active roosts are protected by the Federal Endangered Species Act. If an individual bat or active roost is encountered during construction operations, stop work and notify the engineer and the WisDOT Regional Environmental Coordinator (REC).

In accordance to the final 4(d) rule issued for the NLEB, the department has determined that the proposed activity may affect, but will not result in prohibited take of the NLEB. The activity involves tree removal, but will not occur within 0.25 miles of a known hibernacula,

nor will the activity remove a known maternity roost tree or any other tree within 150 feet of a known maternity roost tree.

If additional trees need to be removed, no Clearing shall occur without prior approval from the engineer, following coordination with the WisDOT REC. Additional tree removal beyond the area originally specified will require consultation with the United States Fish and Wildlife Service (USFWS) and may require a bat presence/absence survey. Notify the engineer if additional Clearing cannot be avoided to begin coordination with the WisDOT REC. The WisDOT REC will initiate consultation with the USFWS and determine if a survey is necessary.

Submit a schedule and description of Clearing operations with the ECIP 14 days prior to any Clearing operations. The department will determine, based on schedule and scope of work, what additional erosion control measures shall be implemented prior to the start of Clearing operations, and list those additional measures in the ECIP.

## 4. Traffic.

Close Old CTH PB to through traffic during construction. A detour route will be signed and details are included in the plans.

Close the Military Ridge State Trail to trail users during construction. A detour route will be signed and details are included in the plans. Prior to closure, contact Kevin Swenson from the DNR at 608-437-5711 regarding closure and to provide opportunity to modify existing trail signs.

# 5. Utilities.

This contract does not come under the provision of Administrative Rule Trans 220. stp-107-065 (20080501)

Alliant Energy has an underground line which enters the project area from the south at approximately 55' RT. The line then continues north to Station 9+00, then veers closer to the roadway across the waterway to Station 10+77, 40' RT. The line then continues north along the roadway to Station 13+75, 40' RT, where it angles out toward the existing right-of-way line at approximately Station 17+15 and crosses underneath the Military Ridge State Trail. The portion of the line from approximately Station 9+50 to Station 11+25 will be lowered and relocated just inside the existing right-of-way line prior to construction and no conflicts are anticipated after relocation. The portion under the Military Ridge State Trail where guardrail is proposed at approximately Station 17+40 is over 10' below the surface and will be left in place.

An overhead line enters the project area from the south at approximately 60' RT. The line then continues north, exiting the project area at 58' RT. This line will remain in place throughout construction. Maintain minimum OSHA clearance requirements when working adjacent to the overhead line.

An overhead line crosses Old CTH PB at approximately Station 14+75 and connects into the pole at Station 14+85, 60' LT, connecting the Badger Prairie Community Garden into the main electrical line. No conflicts are anticipated and this line will remain in place throughout construction.

**TDS Telecom** has several underground communication lines in the project area. They have two underground copper telephone lines which enter the project area from the south at approx. 35' LT, heading north across the branch of Badger Mill Creek to a pedestal at Station 12+43, 43' LT. The lines then continue NNE across Badger Mill Creek and the Military Ridge Recreational Trail, exiting the project area at 35' LT.

They also have an underground fiber optic line which enters the project area from the south at approx. 30' LT, heading north across the branch of Badger Mill Creek and Badger Mill Creek and continuing to follow the roadway NNE, exiting the project area at 25' LT. There is also an existing fiber optic line that parallels the south side of the Military Ridge Recreational Trail crossing Old CTH PB at approximately Station 17+00 (this line was not marked in the field prior to field survey and is not shown on the plans).

The copper and fiber lines will be relocated throughout the length of the project from approximately Station 7+35 LT to Station 18+25 LT. They will be located just inside the existing right-of-way from approximately Station 7+35 LT to Station 15+85 LT where they will then be re-directed to tie into a hand hole at approximately Station 16+85, 35' LT. The existing hand hole at that location will be shifted several feet to the southwest farther away from the proposed guardrail installation. The lines will tie into a new pedestal to the north at approximately Station 18+25, 55' LT. The new lines will be placed approximately 11' below the existing ground under the proposed culverts at Station 10+08 and approximately 8' below the existing Military Ridge Recreational Trail. The old lines will be discontinued and left in place, except for the fiber optic line along the south side of the trail which will remain in place. All work will take place prior to construction. No conflicts are anticipated after construction where these lines will be relocated.

# 6. Notice to Contractor – Airport Coordination by Contractor.

Coordinate with the Federal Aviation Administration (FAA) regarding the height and/or elevation of the temporary features within the airspace around the Verona Air Park.

Since portions of the project come close to the Verona Air Park, the FAA's Obstruction Evaluation Website shall be checked to see if any notices of proposed construction will be required by FAA. The "Notice Criteria Tool' shall be used to see if any equipment will require study. Filing with the FAA is required at least 45 days prior to construction.

If temporary elevations will exceed the estimated notice criteria elevations, the contractor will need to prepare and submit FAA Form 7460-1 Notice of proposed construction or

Alteration at least 60 days prior to the start of construction activities. The required form can be found at the following location:

The contractor shall copy the engineer on any correspondence with the FAA as it relates to new determinations. The contractor must also notify Robin Slotten at the Verona Air Park, phone number (608) 845-7239, if a filing of FAA Form 7460-1 is necessary. A determination concerns the effect of temporary structures on the safe and efficient use of navigable airspace by aircraft and does not relieve the sponsor of compliance responsibilities relating to any law, ordinance or regulation of any Federal, State or local government body.

# 7. Information to Bidders, U.S. Army Corps of Engineers Section 404 Permit.

The department has obtained a U.S. Army Corps of Engineers Section 404 permit. Comply with the requirements of the permit in addition to requirements of the special provisions. A copy of the permit is available from the regional office by contacting John Bainter, WisDOT, at (608) 785-9729.

# 8. Environmental Protection, Aquatic Exotic Species Control.

Exotic invasive organisms such as VHS, zebra mussels, purple loosestrife, Eurasian water milfoil, and New Zealand Mudsnail are becoming more prolific in Wisconsin and pose adverse effects to waters of the state. Wisconsin State Statutes 30.07, "Transportation of Aquatic Plants and Animals; Placement of Objects in Navigable Waters", details the state law that requires the removal of aquatic plants, zebra mussels, and the New Zealand Mudsnail each time equipment is put into state waters.

At construction sites that involve navigable water or wetlands, use the follow cleaning procedures to minimize the chance of exotic invasive species infestation. Use these procedures for all equipment that comes in contact with waters of the state and/or infested water or potentially infested water in other states.

Ensure that all equipment that has been in contact with waters of the state, or with infested or potentially infested waters, has been decontaminated for aquatic plant materials zebra mussels, and New Zealand Mudsnails prior to being used in other waters of the state. Before using equipment on this project, thoroughly disinfect all equipment that has come into contact with potentially infested waters. Use the following inspection and removal procedures (guidelines from the Wisconsin Department of Natural Resources <a href="http://dnr.wi.gov/topic/fishing/documents/vhs/disinfection">http://dnr.wi.gov/topic/fishing/documents/vhs/disinfection</a> protocols.pdf for disinfection:

1. Prior to leaving the contaminated site, wash machinery and ensure that the machinery is free of all soil and other substances that could possibly contain exotic invasive species;

- 2. Drain all water from boats, trailers, bilges, live wells, coolers, bait buckets, engine compartments, and any other area where water may be trapped;
- 3. Inspect boat hulls, propellers, trailers and other surfaces. Scrape off any attached mussels and snails, remove any aquatic plant materials (fragments, stems, leaves, seeds, or roots), and dispose of removed mussels, snails, and plant materials in a garbage can prior to leaving the area or invested waters; and
- 4. Disinfect your boat, equipment and gear by either:
  - a. Washing with ~212° F water (steam clean), or
  - b. Freeze for 8 hours, or
  - c. Soak in 120° F water for several minutes, or
  - d. Drying thoroughly for five days (>84 ° F for 24 hours; >104 ° for >2 hours) after cleaning with soap and water and/or high pressure water, or
  - e. Disinfecting with 1:100 solution (38 grams per gallon) of Virkon Aquatic for 20- to 30-minute contact time. Note: Virkon is not registered to kill zebra mussel veligers nor invertebrates like spiny water flea. Therefore this disinfect should be used in conjunction with a hot water (>104° F) application.

Complete the inspection and removal procedure before equipment is brought to the project site and before the equipment leaves the project site.

# 9. Erosion Control Structures.

Within seven calendar days after the commencement of work on the bridge superstructure, place all permanent erosion control devices, including riprap, erosion mat, ditch checks, seed, fertilizer, mulch, soil stabilizer, or any other item required by the contract or deemed necessary by the engineer. These devices shall be in place in the area under the bridge and on both sides of the roadway, from the waterway to a point 100-feet behind the backwall of the abutment. Within said limits, place these devices to a height equivalent to the calculated water elevation resulting from a storm that occurs on the average of once every two years (Q2) as shown on the plan, or as directed by the engineer. Prior to initial construction operations, place turbidity barriers, silt screens, and other temporary erosion control measures as shown on the plans, and remove them after the permanent erosion control devices are in place unless directed otherwise by the engineer.

In the event that construction activity does not disturb the existing ground below the Q2 elevation, the above timing requirements for permanent erosion control shall be waived. stp-107-070 (20030820)

# 10. Monitoring Wells.

Two monitoring wells are located along the Military Ridge State Trail at Station 17+04, 77.5' LT, and Station 17+07, 72.9' LT. These are monitoring the landfill located north and west of Maple Grove Road and north of US 18. These wells are not to be disturbed. - (1) Remove the existing Structure B-13-784 over the Branch of Badger Mill Creek conforming to the contractor's approved structure removal and clean-up plan. Remove all reinforcing steel, all concrete, and all other debris that falls into the waterway or wetland. Remove large pieces of the structure within 36 hours. The contractor may leave limited amounts of small concrete pieces scattered over the waterway floor or wetland only if the engineer allows.

  - Methods to control dust and contain slurry.
  - Methods for removing piers and abutments. If blasting in water, include restrictions that regulatory agencies and the contract require.
  - Methods for cleaning the waterway or wetlands.
- (3) If stockpiling spoil material, place it on an upland site an adequate distance from the waterway, wetland, or any open water created by excavation. Install silt fence between the spoil pile and the waterway, wetland, or excavation site.

# 15. QMP Base Aggregate.

# **A** Description

# A.1 General

(1) This special provision describes contractor quality control (QC) sampling and testing for base aggregates, documenting those test results, and documenting related production and placement process changes. This special provision also describes department quality verification (QV), independent assurance (IA), and dispute resolution.

- (2) Conform to standard spec 301, standard spec 305, and standard spec 310 as modified here in this special provision. Apply this special provision to material placed under all of the Base Aggregate Dense and Base Aggregate Open Graded bid items, except do not apply this special provision to material classified as reclaimed asphaltic pavement placed under the Base Aggregate Dense bid items.
- (3) Do not apply this special provision to material placed and paid for under the Aggregate Detours, Breaker Run, Select Crushed, Pit Run, Subbase, or Riprap bid items.
- (4) Provide and maintain a quality control program, defined as all activities related to and documentation of the following:
  - 1. Production and placement control and inspection.
  - 2. Material sampling and testing.
- (5) Chapter 8 of the department's construction and materials manual (CMM) provides additional detailed guidance for QMP work and describes required sampling and testing procedures. The contractor may obtain the CMM from the department's web site at: http://wisconsindot.gov/Pages/doing-bus/eng-consultants/cnslt-rsrces/rdwy/default.aspx

# **A.2 Small Quantities**

- (1) The department defines a small quantity, for each individual Base Aggregate bid item, as a contract quantity of 9000 tons or less of material as shown in the schedule of items under that bid item.
- (2) The requirements under this special provision apply equally to a small quantity for an individual bid item except as follows:

# A.2.1 Quality Control Plan

- (1) Submit an abbreviated quality control plan consisting of the following:
  - 1. Organizational chart including names, telephone numbers, current certification(s) with HTCP number(s) and expiration date(s), and roles and responsibilities of all persons involved in the quality control program for material under affected bid items.

- [1] Submit production test results to the engineer for review prior to incorporating the material into the work. Production test results are valid for a period of 3 years.
- [2] If the actual quantity overruns 6,000 tons, on the next day of placement perform one randomly selected placement test for each 3000 tons, or fraction of 3000 tons, of overrun.

- [3] If the actual quantity overruns 9000 tons, on the next day of placement perform one randomly selected placement test for each 3000 tons, or fraction of 3000 tons, of overrun.
- [4] For 3-inch material or lift thickness of 3-inch or less, obtain samples at load-out.
- Divide the aggregate into uniformly sized sublots for testing
- 2. Stockpile testing for concrete pavement recycled in place will be sampled on the first day of production.
- 3. Until a four point running average is established, individual placement tests will be used for acceptance. Submit aggregate load-out and placement test results to the engineer within one business day of obtaining the sample. Assure that all properties are within the limits specified for each test.
- 4. Material represented by a sublot with any property outside the specification limits is nonconforming. The department may reject material or otherwise determine the final disposition of nonconforming material as specified in standard spec 106.5.

# **A.2.3 Department Testing**

- (1) The department will perform testing as specified in B.8 except as follows:
  - Department stockpile verification testing prior to placement is optional for contract quantities of 500 tons or less.

# **B** Materials

# **B.1** Quality Control Plan

- (1) Submit a comprehensive written quality control plan to the engineer at or before the pre-construction meeting. Do not place base before the engineer reviews and comments on the plan. Construct the project as that plan provides.
- (2) Do not change the quality control plan without the engineer's review. Update the plan with changes as they become effective. Provide a current copy of the plan to the engineer and post in each of the contractor's laboratories as changes are adopted. Ensure that the plan provides the following elements:
  - 1. An organizational chart with names, telephone numbers, current certifications and/or titles, and roles and responsibilities of QC personnel.
  - 2. The process used to disseminate QC information and corrective action efforts to the appropriate persons. Include a list of recipients, the communication means that will be used, and action time frames.
  - 3. A list of source and processing locations, section and quarter descriptions, for all aggregate materials requiring QC testing.
  - 4. Test results for wear, sodium sulfate soundness, freeze/thaw soundness, and plasticity index of all aggregates requiring QC testing. Obtain this information from the region materials unit or from the engineer.
  - 5. Descriptions of stockpiling and hauling methods.

- 6. Locations of the QC laboratory, retained sample storage, and where control charts and other documentation is posted.
- 7. An outline for resolving a process control problem. Include responsible personnel, required documentation, and appropriate communication steps.

#### **B.2** Personnel

(1) Have personnel certified under the department's highway technician certification

program (HTCP) perform sampling, testing, and documentation as follows:

Plant personnel under the direct observation of an aggregate technician certified at level one or higher may operate equipment to obtain samples.

(2) A certified technician must coordinate and take responsibility for the work an ACT performs. Have a certified technician ensure that all sampling and testing is performed correctly, analyze test results, and post resulting data. No more than one ACT can work under a single certified technician.

## **B.3** Laboratory

(1) Perform QC testing at a department-qualified laboratory. Obtain information on the Wisconsin laboratory qualification program from:

# **B.4 Quality Control Documentation**

#### **B.4.1** General

(1) Submit base aggregate placement documentation to the engineer within 10 business days after completing base placement. Ensure that the submittal is complete, neatly organized, and includes applicable project records and control charts.

## **B.4.2 Records**

(1) Document all placement observations, inspection records, and control adjustments daily in a permanent field record. Also include all test results in the project records. Provide test results to the engineer within one business day after obtaining a sample. Post or

distribute tabulated results using a method mutually agreeable to the engineer and contractor.

#### **B.4.3 Control Charts**

- (1) Plot gradation and fracture on the appropriate control chart as soon as test results are available. Format control charts according to CMM 8.30. Include the project number on base placement control charts. Maintain separate control charts for each base aggregate size, source or classification, and type.
- Provide control charts to the engineer within one business day after obtaining a sample. Post or distribute charts using a method mutually agreeable to the engineer and contractor. Update control charts daily to include the following:
  - 1. Contractor individual QC tests.
  - 2. Department QV tests.
  - 3. Department IA tests.
  - 4. Four-point running average of the QC tests.
- (3) Except as specified under B.8.2.1 for nonconforming QV placement tests, include only QC placement tests in the running average. The contractor may plot process control or informational tests on control charts, but do not include these tests, conforming QV tests, or IA tests in the running average.

# **B.5** Contractor Testing

- (1) Test gradation, fracture, liquid limit and plasticity index during placement for each base aggregate size, source or classification, and type.
- (2) Perform one stockpile test from each source prior to placement.
- (3) Test gradation once per 3000 tons of material placed or fraction thereof. Determine random sample locations and provide those sample locations to the engineer. Obtain samples after the material has been bladed, mixed, and shaped but before compacting; except collect 3-inch samples or lift thickness of 3-inch or less from the stockpile at load-out. Do not sample from material used to maintain local traffic or from areas of temporary base that will not have an overlying pavement. On days when placing only material used to maintain local traffic or only temporary base that will not have an overlying pavement, no placement testing is required.
- (4) Split each contractor QC sample and identify it according to CMM 8.30. Retain the split for seven calendar days in a dry, protected location. If requested for department comparison testing, deliver the split to the engineer within one business day.
- (5) The engineer may require additional sampling and testing to evaluate suspect material or the technician's sampling and testing procedures.

- (6) Test fracture for each gradation test until the fracture running average is above the lower warning limit. Subsequently, the contractor may reduce the frequency to one test per 10 gradation tests if the fracture running average remains above the warning limit.
- (7) Test the liquid limit and plasticity index for the first gradation test. Subsequently, test the liquid limit and plasticity index a minimum of once per 10 gradation tests.

# **B.6 Test Methods**

#### **B.6.1** Gradation

(1) Test gradation using a washed analysis conforming to the following as modified in CMM 8.60:

Gradation	AASHTO '	Γ27
Material finer than the No. 200 sieve	AASHTO '	T 11

- (2) For 3-inch base, if 3 consecutive running average points for the percent passing the No. 200 sieve are 8.5 percent or less, the contractor may use an unwashed analysis. Wash at least one sample out of 10. If a single running average for the percent passing the No. 200 sieve exceeds 8.5 percent, resume washed analyses until 3 consecutive running average points are again 8.5 percent passing or less.
- (3) Maintain a separate control chart for each sieve size specified in standard spec 305 or standard spec 310 for each base aggregate size, source or classification, and type. Set control and warning limits based on the standard specification gradation limits as follows:
  - 1. Control limits are at the upper and lower specification limits.
  - 2. There are no upper warning limits for sieves allowing 100 percent passing and no lower control limits for sieves allowing 0 percent passing.
  - 3. Dense graded warning limits, except for the No. 200 sieve, are 2 percent within the upper and lower control limits. Warning limits for the No. 200 sieve are set 0.5 percent within the upper and lower control limits.
  - 4. Open graded warning limits for the 1-inch, 3/8-inch, and No. 4 sieves are 2 percent within the upper and lower control limits. Upper warning limits for the No. 10, No. 40, and No. 200 sieves are 1 percent inside the upper control limit.

#### **B.6.2** Fracture

- (1) Test fracture conforming to CMM 8.60. The engineer will waive fractured particle testing on quarried stone.
- (2) Maintain a separate fracture control chart for each base aggregate size, source or classification, and type. Set the lower control limit at the contract specification limit, either specified in another special provision or in table 301-2 of standard spec 301.2.4.5. Set the lower warning limit 2 percent above the lower control limit. There are no upper limits.

# **B.6.3** Liquid Limit and Plasticity

- (1) Test the liquid limit and plasticity according to AASHTO T 89 and T 90.
- (2) Ensure the material conforms to the limits specified in standard spec table 301-2.

#### **B.7** Corrective Action

#### B.7.1 General

(1) Consider corrective action when the running average trends toward a warning limit. Take corrective action if an individual test exceeds the contract specification limit. Document all corrective actions both in the project records and on the appropriate control chart.

## **B.7.2 Placement Corrective Action**

- (1) Do not blend additional material on the roadbed to correct gradation problems.
- (2) Notify the engineer whenever the running average exceeds a warning limit. When two consecutive running averages exceed a warning limit, the engineer and contractor will discuss appropriate corrective action. Perform the engineer's recommended corrective action and increase the testing frequency as follows:
  - 1. For gradation, increase the QC testing frequency to at least one randomly sampled test per 1000 tons placed.
  - 2. For fracture, increase the QC testing frequency to at least one test per gradation test.
- (3) If corrective action improves the property in question such that the running average after four additional tests is within the warning limits, the contractor may return to the testing frequency specified in B.5.3. If corrective action does not improve the property in question such that the running average after four additional individual tests is still in the warning band, repeat the steps outlined above starting with engineer notification.
- (4) If the running average exceeds a control limit, material starting from the first running average exceeding the control limit and ending at the first subsequent running average inside the control limit is nonconforming and subject to pay reduction.
- (5) For individual test results significantly outside the control limits, notify the engineer, stop placing base, and suspend other activities that may affect the area in question. The engineer and contractor will jointly review data, data reduction, and data analysis; evaluate sampling and testing procedures; and perform additional testing as required to determine the extent of potentially unacceptable material. The engineer may direct the contractor to remove and replace that material. Individual test results are significantly outside the control limits if meeting one or more of the following criteria:
  - 1. A gradation control limit for the No. 200 sieve is exceeded by more than 3.0 percent.
  - 2. A gradation control limit for any sieve, except the No. 200, is exceeded by more than 5.0 percent.
  - 3. The fracture control limit is exceeded by more than 10.0 percent.

# **B.8 Department Testing**

# **B.8.1** General

(1) The department will conduct verification testing to validate the quality of the product and independent assurance testing to evaluate the sampling and testing. The department will provide the contractor with a listing of names and telephone numbers of all QV and IA personnel for the project, and provide test results to the contractor within two business days after the department obtains the sample.

# **B.8.2** Verification Testing

## B.8.2.1 General

- (1) The department will have an HTCP technician, or ACT working under a certified technician, perform QV sampling and testing. Department verification testing personnel must meet the same certification level requirements specified in B.2 for contractor testing personnel for each test result being verified. The department will notify the contractor before sampling so the contractor can observe QV sampling.
- (2) The department will conduct QV tests of each base aggregate size, source or classification, and type during placement conforming to the following:
  - 1. Perform one stockpile test from each source prior to placement.
  - 2. At least one random test per 30,000 tons, or fraction of 30,000 tons, placed.
- (3) The department will sample randomly, at locations independent of the contractor's QC work, collecting one sample at each QV location. The department will collect QV samples after the material has been bladed, mixed, and shaped but before compacting; except, for 3-inch aggregates or for a lift thickness of 3-inch or less, the department will collect samples at load-out. The department will split each sample, test half for QV, and retain half.
- (4) The department will conduct QV tests in a separate laboratory and with separate equipment from the contractor's QC tests. The department will use the same methods specified for QC testing.
- (5) The department will assess QV results by comparing to the appropriate specification limits. If QV test results conform to the specification, the department will take no further action. If QV test results are nonconforming, add the QV to the QC test results as if it were an additional QC test.

# **B.8.3** Independent Assurance

(1) Independence assurance is unbiased testing the department performs to evaluate the department's QV and the contractor's QC sampling and testing including personnel qualifications, procedures, and equipment. The department will perform an IA review according to the department's independent assurance program. That review may include one or more of the following:

- 1. Split sample testing.
- 2. Proficiency sample testing.
- 3. Witnessing sampling and testing.
- 4. Test equipment calibration checks.
- 5. Reviewing required worksheets and control charts.
- 6. Requesting that testing personnel perform additional sampling and testing.
- (2) If the department identifies a deficiency, and after further investigation confirms it, correct that deficiency. If the contractor does not correct or fails to cooperate in resolving identified deficiencies, the engineer may suspend placement until action is taken. Resolve disputes as specified in B.9.

# **B.9 Dispute Resolution**

- (1) The engineer and contractor should make every effort to avoid conflict. If a dispute between some aspect of the contractor's and the engineer's testing program does occur, seek a solution mutually agreeable to the project personnel. The department and contractor may review the data, examine data reduction and analysis methods, evaluate sampling and testing procedures, and perform additional testing. Use ASTM E 178 to evaluate potential statistically outlying data.
- (2) Production test results, and results from other process control testing, may be considered when resolving a dispute.
- (3) If the project personnel cannot resolve a dispute, and the dispute affects payment or could result in incorporating non-conforming product, the department will use third party testing to resolve the dispute. The department's central office laboratory, or a mutually agreed on independent testing laboratory, will provide this testing. The engineer and contractor will abide by the results of the third party tests. The party in error will pay service charges incurred for testing by an independent laboratory. The department may use third party test results to evaluate the quality of questionable materials and determine the appropriate payment. The department may reject material or otherwise determine the final disposition of nonconforming material as specified in standard spec 106.5.

#### E Payment

(1) Costs for all sampling, testing, and documentation required under this special provision are incidental to this work. If the contractor fails to perform the work required under this special provision, the department may reduce the contractor's pay. The department will administer pay reduction under the non-performance of QMP administrative item.

(2) For material represented by a running average exceeding a control limit, the department will reduce pay according to CMM 8-10.5.2 for the affected Base Aggregate bid items listed in subsection A. The department will administer pay reduction under the Nonconforming QMP Base Aggregate Gradation or Nonconforming QMP Base Aggregate Fracture Administrative items. The department will determine the quantity of nonconforming material as specified in B.7.2.

# 16. Concrete Staining Multi-Color B-13-0674, Item 517.1015.S.01.

# **A** Description

Furnish and apply a multi-color concrete stain to the exposed concrete surfaces of the structure, as detailed in the plans and as hereinafter provided.

#### **B** Materials

## **B.1** Mortar

Use mortar for sack rubbing the concrete surfaces as given in standard spec 502.3.7.5 or use one of the following products:

Preblended, Packaged Type II Cement: Tri-Mix by TK Products

Thoroseal Pearl Gray by Thoro Products

The mortar shall contain one of the following acrylic bonding admixtures mixed and applied according to manufacturer's recommendations:

Acrylic Bonding Admixture: TK-225 by TK Products

Achro 60 by Thoro Products Achro Set by Master Builders

#### **B.2** Concrete Stain

Use concrete stain manufactured for use on exterior concrete surfaces. Use the following products, or equal as approved by the department:

Tri-Sheen Concrete Surfacer, Smooth by TK Products

Tri-Sheen Acrylic by TK Products

TK-1450 Natural Look Urethane Anti-Graffiti Primers by TK Products

Safe-Cure & Seal EPX by Chem Masters

H&C Concrete Stain Solid Color Water Based by Sherwin-Williams

## **C** Construction

#### C.1 General

Furnish, prepare, apply, cure, and store all materials according to the product manufacturer's specifications for the type and condition of application required.

Match or exceed the stain manufacturer's minimum recommended curing time of the concrete or 28 days, whichever is greater, prior to staining.

# **C.2** Preparation of Concrete Surfaces

Provide a sack rubbed finish according to standard spec 502.3.7.5, using mortar as indicated above on concrete surfaces with open voids or honeycombing.

Following the sack rubbing, clean all concrete surfaces that are to be coated to ensure that the surface is free of all laitance, dirt, dust, grease, efflorescence, and any foreign material and that the surface will accept the coating material according to product requirements. As a minimum, clean the surface using a 3000-psi water blast. Hold the nozzle of the water blaster approximately 6 inches from the concrete surface and move it continuously in a sweeping motion. Give special attention to smooth concrete surfaces to produce an acceptable surface texture. Correct any surface problems resulting from the surface preparation methods. Grit blasting of the concrete surface is not allowed.

# **C.3** Staining Concrete Surfaces

Apply the concrete stain according to the manufacturer's recommendations.

Apply the concrete stain when the temperature of the concrete surface is 45° F or higher, or as given by the manufacturer.

The color of the staining shall produce a multi-color effect that consists of multiple colors replicating varying natural stone coloration. Stain the joints between stones produced by the form liner to create the appearance of grouted joints.

Do not begin staining the structure until earthwork operations are completed to a point where this work can begin without receiving damage. Where this work is adjacent to exposed soil or pavement areas, provide temporary covering protection from overspray or splatter.

# C.4 Test Areas

Prior to applying stain to the structure, apply the stain to sample panels measuring a minimum of 48-inches x 48-inches and constructed to demonstrate workmanship in the use of the form liner specified on the structure if applicable. Match or exceed the stain manufacturer's minimum recommended curing time of the concrete or 28 days, whichever is greater, prior to staining. Submit color samples to the department prior to staining the sample panels. Prepare the concrete surfaces of the sample panels and apply stain using the same materials and in the same manner as proposed for the structure, including staining of the joints between stones produced by the form liner. Do not apply stain to the structure until the department approves the test panels.

#### C.5 Surfaces to be Coated.

Apply concrete stain to the surfaces according to the plan.

#### **D** Measurement

The department will measure Concrete Staining Multi-Color (Structure) in area by the square foot of surface, acceptably prepared and stained.

The department will pay for measured quantities at the contract unit price under the following bid item:

# 17. Architectural Surface Treatment B-13-0674, Item 517.1050.S.01.

## **A Description**

Construct a concrete masonry architectural surface treatment on the exposed concrete surfaces of the structure, as detailed in the plans and as hereinafter provided.

#### **B** Materials

Use form liners that attach easily to the forming system, and do not compress more than \(^1\)4-inch when poured at a rate of 10 vertical feet/hour.

Use a release agent that is compatible with the form liner and coloring materials.

Wall ties shall have set "break-backs" at a minimum of ¾-inches from the finished concrete surface.

#### **C** Construction

#### C.1 Equipment

Equipment and tools necessary for performing all parts of the work shall be satisfactory as to design, capacity, and mechanical condition for the purposes intended. Repair, improve, replace, or supplement all equipment that is not maintained in full working order, or which is proven inadequate to obtain the results prescribed.

## **C.2** Form Liner Preparation

Clean the form liner prior to each pour and ensure that it is free of any build-up. Visually inspect each liner for blemishes or tears, and repair if necessary per manufacturer's recommendations.

Apply form release per manufacturer's recommendations.

## **C.3 Form Liner Attachment**

Place adjacent liners less than ¼-inch from each other, attach liner securely to forms according to the manufacturer's recommendations, and coordinate wall ties with form liner and form manufacturer, e.g., diameter, size, and frequency.

# **C.4 Surface Finishing**

Ensure that the textured surface is free of laitance; sandblasting is not permitted.

Grind or fill pouring blemishes.

#### **D** Measurement

The department will measure Architectural Surface Treatment (Structure) in area by the square foot of architectural surface, acceptably completed.

# **E** Payment

The department will pay for measured quantities at the contract unit price under the following bid item:

# 18. Temporary Access Road, Item SPV.0105.01.

# **A Description**

If desired by the contractor to facilitate construction operations, construct a temporary access road to bypass bridge removal and culvert construction over Branch Badger Mill Creek. Said access consists of a temporary access road connected to Old CTH PB and extending off the east side of the roadway onto existing Wisconsin Department of Transportation right-of-way. This item provides for the construction and maintenance of the temporary access road, removal of the temporary access road prior to the end of construction, and the restoration of the site.

## **B** Materials

Obtain approval of the engineer for all materials and conform to the pertinent requirements of the standard specifications.

## **C** Construction

Address temporary erosion control in the erosion control implementation plan.

At least 30 days prior to construction on WisDOT-owned right-of-way, the contractor will obtain a construction permit from WisDOT.

Provide topsoil, seeding, fertilizer, mulching, and erosion control for the temporary access road and for the restored area after removal of the road.

Provide removal and replacement of woven wire fence disturbed during installation of road.

Provide for installation of temporary culvert or temporary bridge. Coordinate temporary structure with the Wisconsin Department of Natural Resources.

Though not expected to be necessary, if dredging is desired to facilitate means and methods of construction, obtain all necessary regulatory agency approvals.

When removing the temporary access road, restore the surface as closely as possible to its natural state. Thoroughly remove all access road materials from disturbed area and Branch Badger Mill Creek.

#### **D** Measurement

The department will measure Temporary Access Road as a single complete lump sum unit of work, acceptably completed.

# **E Payment**

The department will pay for measured quantities at the contract unit price under the following bid item:

Payment is full compensation for any additional agency coordination and/or permitting; for furnishing all materials; for constructing and maintaining the temporary access road; for the removal of all temporary access road materials; for installation and removal of temporary erosion control along the temporary access road; for removal and replacement of woven wire fence; for installation of temporary culvert, and for restoration of the site after removal of the road.

# 19. Temporary Military Ridge State Trail Detour Surface, Item SPV.0105.02.

# **A** Description

Construct a temporary detour of the Military Ridge State Trail in the northeast corner of the trail's existing crossing with Old CTH PB, where the detour route is not on existing pavement. Said temporary detour consists of a trail surface composed of limestone screenings conforming to Wisconsin Department of Natural Resources specifications. This item provides for the construction and maintenance of the temporary detour, removal of the temporary detour, and the restoration of the site.

#### **B** Materials

Obtain approval of the engineer for all materials and conform to the pertinent requirements of the standard specifications.

Construct a minimum of the top 2 inches of the temporary detour route surface out of limestone screenings. Limestone screenings furnished for this work shall conform to the quality and gradation requirements hereinafter set forth. Alternate gradations shall be submitted a minimum of two weeks prior to construction to the engineer for consideration. All gradation analysis shall be performed by a competent laboratory using AASHTO method T-27 standards. Limestone surface course shall consist of crushed limestone screenings with

100% passing a 3/8 inch screen and well graded down to a No. 200 screen to conform to the following gradation requirements:

Sieve Size	% by Weight Passing
3/8 inch	100
No. 4	80-95
No. 40	65-85
No. 100	25-40
No. 200	8-25

Use bedding free from clumps, rocks, organic and frozen materials.

## **C** Construction

Operations, including constructed features, and storage of equipment and materials shall occur only in permitted areas covered by the Section 404 permit, as shown in the plan.

Address temporary erosion control in the erosion control implementation plan.

At least 14 days prior to the pre-construction meeting, submit a plan to the DNR for approval showing proposed dimensions, materials, and method for construction of the temporary detour surface.

Construct the temporary detour surface to obtain a usable travel way for bicycles and pedestrians. Grade and shape the surface to drain away from the trail. Maintain the surface to avoid ruts, potholes, and washouts.

Provide topsoil, seeding, fertilizer, mulch, and erosion control for the temporary detour surface.

Though not expected to be necessary, if dredging is desired to facilitate means and methods of construction, obtain all necessary regulatory agency approvals.

When removing the temporary detour surface, regrade and restore the disturbed area damaged by the work operations to a condition as close as possible to its original state.

## **D** Measurement

The department will measure Temporary Military Ridge State Trail Detour Surface as a single complete lump sum unit of work, acceptably completed.

# **E** Payment

The department will pay for measured quantities at the contract unit price under the following bid item:

Payment is full compensation for any additional agency coordination and/or permitting; for construction staking; for furnishing limestone screenings and all other materials; for constructing and maintaining the temporary detour surface; for topsoil, seeding, fertilizer, and mulch; for grading to maintain drainage; for the removal of all temporary detour surface materials; and for installation and removal of temporary erosion control along the temporary detour surface.

# 20. Flashing Beacon Equipment, Military Ridge Trail and Old CTH PB, SPV.0105.03.

# A Description

This special provision describes the procurement of solar-assisted batteries, solar panels, wireless radio transceivers, and associated controllers that shall be used to activate the traffic signal faces on the flashing beacon assemblies. The traffic signal faces shall be pedestrian activated by push button. Equipment shall be procured for two flashing beacon assemblies to be installed at two (2) locations at the Military Ridge Trail and Old CTH PB intersection.

#### **B** Materials

# **B.1 Battery**

The Battery shall:

- (1) Consist of three quantity 35Ah batteries connected electrically in parallel that have a nominal output voltage of 12VDC and a total capacity of 105Ah at a C/100 discharge rate
- (2) Be valve regulated, absorbed glass mat (AGM) type
- (3) Be sealed and spill proof
- (4) Have terminals that accept screw or bolts for secure wiring connections.
- (5) Be replaceable independently of other components.
- (6) Be fused for short circuit protection

#### **B.2 Solar Panel**

The Solar Panel shall:

- (1) Operate at 12VDC nominal with a maximum output rating of 85W.
- (2) Include an IP65 rated junction box with terminals sized for 8-16AWG wire.
- (3) Be constructed of an anodized aluminum frame, high-transmission 1/8" tempered glass, with silicon cells encapsulated in double-layer ethylene vinyl acetate (EVA), and with a white polymer backing.
- (4) Be affixed to an aluminum plate and bracket, adjustable at an angle of 45°- 60° to facilitate adjustment for maximum solar collection to optimize battery charging.
- (5) Be attached to a panel, plate and bracket to facilitate mounting and adjustment for maximum solar collection and optimal battery strength.
- (6) Have an overall size of 47.4" Wide x 21.2" tall
- (7) Have a maximum power voltage 17.8V
- (8) Have a maximum power current 4.78A
- (9) Have a short circuit current 5.35A
- (10) Have an open circuit voltage 22.2V
- (11) Operate from  $-40^{\circ}$  to  $+194^{\circ}$ F ( $-40^{\circ}$  to  $+90^{\circ}$ C)

#### **B.3 900 MHz FHSS Wireless Transceiver**

The wireless transceiver:

- (1) Shall seamlessly integrate with the beacon controller to ensure sequential activation of other radio-equipped devices in the system
- (2) Shall include an integrated LCD and two user-interface buttons for setup and troubleshooting, including readouts of flash duration (timeout), battery conditions, and LED testing functionality
- (3) Shall include two LED indicators for status and troubleshooting
- (4) Shall be capable of operating as a Parent (Gateway) or Child (Node or Repeater)
- (5) Shall be capable of providing site-survey data for verification of signal strength between network devices
- (6) Shall include network-wide modification of sign controller settings and output durations, using programmability from any networked transceiver without the use of additional equipment or software
- (7) Shall synchronize the system components to activate the indications within 120msec of one other and remain synchronized throughout the duration of the flash (timeout) cycle.
- (8) Shall operate on the license-free Industrial, Scientific, and Medical (ISM) band radio frequency spectrum
- (9) Shall comply with part 15 of FCC rules
- (10) Shall operate from 3.3VDC to 15VDC
- (11) Shall be, in the unlikely event of failure, replaceable independently of other components.

#### **B.4 Controller**

The control cabinet shall be minimum NEMA 3R Type, constructed of 0.80" aluminum. To promote airflow for internal components, the cabinet shall be vented with screening included on all vents and drains to prevent insects and other foreign matter from entering. For security, the cabinet must include at least two tamper-resistant stainless steel hinges and a replaceable Corbin #2 traffic lock with keys. To facilitate maintenance or repairs, the cabinet shall include a removable control panel to which all control circuit components either mount or connect.

For easy installation on a wide range of pole sizes and types, the cabinet shall utilize four 5/16"-18 stainless steel mounting studs that mate to a range of bracket options. To ensure a secure mount to the supporting post, two banding style brackets that fit pole sizes from 2-3/8" and up shall be included as standard equipment. Max pole size is dependent on the banding length.

To prevent corrosion, all materials used in the construction or mounting of the control cabinet shall be either aluminum or stainless steel. Anti-vandal mounting hardware shall be available as an option.

A UV resistant label shall be applied to the exterior of the cabinet and include system specific information including model number, serial number, date of manufacture, as well as any applicable regulatory compliance information.

## **B.5 Control Panel**

The control panel assembly shall consist of an aluminum back plate to which all control circuit components are secured. Control circuit components shall include a programmable flash controller, solar charge regulator, optional cellular modem, replaceable automotive-type blade fuses, screw-type terminal block, all required wiring and terminals.

The control panel assembly shall be easily secured to, or removed from, the control cabinet assembly by means of four stainless steel screws. Each control panel shall include an outdoor rated label with system specific information including model number, date of manufacture, and production sequence tracking.

The control panel wiring shall:

- (1) Be neatly routed between panel components
- (2) Be color coded for easy troubleshooting if needed
- (3) Have standard automotive style fusing for short circuit protection

# **B.5.1 Programmable Flash Controller**

The programmable flash controller shall:

- (1) Be internally housed in its own IP67 type enclosure
- (2) Be independently replaceable of other control panel components
- (3) Be able to monitor internal temperature
- (4) Have a toggle switch for local control and test
- (5) Include integrated constant-current LED drivers with a minimum of two-channel output
- (6) Include a minimum of two General Purpose Inputs and Outputs (GPIO)
- (7) Be completely programmable, including Beacon LED flash pattern, duration, and intensity. (Can be factory configured for MUTCD Compliant Flash Pattern)
- (8) Be capable of programmed to accommodate RRFB Programming if desired in the future with no controller change.
- (9) Seamlessly integrate with the 900 MHz FHSS wireless transceiver to form a network of connected devices
- (10) Include an integrated Real Time Clock (RTC) with on-board battery backup
- (11) Include data-logging capabilities with selectable interval from one minute to one day
- (12) Include integrated time-clock functionality, including a minimum of 16 events per day, and up to 7 selectable day types
- (13) Include an RS232 serial interface for local programming
- (14) Be programmable from windows-based software (shall be provided)
- (15) Have local configuration parameters and time clock schedule that can be saved
- (16) Include an optional cellular modem interface cable for remote event scheduling control, diagnostic system status monitoring and WEB enabled access and alerts

# **B.5.2 Solar Charge Regulator**

The solar charge regulator shall:

- (1) Utilize an intelligent 4-stage algorithm and Pulse Width Modulation (PWM) for battery charging
- (2) Automatically provide Low Voltage Disconnect (LVD) to protect batteries when needed
- (3) Automatically provide Load-Reconnection once battery levels have been restored to an acceptable value
- (4) Protect against and automatically recover from: short circuit, overload, reverse polarity, high temperature, lightning and transient surge, as well as voltage spikes
- (5) Be independently replaceable of other control panel components
- (6) Operate from  $-40^{\circ}$  to  $+140^{\circ}$ F ( $-40^{\circ}$  to  $+60^{\circ}$ C)

# **B.5.3 3G Cellular Modem Assembly**

The 3G Cellular Modem shall:

- (1) Provide cellular access to the Programmable Flash Controller
- (2) Communicate remotely and securely through a web-based software to:
  - 1. Monitor Flash Controller parameters:
    - Battery voltage
    - RSSI
    - Time-clock scheduling
  - 2. Provide status alerts
    - No connection
    - Low battery
- (3) Provide GPS location information for a web-based traffic device monitor and control software
- (4) Have miniature RF type cellular and GPS antenna connections for easier modem assembly servicing
- (5) Be operational with multiple cellular carriers for flexibility
- (6) Have locking SIM card socket for secure SIM card electrical connection
- (7) Have modem configuration parameters that can be saved
- (8) Operate from  $-40^{\circ}$  to  $+185^{\circ}$ F ( $-40^{\circ}$  to  $+85^{\circ}$ C)
- (9) Provide diagnostic LEDs for visually checking:
  - 1. Power status
  - 2. Input data activity
  - 3. Cellular signal connection
  - 4. Output data activity
  - 5. Modem status

#### **C** Construction

The mounting configuration shall be as shown in the plans. The department and manufacturer(s) will determine the exact location to ensure that the installation does not create a sight obstruction. Aim the solar panels and wireless transmitters per the manufacturer's recommendation. When the installation is complete, advise the department

and allow three days for scheduling of test to ensure the complete assembly is in functioning order.

## **D** Measurement

The department will measure Flashing Beacon Equipment (location) as a lump sum unit of work, acceptably completed, for the installation of flashing beacon equipment for two complete assemblies.

# **E Payment**

The department will pay for measured quantities at the contract unit price under the following bid item:

ITEM NUMBER DESCRIPTION UNIT SPV.0105.03 Flashing Beacon Equipment, Military Ridge Trail LS and Old CTH PB

Payment for the flashing beacon equipment is full compensation for the labor, tools, wiring, equipment, materials and incidentals necessary to complete this work. All signs, plaques and push buttons shall be paid for separately.

# ADDITIONAL SPECIAL PROVISION 4

# **Payment to First-Tier Subcontractors**

Within 10 calendar days of receiving a progress payment for work completed by a subcontractor, pay the subcontractor for that work. The prime contractor may withhold payment to a subcontractor if, within 10 calendar days of receipt of that progress payment, the prime contractor provides written notification to the subcontractor and the department documenting "just cause" for withholding payment.

The prime contractor may also withhold routine retainage from payments due subcontractors.

# **Payment to Lower-Tier Subcontractors**

Ensure that subcontracting agreements at all tiers provide prompt payment rights to lower-tier subcontractors that parallel those granted first-tier subcontractors in this provision.

# **Release of Routine Retainage**

After granting substantial completion the department may reduce the routine retainage withheld from the prime contractor to 75 percent of the original total amount retained.

When the Department sends the semi-final estimate the department may reduce the routine retainage withheld from the prime contractor to 10 percent of the original total amount retained.

Within 30 calendar days of receiving the semi-final estimate from the department, submit written certification that subcontractors at all tiers are paid in full for acceptably completed work and that no routine retainage is being withheld. The department will pay the prime contractor in full and reduce the routine retainage withheld from the prime contractor to zero when the department approves the final estimate.

This special provision does not limit the right of the department, prime contractor, or subcontractors at any tier to withhold payment for work not acceptably completed or work subject to an unresolved contract dispute.

# ADDITIONAL SPECIAL PROVISION 6 ASP 6 - Modifications to the standard specifications

Make the following revisions to the standard specifications:

#### 104.10.1 General

Replace paragraph one with the following effective with the December 2017 letting:

(1) Subsection 104.10 specifies a 2-step process for contractors to follow in submitting a cost reduction incentive (CRI) for modifying the contract in order to reduce direct construction costs computed at contract bid prices. The initial submittal is referred to as a CRI concept and the second submittal is a CRI proposal. The contractor and the department will equally share all savings generated to the contract due to a CRI as specified in 104.10.4.2(1). The department encourages the contractor to submit CRI concepts.

## 104.10.4.2 Payment for the CRI Work

Replace paragraph one with the following effective with the December 2017 letting:

- (1) The department will pay for completed CRI work as specified for progress payments under 109.6. The department will pay for CRI's under the Cost Reduction Incentive administrative item. When all CRI costs are determined, the department will execute a contract change order that does the following:
  - 1. Adjusts the contract time, interim completion dates, or both.
  - 2. Pays the contractor for the unpaid balance of the CRI work.
  - 3. Pays the contractor 50 percent of the net savings resulting from the CRI, calculated as follows:

#### NS = CW - CRW - CC - DC

#### Where:

NS = Net Savings

**CW** = The cost of the work required by the original contract that is revised by the CRI. CW is computed at contract bid prices if applicable.<sup>[1]</sup>

**CRW** = The cost of the revised work, computed at contract bid prices if applicable.<sup>[1]</sup>

**CC** = The contractor's cost of developing the CRI proposal.

**DC** = The department's cost for investigating, evaluating, and implementing the CRI proposal.

## 108.11 Liquidated Damages

Replace paragraphs two and three with the following effective with the December 2017 letting:

- (2) This deducted sum is not a penalty but is a fixed, agreed, liquidated damage due the department from the contractor for the added cost of engineering and supervision resulting from the contractor's failure to complete the work within the contract time.
- (3) Unless enhanced in the special provisions, the department will assess the following daily liquidated damages

#### 203.3.2.2 Removal Operations

Replace the entire text with the following effective with the December 2017 letting:

#### 203.3.2.2.1 General

- (1) Except as specified below for closing culverts, remove the entire top slab of box culverts and the entire superstructure of other culverts and bridges designated for removal. Completely remove existing piles, cribs, or other timber construction within the limits of new embankments, or remove these structures to an elevation at least 2 feet below finished ground line. Remove sidewalls or substructure units in water to an elevation no higher than the elevation of the natural stream or lake bed, or, if grading the channel is required under the contract or the plans, to the proposed finished grade of the stream or lake bed. Remove sidewalls or substructure units not in water down to at least 2 feet below natural or finished ground line.
- (2) If extending or incorporating existing culverts and bridges in the new work, remove only those parts of the existing structure as necessary to provide a proper connection to the new work. Saw, chip, or trim the connecting edges to the required lines and grades without weakening or damaging the remaining part of the structure. During concrete removal, do not damage reinforcing bars left in place as dowels or ties incorporated into the new work.
- (3) Remove pipe culverts designated for salvage in a way that prevents damage to the culverts.
- (4) Dismantle steel structures or parts of steel structures designated for salvage in a way that avoids damage to the members. If the contract specifies removing the structure in a way that leaves it in a condition suitable for re-erection, matchmark members with durable white paint before dismantling. Mark pins, bolts, nuts, loose plates, etc., similarly to indicate their proper location. Paint pins, bolts, pinholes, and machined surfaces with a department-approved rust preventative. Securely wire loose parts to adjacent members, or label and pack them in boxes.
- (5) Remove timber structures or parts of timber structures designated for salvage in a way that prevents damage to the members.
- (6) If the engineer approves, the contractor may temporarily use materials designated for salvage in falsework used to construct new work. Do not damage or reduce the value of those materials through temporary use.

## 203.3.2.2.2 Deck Removal

- (1) Protect the work as specified in 107.14 during deck removal. Minimize debris falling onto water surfaces and wetlands as the contract specifies in 107.18 or in the special provisions. Also, minimize debris falling on the ground and roadway.
- (2) Do not damage existing bar steel reinforcement, girders, or other components that will be incorporated in new work. Remove decks on prestressed concrete girders using a hydraulic shear or other engineer-approved equipment. Thoroughly clean, realign, and retie reinforcement as necessary.
- (3) After deck removal is complete, notify the engineer to request a damage survey. Point out damage to the engineer. Allow one business day for the engineer to complete the damage survey. If damage is identified, the department will determine if repairs or girder restoration will be allowed.
- (4) If the department allows girder restoration, have a professional engineer registered in the State of Wisconsin analyze the effect of the damage to the bridge, make recommendations, and prepare signed and sealed computations and structural details required to restore girders to their previous structural capacity. Submit the restoration proposal, including analysis and structural details, to the department and design engineer of record. The department will accept or reject the restoration proposal within 3 business days. Do not begin restoration work until the department allows in writing.
- (5) The engineer will not extend contract time to assess or remediate contractor caused damage.

## 203.5.1 General

Replace paragraph two with the following effective with the December 2017 letting:

(2) Payment is full compensation for breaking down and removing; costs associated with contractorcaused damage; required salvaging, storing, and disposing of materials; and, unless the contract specifies granular backfill, for backfilling.

## 415.2.3 Expansion Joint Filler

Replace paragraph one with the following effective with the December 2017 letting:

(1) Furnish expansion joint filler conforming to AASHTO M153, AASHTO M213, or ASTM D8139 in lengths equal to the pavement lane width and of the thickness and height the plans show. Where dowel bars are required, use filler with factory-punched holes at the dowel bar locations and with a diameter not greater than 1/8 inch larger than the nominal dowel bar diameter.

## 415.3.20 Filling Joints

Replace paragraph two with the following effective with the December 2017 letting:

(2) Clean joints of laitance, curing compound, and other contaminants before filling. Saw construction joints at least 3/4 inches deep before filling. Sawing is not required for tooled joints in curb and gutter. Sandblast or waterblast exposed joint faces using multiple passes as required to clean joints surfaces of material that might prevent bonding. Blow clean and dry with oil-free compressed air immediately before filling.

#### 415.5.1 General

Replace paragraph six with the following effective with the December 2017 letting:

(6) Payment for Concrete Pavement Joint Filling is full compensation for filling concrete pavement joints; filling adjacent curb and gutter joints; and for sawing.

## 440.3.4.2 Contractor Testing

Replace paragraph two with the following effective with the December 2017 letting:

(2) Coordinate with the engineer at least 24 hours before making profile runs for acceptance unless the engineer approves otherwise. The department may require testing to accommodate staged construction or if corrective action is required.

#### 455.5.3 Tack Coat

Replace paragraph two with the following effective with the December 2017 letting:

(2) The department will adjust pay for Tack Coat, under the Nonconforming Tack Coat administrative item, for nonconforming material the engineer allows to remain in place at a maximum of 75 percent of the contract unit price.

# 460.2.7 HMA Mixture Design

Replace paragraph one with the following effective with the December 2017 letting:

(1) For each HMA mixture type used under the contract, develop and submit an asphaltic mixture design according to CMM 8-66 and conforming to the requirements of table 460-1 and table 460-2. The values listed are design limits; production values may exceed those limits. The department will review mixture designs and report the results of that review to the designer according to CMM 8-66.

Replace paragraph six with the following:

(6) Conduct TSR tests during mixture production according to CMM 8-36.6.14. Test each full 50,000 ton production increment, or fraction of an increment, after the first 5000 tons of production. Perform required increment testing in the first week of production of that increment. If production TSR values are below the limit specified in CMM 8-36.6.14, notify the engineer. The engineer and contractor will jointly determine a corrective action.

#### 502.2.7 Preformed Joint Filler

Replace paragraph one with the following effective with the December 2017 letting:

(1) Use preformed joint filler conforming to AASHTO M153, AASHTO M213, or ASTM D8139.

#### 502.3.7.8 Floors

Replace paragraph fourteen with the following effective with the December 2017 letting:

(14) Unless specified otherwise, transversely tine finish the floors of structures with approach pavements designed for speeds of 40 mph or greater as specified in 415.3.8.3, except make the tining 1/8 inch in depth and do not perform tining within 12 inches of gutters. The contractor may apply a broom finish, described below, instead of the artificial turf drag finish required before tining. The contractor may perform tining manually, if it obtains a finish satisfactory to the engineer. Perform tining within 20 degrees of the centerline of bearing of the substructure units on bridge decks having skew angles of 20 degrees or greater.

#### 505.2.6 Dowel Bars and Tie Bars

Replace the entire text with the following effective with the March 2018 letting:

#### 505.2.6.1 General

- (1) Furnish bars coated in a plant certified by the Concrete Reinforcing Steel Institute. For dowel bars and straight tie bars, there is no requirement for bend tests. Ensure that the bars are the specified diameter and length the plans show.
- (2) The contractor need not coat or patch sawed ends, sheared ends, cut ends, ends left bare during the coating process, or ends with damaged coating.
- (3) The contractor need not repair circumferential coating damage from shipping, handling, or installation, if the following conditions are met:
  - 1. The damaged area is 1/4 inch square or smaller.
  - 2. The total damaged area in any one-foot length does not exceed 2 percent of the circumferential area in that length.
- (4) Repair areas of damaged circumferential coating larger than 1/4 inch square. Reject bars with total damage greater than 2 percent of the bar's circumferential area.

#### 505.2.6.2 Dowel Bars

#### 505.2.6.2.1 General

- (1) Ensure that the bars are straight, round, smooth, and free from burrs or other deformations detrimental to the free movement of the bar in the concrete.
- (2) Saw bars to the required length. For solid bars, the department will allow shearing if no damage occurs to the coating and shearing distortions do not exceed the following:
  - 1. No distorted diameter is more than 0.04 inches greater than the true diameter.
  - 2. No distortion extends more than 0.40 inches from the sheared end.
- (3) Apply a surface treatment to loose dowels, or furnish manufacturer-treated bars in dowel bar baskets, capable of preventing bond between the epoxy-coated bars and the concrete. Apply field surface treatments when loading bars in the dowel bar magazine.

#### 505.2.6.2.2 Solid Dowel Bars

(1) Furnish coated bars conforming to AASHTO M31 grade 40 or 60. Alternatively the contractor may furnish dowel bars conforming to AASHTO M227 grade 70-80. Coat with a thermosetting epoxy conforming to AASHTO M254, type B.

#### 505.2.6.2.3 Tubular Dowel Bars

(1) Furnish welded steel tubular bars conforming to ASTM A513 fabricated from plain carbon steel with a minimum tensile yield strength of 60 ksi and sized as follows:

(2) Cap bar ends to prevent intrusion of concrete or other materials. Ensure that tubing is galvanized on the exterior and interior according to ASTM A653 with a G40 zinc coating and apply 7-13 mils of epoxy to the galvanized exterior according to AASHTO M254, Type B.

## 505.2.6.2.4 High Performance Dowel Bars

(1) As an alternate the contractor may furnish high performance dowel bars from the department's APL.

#### 505.2.6.3 Tie Bars

- (1) Furnish coated bars conforming to AASHTO M31 grade 40 or 60. Coat tie bars as specified in 505.2.4 for coated high-strength steel reinforcement. Ensure that the tie bars are the shape the plans show.
- (2) Repair, with compatible coating material, the bend location of field-straightened coated tie bars.

#### 614.2.1 General

Add the following as paragraph ten effective with the December 2017 letting:

(10) Furnish guardrail reflectors from the department's APL.

#### 614.3.2.1 Installing Posts

Add the following as paragraph five effective with the December 2017 letting:

(5) Provide post-mounted reflectors every 100 feet with one at the beginning and end of each run and a minimum of three reflectors per run.

#### 614.5 Payment

Replace paragraph four with the following effective with the December 2017 letting:

(4) Payment for the Steel Thrie Beam, Steel Plate Beam Guard, Guardrail Stiffened, MGS Guardrail, Short Radius, and various transition bid items is full compensation for providing guardrail and transitions including post-mounted reflectors; for repairing damaged zinc coatings; and for excavating, backfilling, and disposing of surplus material.

#### 641.2.9 Overhead Sign Supports

Replace paragraph three with the following effective with the December 2017 letting:

(3) Provide steel pole shafts, mast arms or trusses, and luminaire arms zinc coated according to ASTM A123. The contractor may provide either straight or tapered pole and arm shafts unless the plans specify otherwise. Provide bolts and other hardware conforming to 641.2.2.

#### 642.2.2.1 General

Replace the entire text with the following effective with the December 2017 letting:

- (1) Provide each field office with two rooms, separated by an interior door with a padlock. Ensure that each room has a separate exterior door and its own air conditioner. Locate the office where a quality internet connection can be achieved.
- (2) Provide long distance telephone service via a land line for exclusive department use that has the following:
  - Two programmable touch-tone phones, one of which is cordless. Ensure that phone operations will not interfere with other telecommunications equipment.
