The information in this letter for the above noted project is meant to satisfy the legal requirements of Wisconsin Statute 84.063 and Administrative Rule Trans 220.

- 1. Within 7 days of receipt of this e-mail <u>and</u> downloading of documents from the FTP site as noted below, please complete and return the Project Plan Acknowledgment portion of the attached DT1078 form, *Project Plan Transmittal*.
- 2. Within 120 days of receipt of this e-mail, you'll need to submit a work plan to describe what relocations or adjustments of your facilities will be required for this project. A copy of the DT2236 form, *Utility Worksheet*, has been posted to the FTP site to help you develop a complete work plan. Sign and date the form in the designated area.

This project will reconstruct the existing at-grade intersection of STH 29 and CTH U with a hybrid J-Turn type intersection. The vertical profile of STH 29 westbound approaching the intersection will be reconstructed to provide required sight distance. Construction activities related to this project include pavement removal, grading, storm sewer work, lighting, concrete paving, traffic control, erosion control, signing, pavement marking, and related work necessary to complete the project as shown in the attached plans.

Within the limits of this project, your company has facilities, some of which may conflict with the proposed construction. Remember that in fill sections and in transitions between cuts and fills, it is common for cuts of from 6" to 18" to occur when removing the existing pavement or topsoil, before the fill is added. Further, pay particular attention to ditch cuts, culvert end walls, proposed lighting, temporary pavement, and driveway construction. All of these seemingly minor operations can affect your facilities in major ways.

The following items have been posted to the FTP site:

- 1. DT1078 form, *Project Plan Transmittal*. Must be returned within seven days.
- 2. An approved Trans 220 project plan for design of utility facility alterations or relocations.
- 3. DT2236 form, *Utility Worksheet*. Must be returned within one hundred twenty days.
- 4. List of possible conflicts
- 5. List of utility facility owner contacts. This list may help you coordinate any relocation work with other utility owners.

You are authorized to prepare plans, and sketches documenting any anticipated alterations or relocations. The plans should show both your existing impacted facilities and your proposed alterations or relocations with ties to highway stationing so that the location can be readily identified.

DEADLINES: By October 2, 2020 please submit the following:

- The completed DT2236 form, Utility Worksheet, for the project.
- Other attachments as needed.

This project has a design completion date of November 1, 2020. The project is anticipated to be let on February 9, 2021.

Upon completion of your plans, please send your work plan documents to HNTB Corporation at the address listed below. HNTB will perform an initial review of your plans for conformity with the project plans and schedule and forward your work plan to WisDOT for approval.
