

A strip of land 25 feet in width lying between and 25 feet south of and parallel to the said south line of present Main Avenue and extending from the west shore line of the Fex River to the east line of Third Street.

In consideration of the agreements herein contained and upon completion of the comstruction of the new bridge and its approaches, the party of the second part at its
own expense, will do any excavating, filling, leveling, or shaping required on the
above described property abutting the street lines to presentably and acceptably comform to the new bridge approach and caused by changing the present street layout and
