Special Provisions

8. Utilities.

*Replace entire subsection titled **CenturyLink Communications, LLC (communications)** under section titled **9200-10-71** with the following:*

CenturyLink Communications, LLC (communications) has an existing fiber optic line along WIS 29 from Station 479+68 'EB' Right to Station 579+55 'EB' Right.

CenturyLink plans to lower the existing communication line 24-inches from Station 558+00 'EB' Right to Station 560+00 'EB' Right.

Lowering of line will be completed by March 31, 2021.

From Station 527+89 'EB' Right to Station 533+55 'EB' Right (Location #1) and Station 551+42 'EB' Right to Station 554+76 'EB' Right (Location #2), during excavation CenturyLink does not anticipate conflicts. If an unanticipated conflict is encountered in these areas CenturyLink will perform the following work.

- Location #1 – CenturyLink to lower existing conduit. Work will take a maximum of 12 working days.
- Location #2 – CenturyLink to lower existing conduit. Work will take a maximum of 6 working days.

No other conflicts are anticipated.
