LOCATION

This project is located on STH 23 within the town of Empire and within the city of Fond du Lac in Fond du Lac county. This project will extend from the western radius point of the SB ramps of the USH 151 interchange (CH limits) to the joint just east of the CTH UU intersection (Photolog 2713 to 2922).Principal Arterial. RP 023E 225K+0.41 to 228+0.05. Approximately 2.1 miles. Long Truck Route; State (designated), Federal (non); NHS Route; OSOW Route.

EXISTING CONDITION

STH 23 consists of a mix of an urban and rural cross section consisting of 2 roadways having 2, 12-ft driving lanes and 8-10-ft shoulders (5-8 ft paved). Posted speed limit varies between 35 mph and 55 mph. The last improvement project was constructed in 1987.

PROPOSAL

This project will be a preservation level improvement project. The paved shoulder width will remain as existing. Additional shoulder gravel will be added with this project. Side slopes should be evaluated and documented within the preliminary design process. This project does not include grading of side slopes. Structure work is not anticipated. Intersection improvements are not anticipated. Signing and pavement marking will be included. It is assumed this project will be constructed without a detour. It is anticipated that any culvert pipe work will be done using county forces; some curb and gutter repair/replacement will be included. Storm sewer should be televised/inspected within design, where applicable. WisDOT FDM standards need to be investigated during preliminary design and thoroughly documented in the DSR. It is anticipated that a variance may be required to address maximum grades. Investigate low cost pavement enhancement options at steep grades. Beam guard removal and replacement and EAT replacement quantities should be evaluated within preliminary design; the estimate should be updated at 30% design. Cost share is not anticipated. Real estate is not anticipated.

UNRESOLVED ISSUES

A pavement design report is required for this project (it is anticipated that the soils/pavement report will be completed in-house); the recommendation shown is for scoping purposes only. See Scoping Estimate for additional assumptions.
