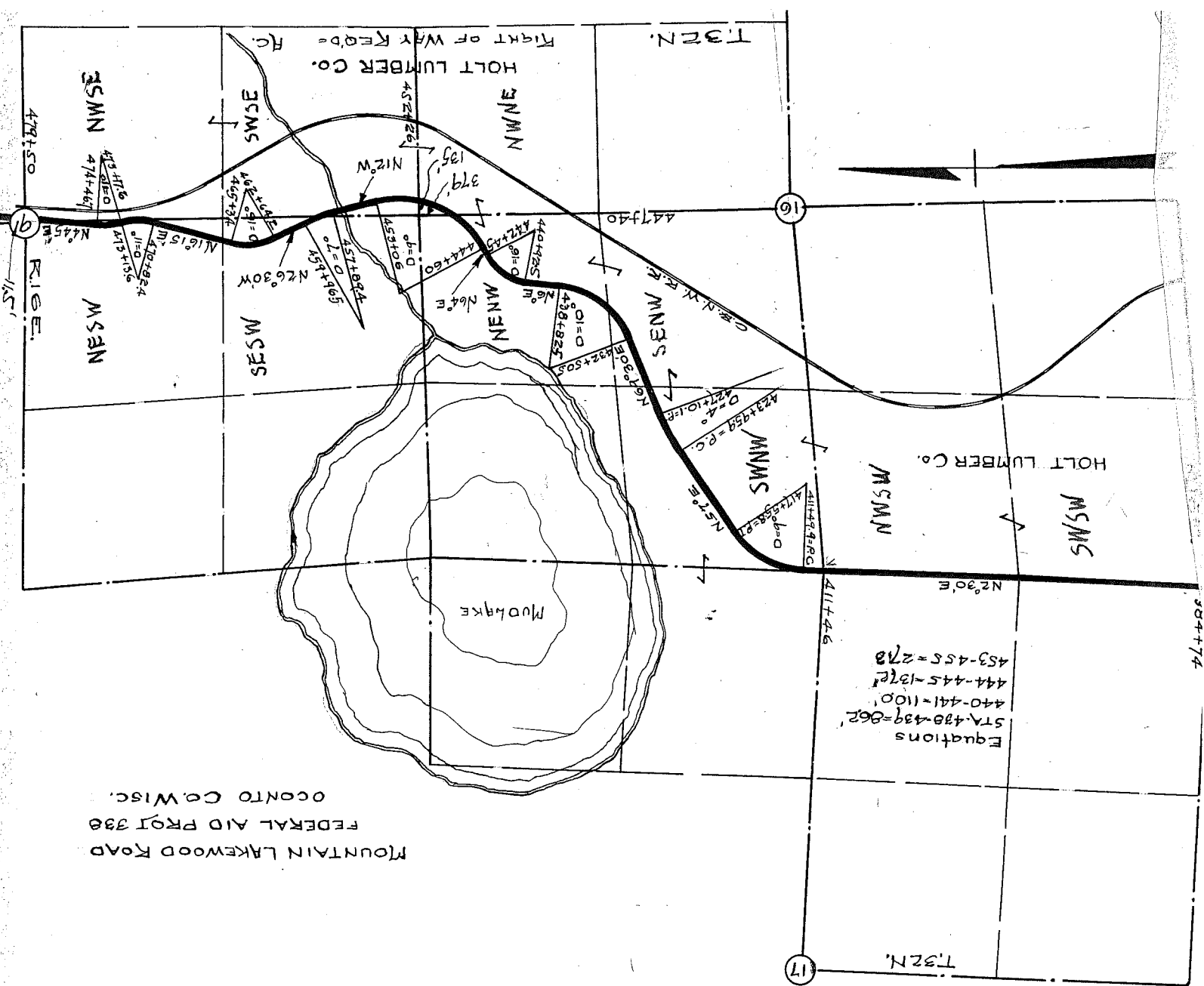

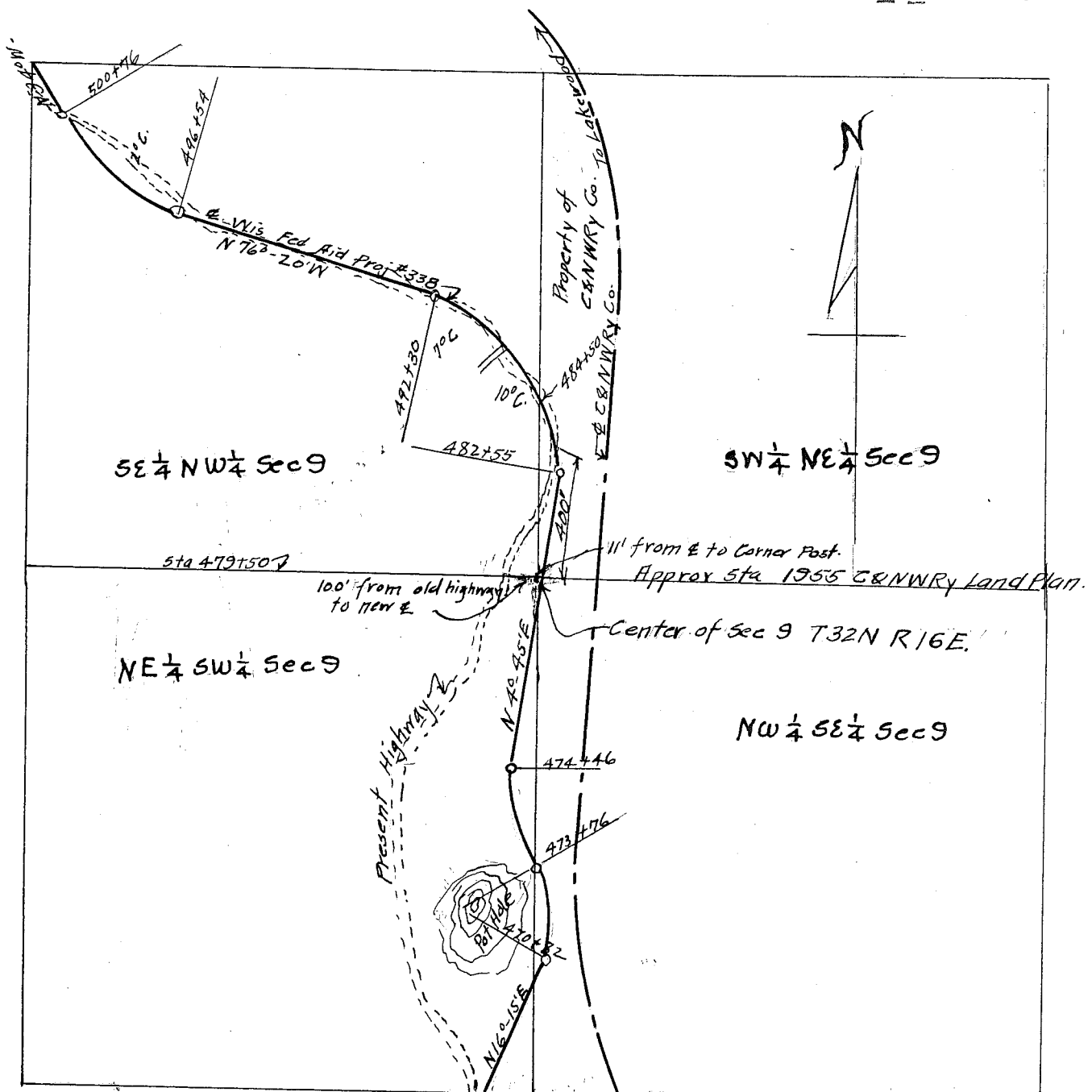


SHOWING THE LOCATION OF WIS. FEDERAL AID PROJECT NO. 338

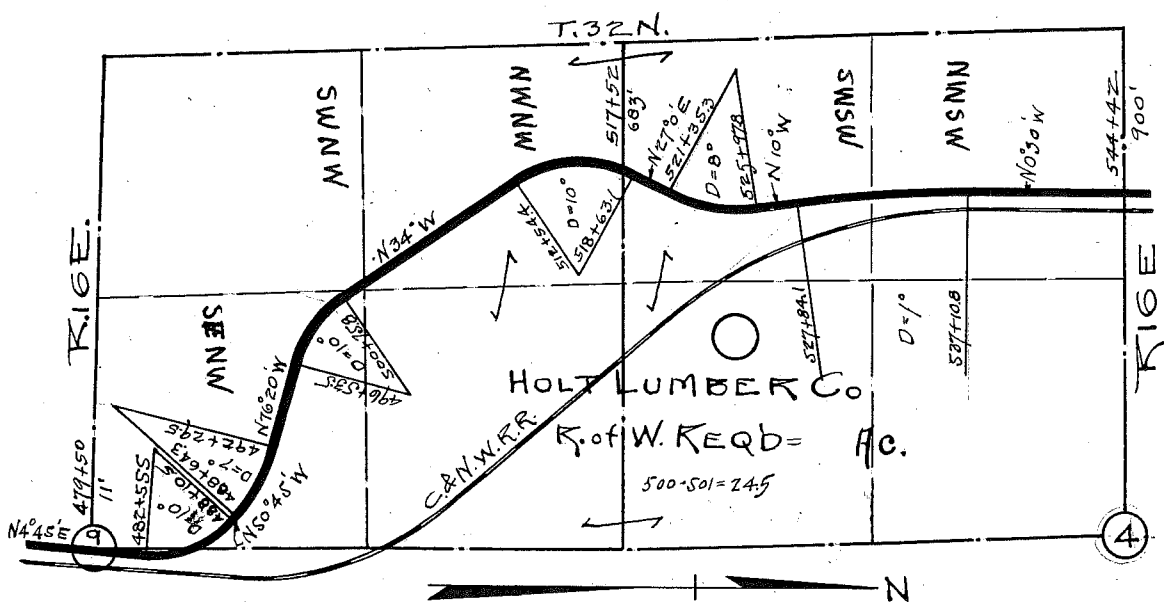

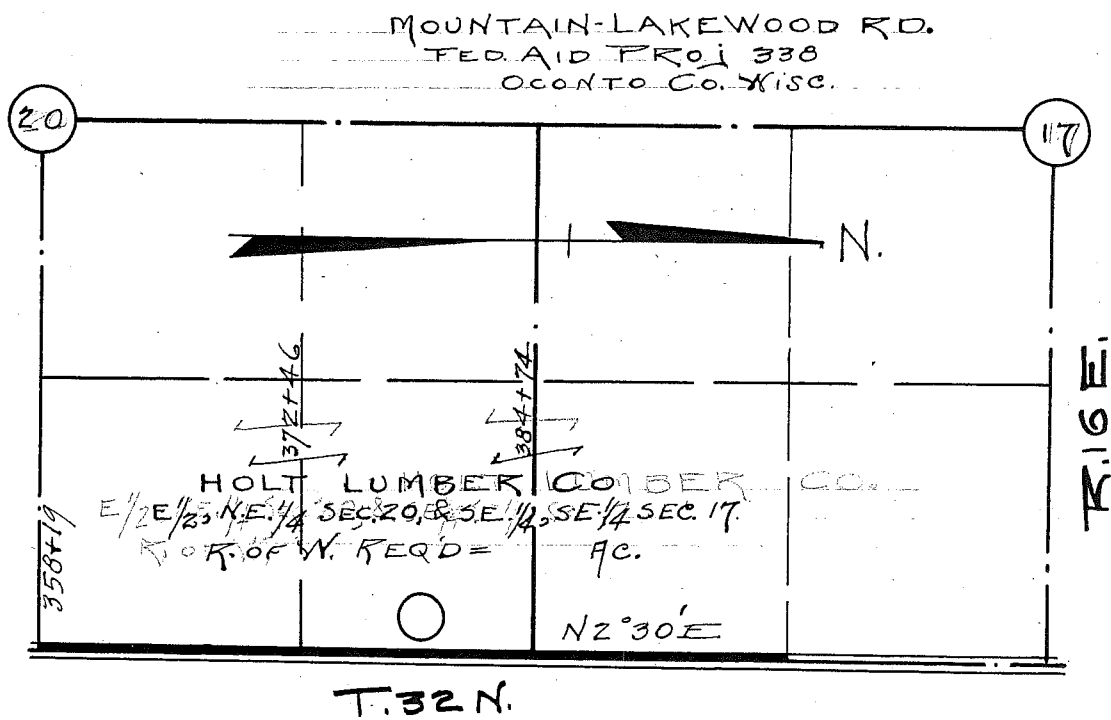

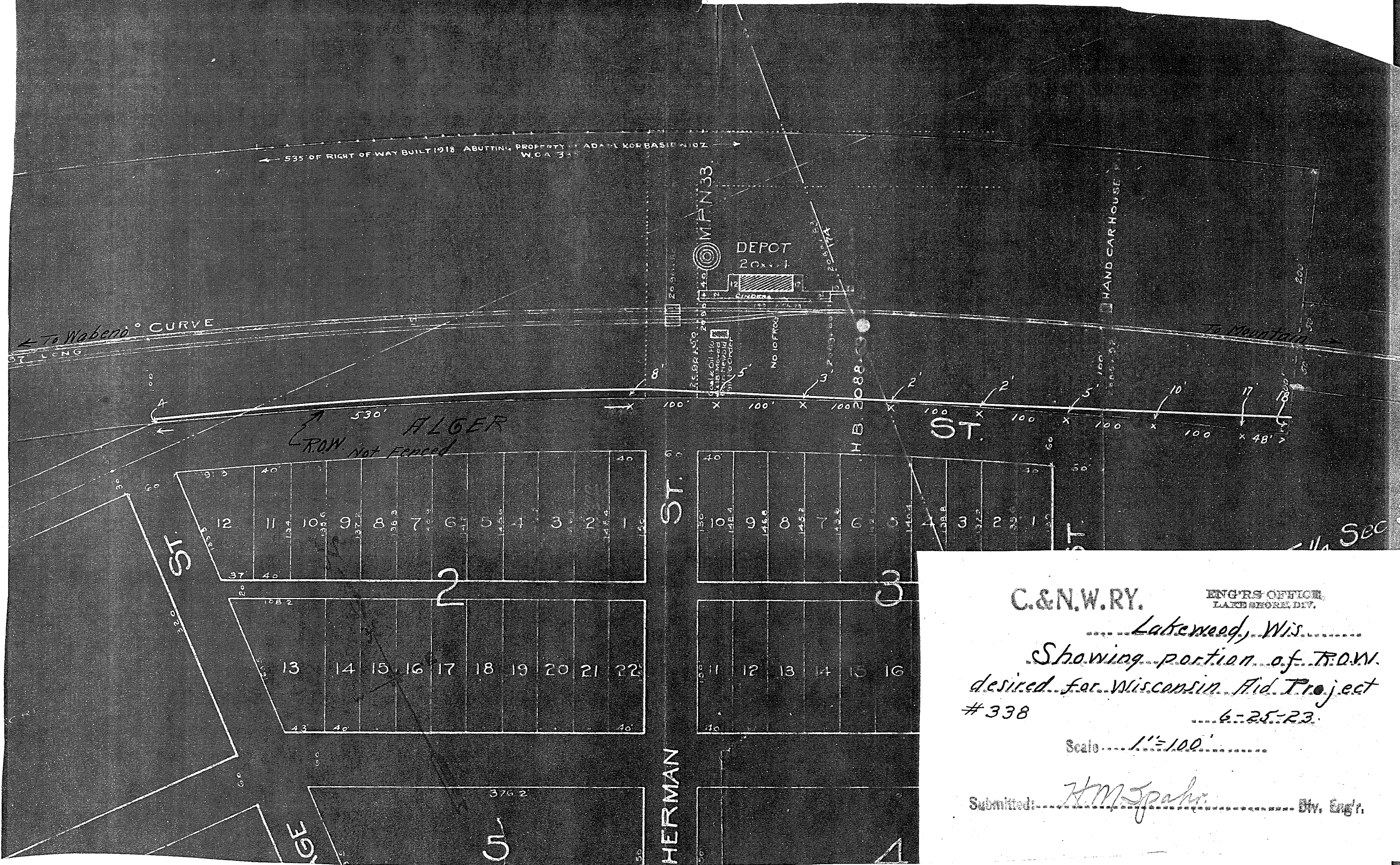

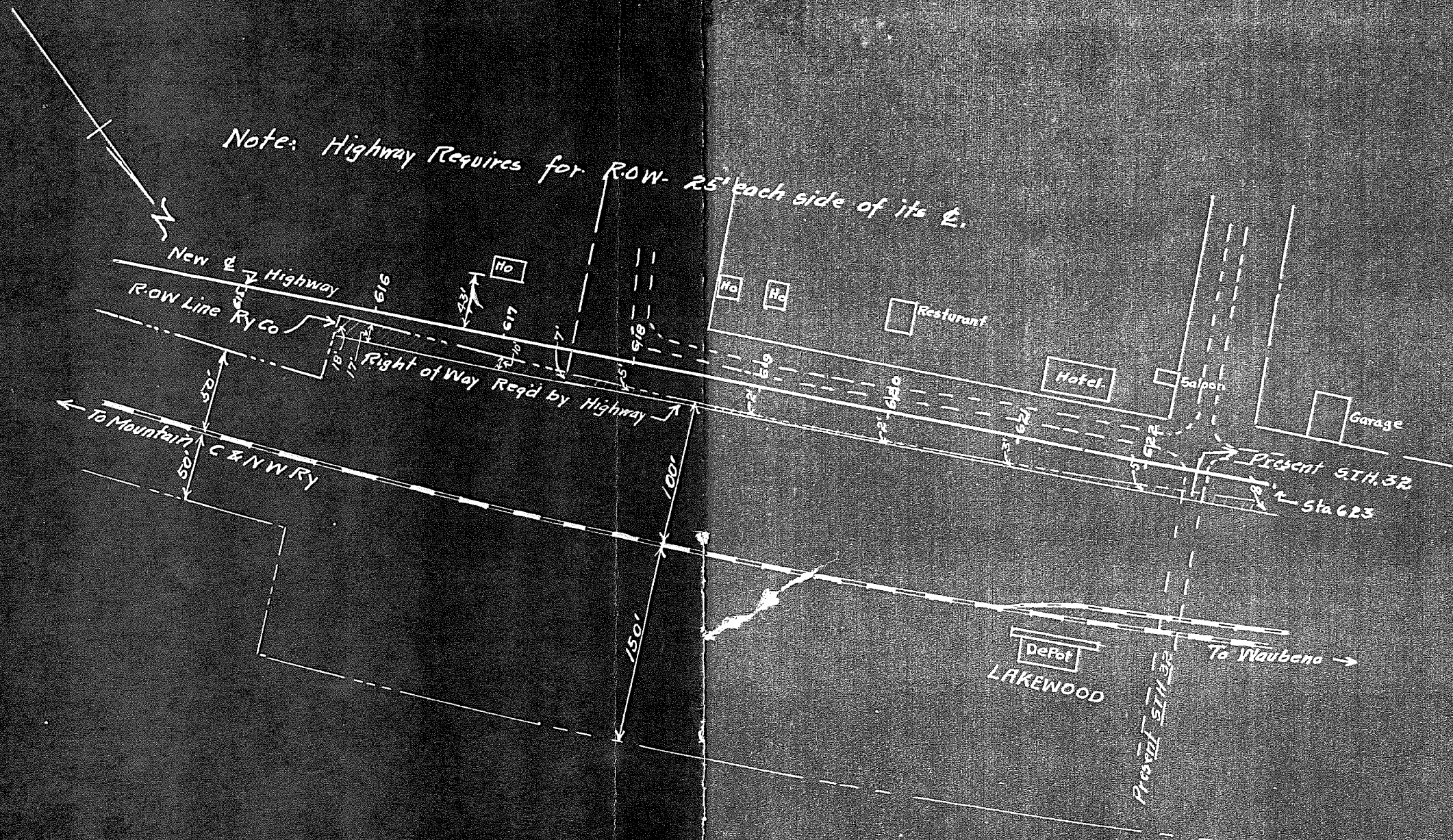
