Public meeting scheduled for WIS 12 - Wilson Creek Bridge in Dunn County

The Wisconsin Department of Transportation (WisDOT) is conducting a public involvement meeting to discuss the proposed improvements to the Wilson Creek Bridge on WIS 12 from Baldwin to Menomonie in Dunn County.

The meeting is scheduled for Tuesday, April 23, 2019 from 4:30 to 6 p.m. at the Knapp Town Hall, 111 Oak St, Knapp, WI 54749. The objective of this meeting is to familiarize the public with the purpose and need for the project and to obtain input on the proposed improvements.

This project involves the replacement of Wilson Creek Bridge, which is located approximately 0.6 miles west of CTH Q. The bridge will be constructed while traffic is detoured. The detour route is 14 miles in length and will use WIS 128, I-94 and WIS 25.

WisDOT representatives will present information regarding the identified needs for this project on WIS 12 and discuss the proposed improvements that will address the purpose and need for the project.

Construction is currently scheduled for 2024 (but could be built as early as 2021).

Adjacent property owners are encouraged to attend the meeting. Citizens who are hard of hearing and require an interpreter may request one by contacting WisDOT at least three working days prior to the meeting via the Wisconsin Telecommunications Relay system (dialing 711).
