NOW, THEREFORE, the Department of Transportation approves and consents to direct access between said highway and the lands of the owner located in Government Lot 2 Section 8, T38N, R16W by means of one Private Driveway(s) and ~~Special Crossing(s) or a Public Highway~~, located as follows: on the easterly side of STH 35 & 70

The authorized access shall be located entirely within the limits of the above-described property, ~~subject to the terms and conditions set forth on the reverse side of this document and such additional terms and conditions as are set forth in the "PERMIT TO INSTALL ACCESS DRIVEWAY TO STATE TRUNK HIGHWAY" required by Sec. 86.07(2), Wisconsin Statutes.~~

~~A SPECIAL CROSSING is to be used solely for travel between covered parcels under the same ownership; such use shall cease and the crossing shall be removed if such parcels pass into separate ownership.~~
