H 35 & 70 in Burnett County, as a controlled-access highway, designated as Controlled-Access Project 8010-9-29, effective on and after February 5, 1986; as recorded in Volume 403 of Records page 246 as Document No. 242311.

NOW, THEREFORE, the Department of Transportation approves and consents to direct access between said highway and Industrial Ave., a village street located in the SW 1/4 - SW 1/4 of Section 4 T39N R16W presently approximately 701 feet North and 75 feet east of the southwest corner of the SW 1/4 said Section 4 by means of one Private Driveway(s) and Special Crossing(s) or a Public Highway, located as follows: extending easterly from STH 35

~~A SPECIAL CROSSING is to be used solely for travel between severed parcels under the same ownership; such use shall cease and the crossing shall be removed if such parcels pass into separate ownership.~~

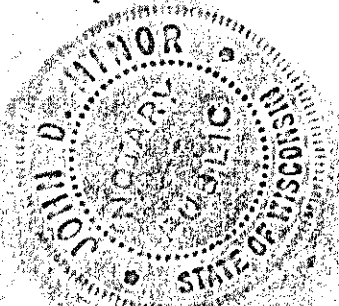
