WHEREAS, pursuant to the provisions of Section 84.25, Wisconsin Statutes, the Department of Transportation has established a section of ST H 35 & 70 in Burnett County, as a controlled-access highway, designated as Controlled-Access Project 8010-9-29, effective on and after February 5, 1986; as recorded in Volume 403 of Records page 246 as Document No. 242311.

~~A SPECIAL CROSSING is to be used solely for travel between severed parcels under the same ownership; such use shall cease and the crossing shall be removed if such parcels pass into separate ownership.~~

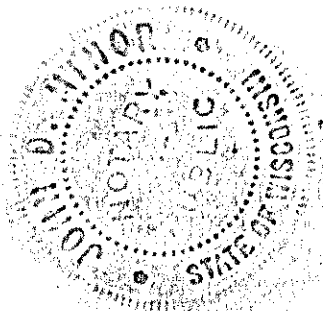
