WHEREAS, pursuant to the provisions of Section 84.25, Wisconsin Statutes, the Department of Transportation has established a section of ST H 35 & 70 in Burnett County, as a controlled-access highway, designated as Controlled-Access Project 8010-9-29, effective on and after February 5, 1986; as recorded in Volume 403 of Records page 246 as Document No. 242311.

by means of one Private Driveway(s) ~~and~~ (Joint) ~~Special Crossing(s) over a Public Highway~~ located as follows:

One private driveway for joint usage located on the northerly property line on the westerly side of STH 35 used jointly with the Charles E. Crowley property adjacent to the west as described in Doc. No. 219616, Vol. 352, Page 601.

The authorized access shall be located entirely within the limits of the above-described property ~~subject to the terms and conditions set forth on the reverse side of this document and such additional terms and conditions as are set forth in the PERMIT TO INSTALL ACCESS DRIVEWAY TO STATE TRUNK HIGHWAY, required by 88C 86.07(2), Wisconsin Statutes~~

~~A SPECIAL CROSSING is to be used solely for travel between severed parcels under the same ownership; such crossing shall be removed if such parcels pass into separate ownership~~

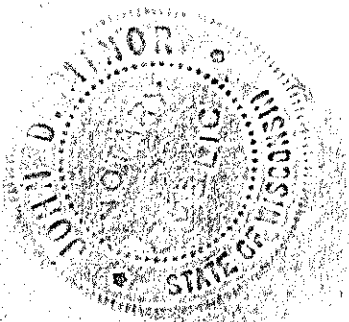
