We Energies - Gas relocation plan listed below is based on project plans dated 12-21-2016.

Relocations and adjustments of We Energies facilities will be constructed per existing WR 3932486 on W. North Ave. as part of WisDOT project 1060-34-77 for the Zoo IC project.

Highway stationing has been used where possible to locate new facilities. See previously submitted CAD alignment for the 12" ST gas relocation under WR 3932486. See the attached preliminary design for WR 3932486.

Any facilities not explicitly identified as being relocated have been deemed to be not in conflict and will remain in place as is. It is expected that contractors will work safely around any facilities left within the work-zone. If plans change such that facilities become in conflict, it is expected that will work wit We-energies to resolve said conflict.

2. Conflicting utility facilities will need to be relocated prior to construction. If this is not feasible, provide an explanation and an indication of what work will require coordination with the highway contractor during construction.

We Energies plans to relocate its facilities prior to the start of road construction, dependent on the conditions specified in this work plan and attached design.

All discontinued facilities are annotated on the design drawing and will be left in place.

We Energies requests WisDOT survey a reference line for utilities use. Please contact We Energies when reference line survey is scheduled.

Estimated time required in section 4 was calculated assuming typical weather conditions. If weather conditions are more severe than normal, more time may be required. If more time is required, the DOT Utility Coordinator will be made aware of the situation as soon as possible.

The proposed relocations and schedules listed in this Work Plan may have to be revised if any unknown environmental conditions are encountered within any areas where We Energies is planning to perform work. Coordination with the DOT and/or the road contractor may be required if this occurs.

Relocation plans were determined based on cross sections shown on project plans. If more extensive EBS work is found to be required during road construction, the road contractor will inform We-energies of the change in plans and work to resolve the conflict in an agreeable manner.

If utilities were not considered in WisDOT's Traffic mitigation plan the relocations and schedule described above may be affected and revisions to this work plan may be necessary. If lighting and signal plans were not made available prior to submission of this work plan revisions may be necessary.

WisDOT staff are responsible to request any new services (recommended 30 days prior to let date) and the owner of record is required to request any disconnections of existing services through the We Energies Contact Center at 800-242-9137.

If the contingencies listed in sections 5, 6, & 10 cannot be met 30 days prior to the anticipated start date, We Energies will be forced to adjust the start date which could require relocations be done during road construction.

We Energies Electric Dispatch #1-800-662-4797 We Energies Gas Dispatch #1-800-261-5325 If the above boxes regarding hazardous material or remaining product are checked "No" AND the line has been verified by We Energies to be dead per the above paragraph, it is the responsibility of the road contractor to remove and dispose of all sections of the discontinued facility necessary for them to continue with the project.
