Byways are designed to invite visitors to travel the back roads and to see and experience the "real" America, those communities not seen or experienced from the interstates. The Louisiana Great River Road has provided that experience since the 1930s, traveling through river towns, rural communities, farmlands, and today it is juxtaposed to industrial and petrochemical plants that share a connection to the river.
