This year has new "Core Questions" which are different than previous year's. Our office has worked with WisDOT Central Office in order to obtain the majority of the source documentation needed to answer our Core Questions, and I have worked with contract Specialists in the SE and SW Regions to gather info required to answer Core Question 2 (CQ2); however, we need the help of the PM/Responsible Charge to answer and provide documentation for CQ 10.

• For CQ 10, please provide any documentation produced after NEPA signing, at subsequent project development steps, that shows that the NEPA decision remained valid. This can take the form of an email, any document to the project file, PMP printout, or other documents. If there is not written documentation for this item, please respond as to whether there was an undocumented evaluation.

If you could answer CQ 10 by January 4, 2019, I would greatly appreciate it. If this date cannot be met, please just let me know. I realize this is a busy time of the year for everyone. Considering the most timeconsuming documentation efforts have already been completed, we are hoping the remaining documentation should not be too demanding. I am in the office through this Friday myself, and off Christmas week and until January 2<sup>nd</sup>.

This assignment listing was supplied to FHWA by Central Office as accurate as it was at the time, and if PM assignment has changed, or is in error, please forward to the appropriate individual. When responding, please do not do a ReplyAll so that everyone does not become swamped with each other's responses!
